

A Fake Marburg Virus Threat may be Used to Mandate Further Vaccinations

A Possible Marburg-RiVax Final Solution

In this paper I would like to examine a warning issued by a fellow Irishman. On 22 September 2021, Kieran Morrissey published an article on lewrockwell.com titled, **A Possible Marburg-Rivax Final Solution**. He also released a short video presentation with the same warning.

In order to show that his general argument is well founded, we have set it out in the following pages in a more discursive or explanatory form.

For many years the Elite have been warning the world of the great potential threat posed by two deadly diseases, Ebola and Marburg. It has been implied over and over that, if either of these dangerous pathogens mutated into a more contagious form they would cause millions of deaths in a very short time unless a suitable vaccine was developed. The dangers of ricin have also been aired widely in the media, especially after its use by a religiously motivated terrorist group, Aum Shinrikyo, in the Tokyo underground in 1995. Several thousand passengers were injured and about 14 died. Ricin is a highly toxic substance which can be made from castor oil beans by someone with little expertise and only basic equipment. It works by interfering with protein synthesis and leads within hours to respiratory failure. It was first developed by the Nazis for use as a nerve gas which they called ‘Sarin.’

Disproportionate attention given to rare and exotic diseases

These three pathogens – Ebola, Marburg, and Ricin – have received widespread media attention. This sensational coverage bears no relationship to the threat posed by any of them. For example, in the period 2017-2018, Ebola caused only 37 deaths worldwide. Where serious outbreaks do occur, it is invariably in subtropical regions where living standards are extremely low, nutrition is poor, and standards of hygiene are minimal. The number of deaths from Marburg is even lower, at just 4 in the period 2014-2017. Compare these rates of mortality with that of malaria, which caused 435,000 deaths in 2017 alone.

The disproportionate attention given in the mainstream media to these rare and exotic pathogens would suggest that the public in the West is being conditioned to believe that vaccines to protect against them will eventually be required. All that is needed is a trigger event, an ‘outbreak’ in Europe or America, to generate the required level of fear, stoked no doubt by horrific case reports in the media and greatly exaggerated rates of projected deaths.

The symptoms produced by these pathogens is of particular interest at a time when serious adverse reactions to the Covid vaccines are a matter of great concern. Both Ebola and Marburg cause what is known as hemorrhagic fever or massive internal bleeding. The disease attacks the cells which enable the blood to clot. Once this clotting factor has been disabled the victim suffers severe, uncontrollable internal bleeding. This is why the disease was long known as Ebola hemorrhagic fever, but has recently been renamed 'Ebola Virus', no doubt to augment the conditioned belief that, if something is a virus, it can only be tackled with a vaccine.

Marburg, which also causes death by massive internal bleeding, was known until recently as Marburg hemorrhagic fever. However, it too has undergone a semantic makeover and is now called 'Marburg Virus.'



As Mr Morrissey points out, the similarity between Ebola and Marburg, both of which interfere fatally with blood coagulation, and the main adverse event associated with the Covid vaccine, namely progressive clotting in the capillaries, is hardly a coincidence. The first two inhibit clotting, while the latter promotes it unnecessarily, but the same pathological phenomenon is observed – faulty blood coagulation.

If the Covid vaccines continue to cause a high rate of blood clotting among recipients, the manufacturers will need some way of covering their tracks and avoiding responsibility for an unfolding disaster. A Marburg or Ebola outbreak in Europe or America would create a whole new wave of medical uncertainty and frighten tens of millions into taking a suitable vaccine, if one were available. The numbers willing to take the vaccine would be greatly multiplied if a test was available which showed, before any symptoms appeared, whether or not one had contracted the virus.

Mr Morrissey checked to see whether these two conditions – (1) a new vaccine for Ebola or Marburg and (2) a suitable method for testing asymptomatic cases – were actually satisfied. And he found that they are.

The next hoax is ready to roll

We need to look further at this disturbing scenario. Many of the improbable developments that are needed to bring it about are already happening:

1... GAVI, April 2021

On 22 April 2021, the GAVI website published a paper with a very provocative title: “The Next Pandemic: Marburg?” It drew several obvious parallels with Covid-19. For example it stated that Marburg, like Covid, was believed to have originated in bats. It also implied that Marburg could be transmitted by asymptomatic carriers: “This can be extremely dangerous. In early 2021, there were reports that Ebola, closely related to Marburg, could lay dormant in people only to emerge many months after an epidemic had ended, triggering another outbreak.” Note that these two ‘deadly viruses’, Marburg and Ebola, are “closely related” to one another.



It states ominously: “Most outbreaks have been in Africa, with cases reported in Angola, the Democratic Republic of the Congo, Kenya, South Africa, Uganda and Zimbabwe. However, there have been outbreaks in Europe and the USA.” The author and GAVI, his sponsor, are sowing in the mind of the reader the possibility that this killer virus could suddenly break out in Europe or the US. This is blatant fearmongering and propaganda.

They then take this fanciful possibility and present it as a legitimate “pandemic threat”:

“As Marburg virus can spread from human to human through contact of bodily fluids, much like Ebola. As outbreaks in Europe and the US have already shown, increasing globalisation and international travel mean that the risk for global spread is high, especially when the incubation period could be up to three weeks. This could be disastrous given its high death rate.”

The author goes on to paint a gruesome picture of the devastation wrought by Marburg:

“Many people go on to develop severe viral haemorrhagic fever, and in severe cases have blood in their vomit and faeces, and may bleed from their nose, gums and vagina. The onslaught of the virus is so extreme that most people die 8-9 days after infection, often because of extreme loss of blood.”

Again we have a forbidding image, a “severe viral haemorrhagic fever” which, like a vampire, drains the life-blood from its victims.

The paper referred to the work now under way to develop a vaccine and “rapid diagnostics” to test whether asymptomatic carriers are unknowingly spreading the virus. It also leaves plenty of scope for a future ‘lockdown’ by stating that “extremely stringent infection control measures are needed to avoid people being in any contact with each other...”

2... WHO, August 2021

In a press briefing on 11 August 2021, the Director of the World Health Organization (WHO) announced the following:

“Last Friday, the Ministry of Health of Guinea informed WHO of a case of Marburg virus disease in the country’s south-west, in a man who died 8 days after onset of symptoms. This is the first known case of Marburg in West Africa. There is no licensed vaccine for Marburg, although there are vaccines under development, and WHO is working with our partners to seek opportunities to assess them during this outbreak through the R&D Blueprint for Epidemics.”

Marburg disease has been around since 1967 but only now is a vaccine in prospect. It is curious that the head of the WHO should be adverting publicly to this as Marburg is virtually unknown as a pathogen that might threaten any society and there is no demand whatever for a vaccine, not even in Africa – remember, it caused just 4 deaths worldwide in the period 2014-2017.

He then went on to say:

“Marburg is a very different virus to the one that causes COVID-19, but many of the elements of the response are the same: isolating and caring for those infected, tracing and quarantining their contacts, and engaging local communities in the response.”

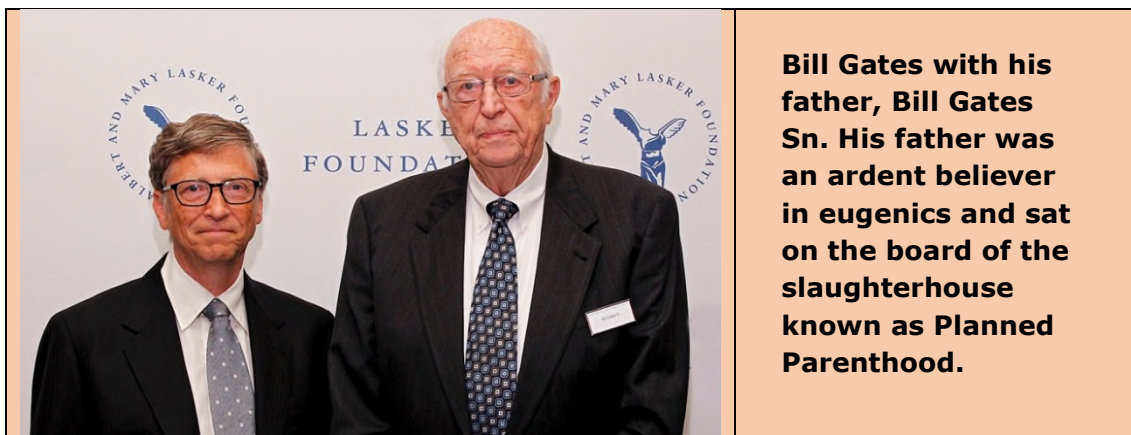
Here he is drawing a direct comparison between Covid-19 and Marburg. Since tracing and quarantining are mentioned, he is implying that asymptomatic carriers would pose a threat to the community. This happened to be the main ‘medical’ reason for locking down nearly all western economies during Covid.

3... The Marburg vaccine

We have seen that both GAVI and WHO speak of a Marburg vaccine currently under development. This is one of the two conditions that must be met before a bogus pandemic can be set in motion. The advantage with a vaccine that is still in the experimental stage was made obvious in the so-called Covid pandemic. It can be released on the public under emergency approval, with no requirement whatever to demonstrate that it is actually safe.

This is all very convenient.

GAVI is overseen by the notorious medical genius, Bill Gates. This egomaniac has selflessly dedicated the latter decades of his life to developing vaccines which earn staggering profits for his foundation and greatly enlarge his already considerable wealth. Since he is the principal financial contributor to the World Health Organization, without whose donations it could not survive, Mr Gates is personally framing and directing the policies followed by almost every country on earth for the containment and elimination of infectious diseases. No one in history has exercised this level of control over the well-being of humanity.



GAVI is the vehicle Gates is using, along with CEPI [see below] and his puppets in WHO, to shape medical opinion. The edicts issued by these bodies are then promulgated by the mainstream media and drip-fed to a naïve, scientifically illiterate public. So, when Gates says, *Watch out, Marburg is the next pandemic*, we can be fairly sure it plays an important role in his scheme to anchor future medical practise to his vaccine-themed ideology.

4... The Marburg test kit

The second condition that must be met before another ‘pandemic’ can be set in motion is the wide availability of a suitable clinical test for Marburg. The Covid lockdowns were enabled primarily by the bogus PCR test for Covid which was developed by a malicious German scientist. By using this phony test, governments were able to allege that the number of “cases” of Covid remained at a dangerously high level, even though the subjects concerned showed no symptoms whatever. This fraudulent concept, the ‘asymptomatic carrier’, was used to justify the suppression of social and economic activity across society and the incarceration of millions of healthy people in their own homes. The Marburg test will likely serve a similar purpose.

Details of the Marburg test kit were published by a company called PrimerDesign under its ‘genesig’ label in November 2018. It states: “The natural hosts of the Marburg virus are fruit bats, *Rousettus aegypti*. Transmission is thought to occur from fruit bats to humans after prolonged exposure to mines or caves inhabited by the bats... The symptoms of the disease are clinically indistinguishable from Ebola virus disease and can be easily confused with other prevalent diseases in typical regions such as other viral haemorrhagic fevers and more.” So, from a symptomatic perspective, Ebola and Marburg are “clinically indistinguishable.” This fits the narrative very nicely, leaving plenty of scope for obfuscation, ambiguity and confusion – exactly what one needs when pushing one bogus pandemic after another.



Soligenix

The company earmarked to produce the new Marburg vaccine is Soligenix. On 18 August, 2021, Soligenix issued a press release, “Soligenix Announces Positive Preclinical Data with Multiple Heat Stable Filovirus Vaccine Candidates” It said:

“Once developed, such a vaccine may be able to address emerging outbreaks, such as the Marburg virus infection that appeared in Guinea recently. We feel that this technology may be an important contribution to Dr. Fauci’s proposed idea to develop prototype vaccines against the top 20 viral families that may also cause pandemics. Having such a platform available would likely enable broader and faster worldwide vaccination campaigns addressing future health emergencies.”

Such a Fauci-friendly proposal should make one’s skin crawl. They envisage “worldwide vaccination campaigns” to address future pandemics and “health emergencies.” Since they are in the business of making profits – huge profits – we can infer that their pandemic predictions will shortly come to pass.


They also refer to the close similarity between Ebola and Marburg and the supposed common origin of these diseases, namely African bats:

“All species of ebolavirus belong to the Filoviridae family, a family that further contains the equally human pathogenic Marburg virus. Filoviruses are believed to be harbored in various animal species in Africa, particularly bats, although the specific reservoir host for many of these viruses is still unknown.”

They comment as follows on their funding sources:

“To date, this business segment has been supported with government grant and contract funding from the National Institute of Allergy and Infectious Diseases (NIAID), the Defense Threat Reduction Agency (DTRA) and the Biomedical Advanced Research and Development Authority (BARDA).”

Anyone who has studied this sordid business will hear alarm bells when NIAID, DTRA, and BARDA are mentioned in the same sentence. When these organizations work together it is solely in connection with bio-terrorism and biological warfare.

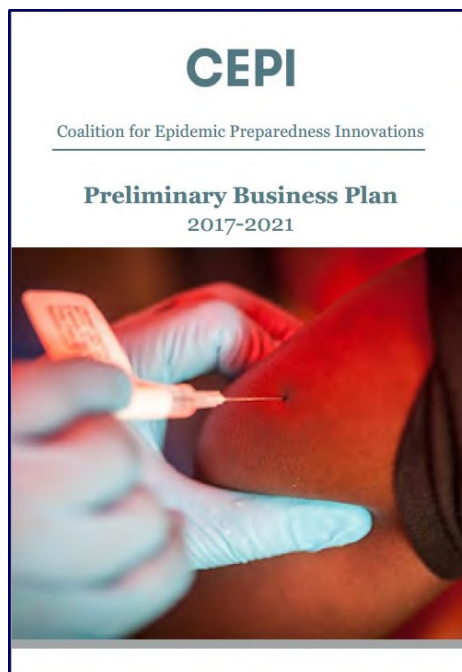

As we stated in some of our previous papers, a small number of immensely influential but little known investment companies own or control most of the large and highly profitable corporations on earth. The list comprises the core members or founders of CEPI (excluding delegates representing the Norwegian Government). All three organizations – the Wellcome Trust, the Gates Foundation, and the World Economic Forum – have high ranking members who are strongly committed to world population reduction and favor the use of eugenic methods, including euthanasia and stealth technology, for this purpose.

CONCLUSION

The Ruling Elite did a trial run of their pandemic strategy about a hundred years ago when they murdered more than 20 million people worldwide using vaccines newly developed by the US military – the first recorded case occurred at Fort Riley, Kansas. It is generally believed that the most harmful of these untried vaccines was the one designed to protect against bacterial meningitis.

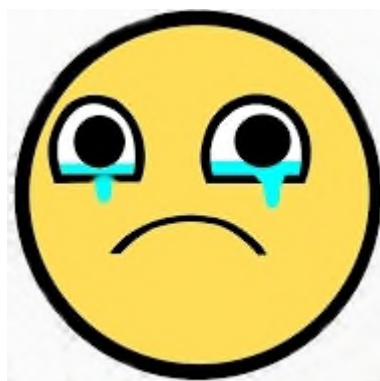
We know the catastrophe as 'the great Spanish Flu pandemic' but very few of these unfortunate victims died of flu. The cause of death in almost all cases was acute double pneumonia brought on by experimental vaccines. The background was as follows: The Rockefeller Foundation took advantage of the massive increase in the size of the US military in 1917 by administering more than a dozen experimental vaccines to new recruits. The same experimental vaccines were also exported to the military in Europe, mainly France. As soldiers sickened and died, the public became alarmed. The pharmaceutical industry took advantage of the great fear generated by this to develop and market so-called flu vaccines for the civilian population. As more people died, more rushed to receive one of these dubious new vaccines. Many of the victims were also encouraged to take large amounts of the 'wonder' drug known as aspirin which made them even more susceptible to respiratory failure. Thus, in a period of roughly six months, tens of millions of people died.

It is difficult at this remove to say how much of this catastrophe was due to malice aforethought, how much was due to further malicious actions taken during the event, and how much was due to medical stupidity and incompetence. One way or another the Elite learned a valuable lesson – If you want to kill millions of people, kill a small number first and blame their untimely demise on a deadly contagious disease and then advertise and exaggerate the disaster by every means possible. Next, offer the petrified public a miraculous ‘vaccine’ remedy. Include in the ‘vaccine’ a toxin which mimics the symptoms of the disease. Millions will die and no one will be any the wiser.

We have just seen a repeat of this wicked strategy in the so-called Covid pandemic.

The WEF-CEPI-GAVI-WHO coalition should be seen as an axis of evil that clearly intends to use Marburg and Ebola in its next campaign of terror. As Mr Morrissey suggests, they appear to want to exploit the hemorrhagic symptoms produced of the Covid vaccines to convince the public that a new, non-Covid, illness – both lethal and contagious – has arrived on the scene. This will deflect attention away from the real cause – the toxins secreted in the Covid vaccines – and place it on an imaginary new disease which, obviously, will require a miraculous vaccine to protect against it. In case the public is reluctant to accept the official explanation for the new illness, the authorities will have a ‘scientific’ test ready to prove that all of these cases are due to Marburg (or Ebola).

The alleged Marburg-Ebola test will likely be used in the same way as the bogus PCR test for Covid, marking as infectious, contaminated and dangerous anyone who tests “positive,” even if they are completely asymptomatic. We may witness a new round of lockdowns, far more draconian than the first, with millions of innocent people – all false positives – hauled off to quarantine camps for their own protection and the “greater good.” Even those who are not shown to be positive may be relocated from areas deemed by the authorities to be contaminated – please bear in mind that CEPI claims that person-to-person transmission can occur through direct contact with “contaminated objects.” Entire towns could be uprooted.
