

# How Modern Technology Could Counterfeit the Ten Plagues of Egypt

We are at an extraordinary time in history, not just history as man conceives it, but history as seen through the eyes of our Creator.

His Holy Word tells the story of history from His point of view. We must weigh it well since it sets out the parts we have yet to see, parts we can understand only by reference to what has already happened.

Throughout His Word, the LORD refers back to the series of “wonders” that He performed in ancient Egypt when He freed His chosen people from the iron furnace. Prior to the incarnation of Christ the Exodus is the singular event that He uses over and over again to exemplify His awesome sovereignty and power, not only before His chosen people but before the whole of mankind.

As Rahab said, forty years later, the people of Jericho had heard what the LORD had done in Egypt and they quaked at the prospect that this unusual nation was moving ever closer to their border. She understood what her fellow countrymen did not, namely that, while their military might contend with the Israelites, they had no chance against the God of Israel!

The demons, too, had seen what God had done. Jethro summed it all up when he said:

**“Now I know that the LORD is greater than all gods: for in the thing wherein they dealt proudly he was above them.” (Exodus 18:11)**

### **Advanced technology**

The great mill of history never sits still but grinds continually. With the advent of modern technology, Satan finally has an opportunity to foist upon the world his own version of the Ten Plagues of Egypt. For the first time in history he can attempt to reverse what he and his fallen angels must have perceived as a great humiliation.

Their shame was made even more painful when the LORD recorded His victory in detail in His holy Word and preserved it for the edification of all future generations. Anyone who cared to look would see that the sovereign God of the Israelites could thoroughly thrash the Enemy and that, despite his impious claims, he was not to be feared.

We know that the leader of the fallen angels is determined to be **“like the Most High” (Isaiah 14:14)**. Since this is his supreme ambition we can infer that everything he does must contribute in some way to achieving his ultimate goal. It means also that he probably wants to duplicate the Ten Plagues of Egypt and demonstrate to all – both angels and men – his ability to “compete” with God.

As part of this grand duplication, he intends to send his “son” to rule in his name over the entire earth, thereby usurping what God had declared was *His* divine prerogative.



**Turning the waters into blood.**

## Duplicating the Ten Plagues

While the Ten Plagues of Egypt were expressions of God's supernatural power, the Enemy was able to duplicate two of them at the time, namely, [#1] turning the waters into blood and [#2] raising frogs seemingly from nowhere. However, his occult power went only so far, both in relation to the type of counterfeit miracles he could perform and in relation to the extent or degree to which he could perform them. While the LORD could manifest His first two miracles across the entire extent of Egypt, Satan's sorcerers – as far as we can tell – were only able to perform their counterfeits in the immediate locality.

Unless his occult power has increased since that time, he will need to draw on additional resources to counterfeit the other eight plagues. The prime candidate for this purpose is advanced technology.



**The Plague of Frogs.**

Humanly speaking, we cannot assign a comparative difficulty to each of the Ten Plagues, but we can reasonably assume that the last would be the hardest of all to duplicate. The first nine were “blanket”-type events, covering all geographical regions without distinction (other than Goshen), but the last was incredibly selective.

In order to duplicate the tenth plague – killing all firstborn males – Satan would need to devise a way to kill by remote means the eldest male in each family on the same night, across a wide geographical area, and leave everyone else unharmed. Up to now this appeared to be an impossible task. For this reason most Bible commentators, as far as we can tell, have never considered the possibility that the Enemy might try to counterfeit the Ten Plagues.

It has become very apparent that the spectacular advances in technology which we have seen over the past century or so were intended by the Enemy to ensnare mankind. The more dependant we are on technology the more dependant we are on those who own and control that technology. Patents for new inventions are quickly bought up by the super-rich and only those which fit the Enemy's End Time plan are put into production.

Computer science and genetics have been the main beneficiaries in recent decades, largely because advances in these areas offer immense potential to control human behavior and to corrupt (or “improve”) the biological processes designed by our Creator.

### **The End Time role of “vaccines”**

Given what we have learned about Covid vaccines over the past year, it is clear that, not only are they part of a sinister agenda, but that the agenda itself appears to match what we know Satan wants to do to mankind. [We refer readers to our earlier papers on this controversial subject, including #205 (*Vaccines are the Perfect Vector for Mass Infection*), #255 (*Worldwide Vaccine Experiment on Human Guinea-Pigs*), and #295 (*Evidence that the Covid Vaccines Implant Bluetooth Biosensors*).]

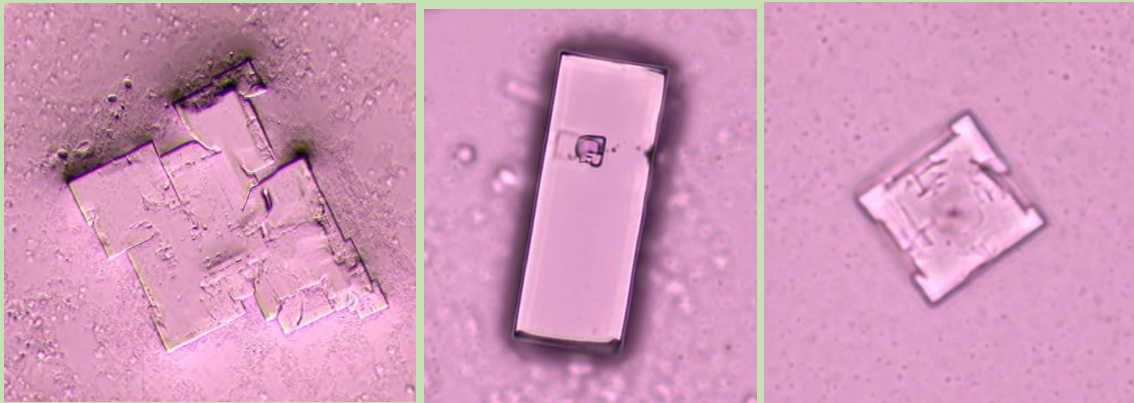


The public at large is not aware that the so-called vaccines are being used to infiltrate highly sophisticated nanoscale devices into our bodies.

*Nanoscale* refers to structures so small – a millionth of a millimetre – that they are extremely difficult to detect, even with a powerful optical microscope. Using various photographic and lighting techniques, Dr Pablo Campra, a professor at the University of Almeria, Spain, was able to capture the details of nanoscale objects embedded in the hydrogel of several vials of the Pfizer vaccine. A hydrogel is a colorless polymer – a type of plastic – which is able to absorb and retain water without losing its intrinsic structure. For some reason our immune system doesn’t attack it, so anything embalmed in a hydrogel, such as a miniature medical device or microchip, can survive indefinitely inside our body.

Dr Campra specializes in the detection of nanoscale ingredients in liquids using leading-edge microscopy. Since there are few scientists in Europe or America with both the equipment and the expertise needed to conduct this kind of analysis, his findings are especially valuable.

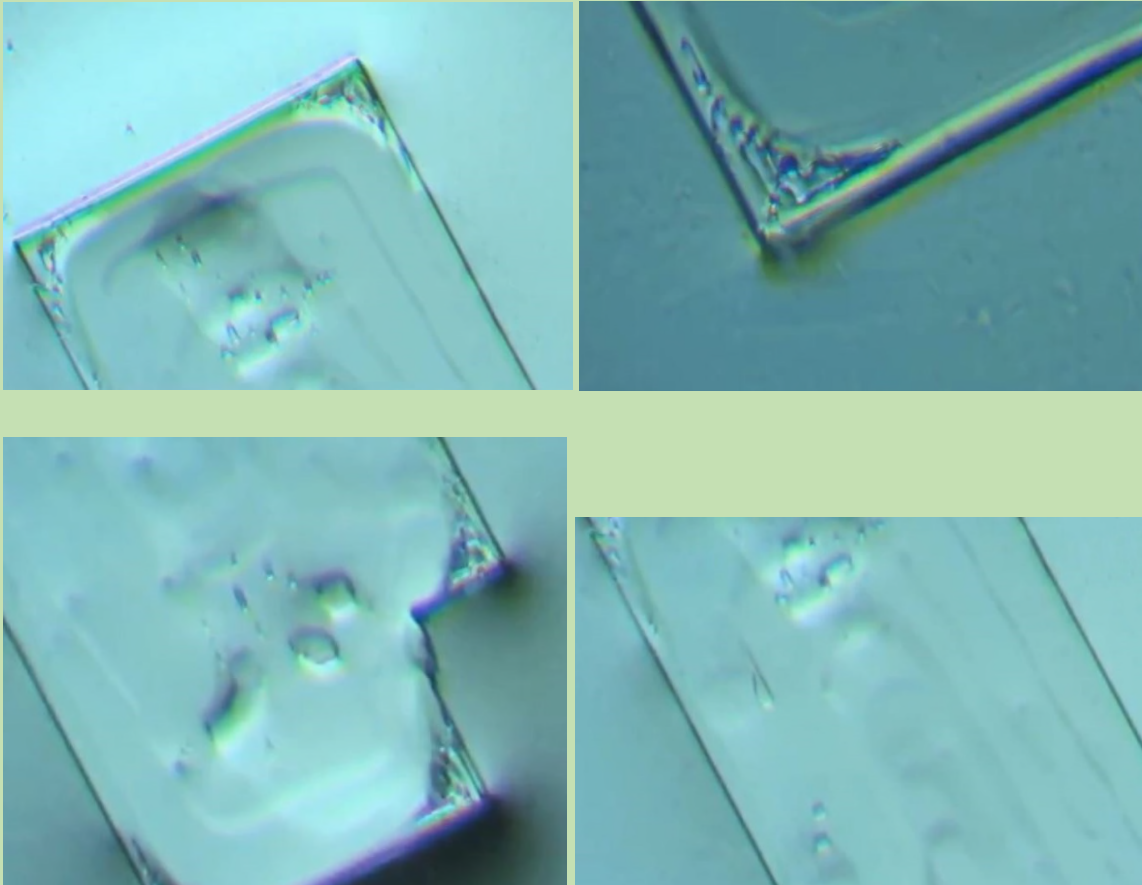
**According to some sources it is necessary to allow the water in the hydrogel to completely evaporate over a period of 4-5 days before these artificial structures become visible. This may explain why they are only being discovered now.**

Objects of this kind do not occur in nature. Any time one finds a structure with a right angle, one must always check to see whether it might be manmade. If several right angles are present, it is invariably manmade. So these “objects”, which are embedded in hydrogel and present in the Covid vaccine made by Pfizer, are a product of human ingenuity and have been added to the vaccines deliberately. They are clearly intended to survive intact inside our body and to perform some function, or possibly a range of functions, not specified by the manufacturer.

It is important to understand that the public is NOT meant to know about these ultra-small objects inside the vaccines. While numerous references to such nanoscale devices may be found in technical papers published over the last fifteen years or so, there is little public awareness of what they can do. The mainstream media never mentions them.

Dr Campra believes, as do a number of other scientists, that this nanoscale technology may be part of a wireless nanosensor network for monitoring biological processes inside the body. Given that the FDA approved the use of such devices by the pharmaceutical industry in 2017, and to their inclusion in pharmaceutical products, their suspicions are fully justified. And if this is the case, then we can understand why governments around the world are doing all they can to ensure that everyone, without exception, receives the Covid ‘vaccine’. A worldwide surveillance network which omitted, say, 10 percent of the population would not be nearly as effective as one which tracked absolutely everybody.

## **The Beast System**

Nanoscale biosensors will collect the data, wifi and smartphone antennas will transmit it, and a bank of powerful supercomputers will process it. None of this will require human intervention or oversight. It will operate automatically, 24 hours a day, 7 days a week, sending reports to the Ruling Elite that will enable them to identify potential dissidents and maintain a draconian grip on mankind. The "chronically noncompliant" will be eliminated.

Since wireless biosensors can both transmit and receive data, the central computer bank will be able to issue instructions to nanoscale devices inside an individual citizen or group of citizens. These could prompt their bodies to produce specified amounts of certain hormones which impinge directly on their behavior, mood or emotional state. This could be done simultaneously to millions of individuals in a city or state, none of whom would know that they were being manipulated in this way.

If they are now implementing this technology on a mammoth scale, we can be pretty sure (a) that it works, (b) that it has been thoroughly tested, and (c) that they will stop at nothing to ensure everyone is “captured” by the system. And if that is the case, then this is the system that the Antichrist will later use to impose the Mark of the Beast.

## **The Internet of Bodies**

This grand plan will work only where a target population is located within a computer-controlled microwave grid. This is the purpose of the 5G networks being constructed across Europe, America and elsewhere. They will comprise an invisible prison, especially in large cities, where the planned “Internet of Bodies” will monitor and control the masses on a continuous basis.

As several commentators have warned, the system will be used to reduce the population and to completely pacify those who remain. The word *genocide* may be used inappropriately at times, but it certainly fits the scenario that Satan and his servants in the New World Order have planned for mankind.

We would have difficulty comprehending this degree of evil if the Book of Revelation had not already informed us that this massive death toll is inevitable.

Christians in the main should have the spiritual strength to acknowledge that this is coming. If they do they should be able to see why a variation of this planned extermination – a *selective* genocide, if you will – would be especially pleasing to the Enemy. He could use the system to claim the lives of all firstborn males in a single night in whichever part of the earth he selects.

This would enable him, not only to emulate the Tenth Plague of Egypt, but to repeat it over and over again.

## The modus operandi

If we examine the technology that the Ruling Elite have already perfected, we can see how this sinister exercise could be carried out. Using the data transmitted by the Bluetooth feature implanted in each recipient of the Covid vaccine, a central database will compile a detailed record of the individual's personal information, including all the people they are related to or have social contact with. This will allow the firstborn males in every city or state to be identified.

Vaccine recipients also receive a dose of graphene nanoparticles to add to those already in their body, which were acquired by other means (aerosols, food products etc). These are sensitive to magnetic fields and tend to accumulate in those parts of the body which are most electrically active, namely the brain, heart and lungs.

An array of microwave antennas can then direct concentrated pulses of energy to a chosen target or location. One only needs the geographical co-ordinates, which a real-time tracking and surveillance system, namely the Internet of Bodies, will already have. The graphene and metallic particulates in his body will absorb this energy, just like a metal spoon in a microwave oven, and burn the sensitive tissue around them. Most victims of such an attack would survive no more than a few hours. Heart failure, a pulmonary embolism, a seizure, or brain hemorrhage would be given as the official cause of death in most cases.

This may seem farfetched, but it will help to remember that this technology was designed by the military for use on military targets. It contains no elements that were not thoroughly understood and tested more than thirty years ago (A type of graphene known as the fullerene or carbon-60 molecule was discovered in 1985). The only novel aspect of this scenario is its application in a civilian setting, where the intended targets have chosen, unwittingly, to live inside a massive, computer-controlled microwave grid and have obligingly allowed themselves to be inoculated with nanoscale biosensors and magnetic particulates.

What could possibly go wrong?

While it pains us to state it in these terms, it's as if all the chickens in the village decided to attend an event hosted by the local fox.

### **The Plague of Lice [#3]**

We will now examine briefly the way modern technology could be used to duplicate the other plagues of Egypt. Since we have already addressed plagues #1 and #2, we will begin with #3:

**“And the LORD said unto Moses, Say unto Aaron, Stretch out thy rod, and smite the dust of the land, that it may become lice throughout all the land of Egypt. And they did so; for Aaron stretched out his hand with his rod, and smote the dust of the earth, and it became lice in man, and in beast; all the dust of the land became lice throughout all the land of Egypt. And the magicians did so with their enchantments to bring forth lice, but they could not: so there were lice upon man, and upon beast.” (Exodus 8:16-18)**

The word for “lice” in the Hebrew text is *kên* (Strong’s H3654), which might also denote gnats. Either way, it is generally taken to mean a swarm of tiny insects. The Word of God does not specify the ailment or malady they induced, either in men or in animals. Perhaps they were mainly an irritant in one’s mouth, nose and eyes, disrupting normal daily activities. We are not told how long they lasted or whether a special act of God was required to remove them.

We won’t dwell on this plague since it would seem possible to duplicate it by breeding very large quantities of tiny insects in a laboratory and dropping them en masse from low-flying airplanes. We are unable to guess the quantity that would be needed to constitute a “plague” but the problem would seem to be primarily one of logistics rather than innovation.

### **The Plague of Flies [#4]**

The Hebrew text does not expressly state that the grievous swarm in the fourth plague consisted of flies per se, but most commentators take it to be implied:

**“And the LORD did so; and there came a grievous swarm of *flies* into the house of Pharaoh, and into his servants' houses, and into all the land of Egypt: the land was corrupted by reason of the swarm of *flies*.” (Exodus 8:24)**

The flies must have descended in vast numbers since it required a miracle of God to remove them, such that **“there remained not one.”**

Again, the challenge here is mainly one of logistics. Presumably, if enough resources are dedicated to this task, it could be done.

### **The Plague on Larger Farm Animals [#5]**

We are not told how this plague or pestilence (“murrain”) caused the animals to expire but seemingly they died in large numbers. The animals most affected were oxen, sheep, horses, donkeys, and camels, all of which had commercial value:

**“Behold, the hand of the LORD is upon thy cattle which is in the field, upon the horses, upon the asses, upon the camels, upon the oxen, and upon the sheep: there shall be a very grievous murrain.” (Exodus 9:3)**

The key point of note here (for our purpose) is that the animals died within a few days. Many may have died almost immediately. We know of no disease in large animals which can incubate inside a healthy specimen and cause death in such a short time. If this plague is to be duplicated, it would require a cocktail of harmful pathogens. These would have to be genetically engineered in a laboratory and delivered from the air, either in the form of an aerosol or a cloud of spores. Sadly, this is now possible.



### **The Plague of Boils [#6]**

The next plague begins as a shower of dust across the land of Egypt which, when it settles on man and beast, produces painful boils and inflamed pustules on the skin:

**“And the LORD said unto Moses and unto Aaron, Take to you handfuls of ashes of the furnace, and let Moses sprinkle it toward the heaven in the sight of Pharaoh. And it shall become small dust in all the land of Egypt, and shall be a boil breaking forth with blains upon man, and upon beast, throughout all the land of Egypt. And they took ashes of the furnace, and stood before Pharaoh; and Moses sprinkled it up toward heaven; and it became a boil breaking forth with blains upon man, and upon beast.” (Exodus 9:8-10)**

The Enemy could duplicate this plague also with airborne, genetically engineered pathogens. He would appear to be experimenting with this already through the use of chemtrails which are known to distribute, among other things, tiny fibers that infiltrate the skin and cause a painful condition called morgellons disease.

## **The Plague of Hail [#7]**

Since everyone in Egypt had advance warning that a deadly hail storm was coming, those with any sense could ensure they were indoors when it struck, along with their animals:

**“And Moses stretched forth his rod toward heaven: and the LORD sent thunder and hail, and the fire ran along upon the ground; and the LORD rained hail upon the land of Egypt. So there was hail, and fire mingled with the hail, very grievous, such as there was none like it in all the land of Egypt since it became a nation.” (Exodus 9:23-24)**

The ones who took steps to protect themselves had respect for what the God of Israel could do and “feared the word of the LORD”:

**“He that feared the word of the LORD among the servants of Pharaoh made his servants and his cattle flee into the houses: And he that regarded not the word of the LORD left his servants and his cattle in the field.” (Exodus 9:20-21)**

Since modern weather-modification technology can produce terrible storms and cause a wide range of extreme meteorological conditions, the Enemy will have no difficulty duplicating Plague #7 (as far as we can tell). The component parts – the hail, the fire, and the electrical effects – will be artificial to some degree, as in any counterfeit, but to the world at large the outcome will nonetheless be very convincing and very destructive.

## **The Plague of Locusts [#8]**

This plague, it would seem, was designed to destroy the crops and foliage that survived plague #7:

**“And the LORD said unto Moses, Stretch out thine hand over the land of Egypt for the locusts, that they may come up upon the land of Egypt, and eat every herb of the land, even all that the hail hath left.” (Exodus 10:12)**



Now and then certain countries in Africa and Asia experience a plague of locusts, but few compare to the one which struck regions of East Africa, Arabia and India in the period 2019-2021. It was the worst outbreak in Kenya in 70 years. We would normally ascribe these outbreaks to a natural cycle or, in some cases, to a failure by national authorities to take elementary precautions to limit the growth of the locust population. However, on this occasion, so many countries were affected simultaneously, across a wide geographical area, that one must ask whether other factors were at work.

We already know that Bill Gates and his cronies are keen to interfere with the reproduction cycle of certain insect populations, notably mosquitoes, by altering their genetic profile. They even released genetically modified mosquitoes in Florida in May 2021, despite intense local opposition. This was done, allegedly, to lower the incidence of malaria and other pathogens carried by mosquitoes. However, many believe that this is part of a wider program to develop genetic techniques that can be applied across a number of insect species. The scientific knowledge gained from these unethical experiments may enable techniques to be developed which accelerate, rather than reduce, the rate of insect reproduction. It may also disclose ways to efficiently farm insect larvae in large quantities and release them en masse when they have reached maturity.



### **The Plague of Darkness [#9]**

The ninth plague rebuked the sun god, Ra, whom the Egyptians revered. He was supposed to be the most powerful of all the deities in their extensive pantheon and yet he was helpless. The idea that he could be completely erased for three days was simply unthinkable to the Egyptians:

**“And the LORD said unto Moses, Stretch out thine hand toward heaven, that there may be darkness over the land of Egypt, even darkness which may be felt. And Moses stretched forth his hand toward heaven; and there was a thick darkness in all the land of Egypt three days: They saw not one another, neither rose any from his place for three days: but all the children of Israel had light in their dwellings.” (Exodus 10:21-23)**

This darkness was a “darkness that may be felt.” We would take this to mean that it devoured even the light given off by a candle or lamp. The Israelites alone “had light in their dwellings” over the three-day period,

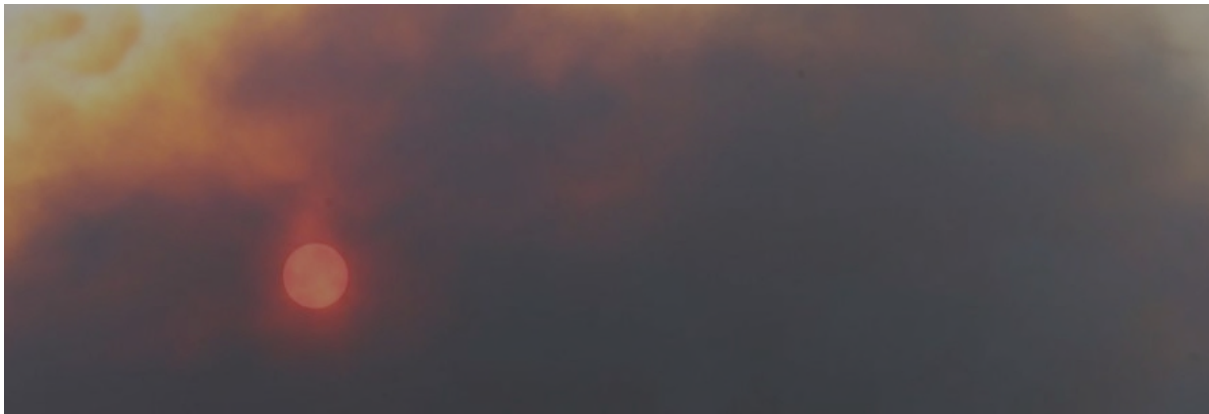
The Enemy will not be able to make a perfect counterfeit of this plague but he will get as close as he can. We can infer this from a number of prophetic passages, including:

**“... for the day of the LORD cometh, for it is nigh at hand; a day of darkness and of gloominess, a day of clouds and of thick darkness...” (Joel 2:1-2)**

**“The sun shall be turned into darkness, and the moon into blood, before the great and the terrible day of the LORD come.” (Joel 2:31)**

**“Shall not the day of the LORD be darkness, and not light? even very dark, and no brightness in it?” (Amos 5:20)**

**“That day is a day of wrath, a day of trouble and distress, a day of wasteness and desolation, a day of darkness and gloominess, a day of clouds and thick darkness...” (Zephaniah 1:15)**



We will consider in a moment a possible cause of this darkness. In doing so we must be careful to distinguish it from a separate darkness which is sent directly by the sovereign will of God and poured out on “the seat of the beast” – the kingdom of the Antichrist – toward the latter part of the Tribulation:

**“And the fifth angel poured out his vial upon the seat of the beast; and his kingdom was full of darkness; and they gnawed their tongues for pain, and blasphemed the God of heaven because of their pains and their sores, and repented not of their deeds.” (Revelation 16:10-11)**

The earlier darkness would seem to begin near the start of the Tribulation and to continue, and possibly get worse, as time progresses.

Volcanic activity is the most common cause of reduced solar illumination. For example, when Krakatoa exploded in 1883 it sent a massive quantity of volcanic ash high into the atmosphere and darkened the sky worldwide – to a modest extent – for several years thereafter. The End Time increase in volcanic activity (Matthew 24:7) may prove to be the main cause of the “darkness and gloominess” foretold by Joel, Amos and Zephaniah.

In our paper, *Earthquakes, Technology and the End Time* [#284], we discussed the role that rebellious man will play in these events. The US military, as well as the military in several other countries, are understood to possess high-energy electromagnetic devices which can stimulate the level of seismic activity in a region and create earthquakes. They even have a treaty to limit their use, which would confirm that they actually exist and that they are effective.

There are also projects under way to determine how solar radiation could be “dimmed”. For example, the Keutsch Group at Harvard are currently conducting experiments under their SCoPEX program, which they describe as follows:

SCoPEX is a scientific experiment to advance understanding of stratospheric aerosols that could be relevant to solar geoengineering. It aims to improve the fidelity of simulations (computer models) of solar geoengineering by providing modelers with experimental results vital to addressing specific science questions. Such simulations are the primary tool for estimating the risks and benefits of solar geoengineering, but current limitations may make the simulations look *too good*. SCoPEX will make quantitative measurements of aspects of the aerosol microphysics and atmospheric chemistry that are currently highly uncertain in the simulations.

This research into “solar geoengineering” – an impressive name for a dangerous idea – is funded in part by Bill Gates.

The most obvious way to impose a great darkness is to sabotage the electrical grid. When the lights go out, there will be a great universal darkness, but only during the night time hours. As a counterfeit this does not go far enough, but it could form part of a wider plan.

## CONCLUSION

We know that the turbulent events described in the Book of Revelation will come to pass, each and every one of them, exactly as the Word of God foretold. We know, also, that the Enemy wants to “be like God” and that he may be keen to counterfeit the wonders which God Himself performed in Egypt to demonstrate His sovereignty. Finally, we know that the masterminds behind the proposed New World Order have been secretly developing advanced technology to subdue and coerce the masses, all with the aim of imposing a worldwide system of social control.

In this paper we have tried to show how these three elements fit together.

Until quite recently we had little evidence to show that the Enemy might be able to select and kill the firstborn. The better we understand his objectives the more we can discern how certain types of technology might be used to advance them. For example, if we accept that he might be planning to emulate the Tenth Plague of Egypt, then we can see how a mass vaccination program could have a sinister purpose, feeding data into a real-time surveillance system and allowing individual targets to be identified and tracked. We can also see why he might install a massive microwave grid in all our towns and cities and use it to fatally injure chosen targets.

For far too long, the majority of Christians have treated Bible prophecy as an *interesting* study, if they bothered to study it at all. But it is not just interesting; it is also intensely practical. They forgot that they had an enemy. As a result they couldn't see how the LORD's prophetic warnings were shining a light on the plan that the enemy was actually following. They bought instead the fantasy future projected by the media and the entertainment industry and the dreamland propaganda that issues forth continually from so-called scientific experts and technological gurus.

The harsh reality is never openly discussed. The sheer wickedness of the forces arrayed against us is simply not understood. Even Christians cannot see that our leaders today are every bit as ruthless as the Lord revealed to us during his ministry:

**“Woe unto you, scribes and Pharisees, hypocrites! for ye compass sea and land to make one proselyte, and when he is made, ye make him twofold more the child of hell than yourselves.” (Matthew 23:15)**

These people are exactly as Jesus said, Children of Hell. We have included photos of three of them on pages 7 and 8.

The rulers of this world serve the prince of this world, and when it comes to imposing their Antichrist system, which they are calling the New World Order, they will show no mercy. The Children of Hell are going to come storming forth with cruelties we never imagined.
