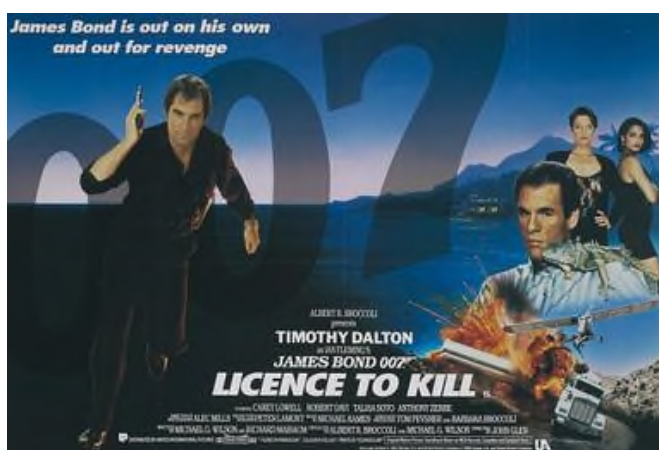


Legalized Tyranny is Hastening the Marxist Takeover of Europe and America

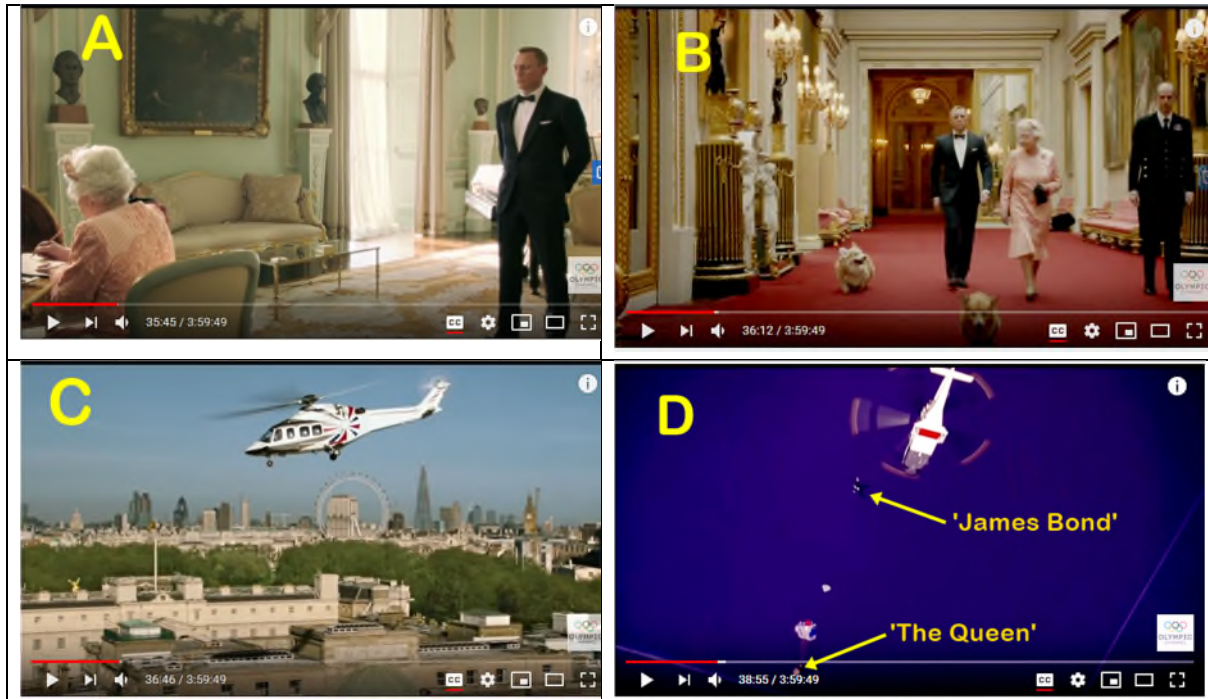

The Illuminati gave a ritual preview of their intentions at the opening ceremony of the 2012 Olympic Games in London. We discussed this, along with their planned treatment of our children, in our paper, *Medical Tyranny as a Weapon to Break Up Families and Harm Children* (#231).

The ceremony itself began with the staged arrival of the Queen Elizabeth II, accompanied by – of all people – ‘James Bond’, played by the actor Daniel Craig [See photos [overleaf](#)]. He waits patiently in her office at Buckingham Palace as she completes a letter (A). Next he accompanies her to a helicopter (B) which carries them both across London to the Olympic stadium (C). In a staged display they jump from the helicopter and descend slowly by parachute to the fawning multitude below (D).

There is a dark significance behind this elaborate piece of pantomime. James Bond carries a “licence to kill” and his official security ID is 007 – see graphic [above](#).



The numerical code 007 was associated with John Dee, the famous sorcerer who served Queen Elizabeth I. It was said to be the glyph or secret signature that he used when communicating with the monarch.

A Licence to Kill

Of particular interest is Bond's "licence to kill". In the world of the Illuminati, this is seen as the prerogative of Cain, who defied God and killed his brother. The Children of Wickedness believe that they too possess this right, the "licence" to kill with impunity. They see this as the triumph of the will and the ultimate rejection of God's moral authority.

So, while some may see this licence to kill as a kind of professional qualification, it is in reality an authorization by the Crown to act outside the law. If he chooses to do so Bond may kill without being held accountable by anyone, not even the Crown. Of course, if he used it too liberally and drew undue attention to his profession or his employer, the Crown could remove his licence to kill.

By arriving from the sky, the Queen and her lawless companion were further emphasizing their separation from the enslaved masses of mankind. The *illuminatus* likes to believe that he has become a god or that he is in the process of transmuting himself alchemically into a god. This is a threshold event in world history since it is the first time that any democracy has passed a Bill which enables the government to lawfully commit serious crimes against its own citizens. Once it has been approved by the House of LORDS, this vile piece of legislation will allow the state to bypass the law whenever it chooses. The persons or persons who carry out these crimes on behalf of the state will be immune from prosecution. Since the kinds of crimes they may commit are not specified in the legislation, they can include abduction, torture and murder.

What the state can do to its own citizens

Many readers may find it difficult to believe that the UK has done this. Surely there are very tight controls on what the state can do to “protect” itself? Well, according to this Act, there aren’t. This will become clear as we examine the details.

According to the Explanatory Memorandum which accompanied the Act

authorized agencies may “participate in criminal conduct where it is necessary and proportionate to do so for a limited set of specified purposes.”

an authorization to commit a crime can only be given “(a) in the interests of national security, (b) for the purpose of preventing or detecting crime or of preventing disorder, or (c) in the interests of the economic well-being of the United Kingdom.”

a criminal conduct authorization will render the conduct “lawful for all purposes.”

The state is judge, jury and executioner under this Act. What is worse, the state itself in this instance comprises but a few faceless individuals who between them can collude to abduct and murder whomever they choose. It is only necessary that they concoct in advance a threat of sufficient gravity to justify abduction and murder as a “proportionate” response.

This is an astonishing power to grant anyone. Even if all the facts in relation to a case were subsequently brought into the public arena, there would be no way to challenge or verify any of the evidence presented by the state. Its version of events would carry the day in a court of law, assuming it is even possible under this Act – this assassin’s charter – to prosecute the state for its possible abuse of the legislation. Remember, no crime has been committed. The conduct authorized was lawful for all purposes. The best one could hope for is a judicial review of the procedures followed in a given instance. If successful, one or two civil servants in Whitehall might be told to tighten up their procedures, but the matter would end there.



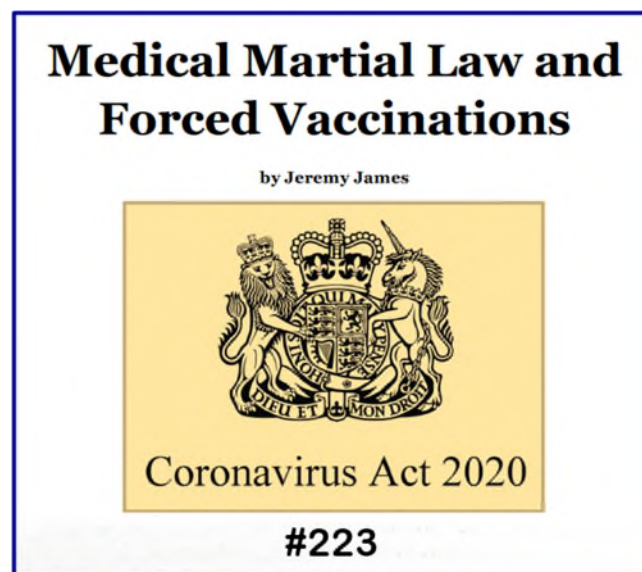
Cain Killing Abel

An assassin’s charter

Have no doubt, this Act is an assassin’s charter. It enables the government, should it choose to do so, to draw up a list of political opponents or outspoken critics of its regime and have them liquidated one by one. The Act even makes it possible to disguise this heinous activity by having a number of different agencies involved. One might have thought that covert killing under the legislation would be “licensed” only to MI5 or MI6, but this is not the case. In fact a bewildering array of public service agencies are empowered to conduct clandestine crimes, including murder. The Act lists the following:

- Any of the intelligence services
- Any police force
- The National Crime Agency
- Her Majesty's Revenue and Customs
- Any of Her Majesty's forces
- The Department of Health and Social Care
- The Home Office
- The Ministry of Justice
- The Competition and Markets Authority
- The Environment Agency
- The Financial Conduct Authority
- The Food Standards Agency
- The Gambling Commission
- The Serious Fraud Office

It is extraordinary to think that a few officials at the Home Office could, by conspiring together, concoct a threat that would warrant the abduction and murder of an innocent person. The officials concerned could claim to have based their assessment on evidence which no outsider could refute. After the killing had been carried out, the Act could be quietly invoked and any possible police investigation avoided. The aggrieved relatives might never get to hear what actually happened, except perhaps after many years when there was little hope of gathering evidence and all records were sealed for reasons of national security.



State sanctioned killings of this kind have been commonplace in communist, fascist and Muslim countries for a great many years. The Neo-Marxist regime that controls the UK has decided that it is now time to implement its own completely legal, *Made in Britain* version of the same wicked procedure.

We are aware of only one other piece of UK legislation which displays the bare fangs of the state in such lurid detail. Under the UK Coronavirus Act of 2020, the government can order the indefinite detention in an isolation facility of any person whom it considers may be infected with Covid-19. Then, following his “unexpected” demise, the authorities can have his body cremated and the ashes sent to his grieving widow. No post mortem, no enquiry into the cause of death. Again the version of events supplied by the state will be final.

An open contempt for humanity

The UK legislation reveals an open contempt for humanity. It does not bother to hide itself. The same contempt may be seen in other jurisdictions, though not necessarily in such a brazen legislative form. A startling recent example of this is the mandatory *Guidance for Private Gatherings* released by the California Department of Public Health on October 9th.

California is one of the largest economies in the world, with a population of about 40 million. It has, until recently, been seen by many as a bastion of human enterprise, innovation and individualism. It has long enjoyed a reputation for light regulation and minimal state interference in the exercise of one’s civil liberties. However, the *Guidance* document issued by the Department of Public Health, and addressed to “All Californians,” reads like a mandate compiled by the Chinese Communist Party.

California or Communist China?

Here are some extracts, with our comments in square brackets:

“Gatherings that include more than 3 households are prohibited... The host should collect names of all attendees and contact information in case contact tracing is needed later.”

[There is a legal obligation on the host to keep a record of everyone who attends a simple family gathering. Four siblings cannot gather with their respective families because that would breach the “three household” rule. This bizarre document places a family gathering on the same footing as a meeting between complete strangers.]



“All gatherings must be held outside. Attendees may go inside to use restrooms as long as the restrooms are frequently sanitized.”

[It is comforting to know that the state will allow participants to visit a restroom. It is a mark of the contempt that the authorities have for the residents of California that they even tell them where to pee. If they go into the family home for any other reason they are guilty of an offense. The voice of Satan echoes throughout this wicked document.]



“Gatherings may occur in outdoor spaces that are covered by umbrellas, canopies, awnings, roofs, and other shade structures provided that at least three sides of the space (or 75%) are open to the outdoors.”

[The 40 million residents of California are mocked and ridiculed by this absurd requirement. The authorities have the audacity to define the shape of the “space” we can have around us, even when we’re outdoors! If your umbrella is too long on one side, you could be accosted by the police.]



“This know also, that in the last days perilous times shall come...Yea, and all that will live godly in Christ Jesus shall suffer persecution. But evil men and seducers shall wax worse and worse, deceiving, and being deceived.”

- 2 Timothy 3:1,12,13

“...multiple gatherings of three households cannot be jointly organized or coordinated to occur in the same public park or other outdoor space at the same time – this would constitute a gathering exceeding the permitted size.”

[This requirement makes it an offense to go to the park and discover, heaven forbid, that one’s neighbors got there first. The state will tell you where you can go and who you can socialize with.]



“For any gatherings permitted under this guidance, the space must be large enough so that everyone at a gathering can maintain at least a 6-foot physical distance from others (not including their own household) at all times.”

[If a member of one household happens to bump against a member of another household, law enforcement can intervene. It is now a crime to hug your brother or your sister in a public park.]



“Seating must provide at least 6 feet of distance (in all directions—front-to-back and side-to-side) between different households.”

[No family gathering is complete without a measuring tape. If children want to play together, presumably they will have to do so online. The level of insanity behind this requirement is matched only by its outrageous contempt for humanity. Anyone who can pen this sort of garbage is either suffering from an acute mental illness or they have made a covenant with the powers of darkness.]



“Everyone at a gathering should frequently wash their hands with soap and water, or use hand sanitizer if soap and water are not available. Shared items should not be used during a gathering. As much as possible, any food or beverages at outdoor gatherings must be in single-serve disposable containers.”

[Remember, this guidance document was prepared by people who claim to “care” about other people. But they are liars. Their hearts are poisoned by envy. They hate what they see in their fellow man, a creation formed in the image and likeness of God. As the Bible says: **“A sound heart is the life of the flesh: but envy the rottenness of the bones.” (Proverbs 14:30)** Truly, a great rottenness has forged this loathsome document.]



“When gathering, face coverings must be worn...People at gatherings may remove their face coverings briefly to eat or drink as long as they stay at least 6 feet away from everyone outside their own household, and put their face covering back on as soon as they are done with the activity. Gatherings should be two hours or less.”

[It now turn outs that, not only must you stand at least 6 feet away in every direction from members of other households, occupy only the right kind of space, wash your hands “frequently”, and enter your home only if you need to use the bathroom, but you must wear a face mask as well! Such a joyous occasion, alas, cannot extend beyond a strict two-hour limit.]



“...singing, chanting, and shouting are strongly discouraged, but if they occur, the following rules and recommendations apply: All people who are singing or chanting should wear a face covering at all times while singing or chanting, including anyone who is leading a song or chant...People who are singing, shouting, chanting, or exercising are strongly encouraged to maintain physical distancing beyond 6 feet to further reduce risk...People who are singing or chanting are strongly encouraged to do so quietly (at or below the volume of a normal speaking voice)”

[Singing at a family gathering is “strongly discouraged” but should such an unnatural activity take place, everyone must continue to wear a face mask. Pardon? Are we now in North Korea? Even the unfortunate prisoners in the gulag could sing if the brutal guards were out of earshot! Seemingly the 40 million in the new gulag known as ‘California’ can sing only if they whisper (“below the volume of a normal speaking voice”).]



“Playing of wind instruments (any instrument played by the mouth, such as a trumpet or clarinet) is strongly discouraged.”
