

# Major Covid Test Center being Built on the Grounds of a Large Mental Hospital

The hour is late.

The two draconian laws passed by the Irish Parliament in March 2020 to “combat” Covid-19 conferred astonishing powers on those who wish to destroy Ireland’s sovereignty and drag our country – beaten, bruised and humiliated – into the New World Order.

The second of these, the ***Emergency Measures in the Public Interest (Covid-19) Act 2020***, which was passed on 27 March, enables the police to “detain” anyone whom they believe may be suffering from a “mental disorder.” Once a person is taken into the so-called mental health system in Ireland, it is very difficult to get out. The Act makes it more difficult still by reducing the membership of the mental health ‘Tribunal’ – who review each case – from three down to one. This lone individual is not even a medical professional, but a lawyer (solicitor or barrister)!

Furthermore, a person detained under the Mental Health Act 2001 can be forcibly medicated by the state. [See relevant extracts from the legislation in **Appendix A.**]

When legislation designed to address a supposed pandemic includes a provision which strengthens police powers under the Mental Health Act, we know that persons “suspected” of having the fake Covid virus but who refuse to be tested could then be “suspected” of something else – a mental disorder.

Further evidence of this emerged recently when work began on a major drive-thru Covid Test Center in Newcastle, County Wicklow, about 20 miles from Dublin. The facility, which would appear to entail land clearance and development over four acres, is located in the grounds of a mental hospital.

The maps below show the extensive grounds of the hospital, the area of the grounds where the Test Center is being built, and the number and size of the buildings already in situ which can be fitted out to accommodate a significant increase in the number of 'residents':

We spoke with a woman living near the facility who said that her community has not been officially informed that the state was building a major test center in their town. We also spoke to a worker on the new site who confirmed that it was a drive-thru test center but that he had no idea why so much land was being developed for this purpose.

Later we raised the matter with one of our contacts in the Garda Síochána who told us, off the record, that many similar facilities are being built around Ireland and that they were being located in the grounds of former TB sanatoriums (similar to Newcastle Mental Hospital). We would infer from this that, if the state needed to swiftly and unobtrusively “detain” non-compliant people under the Mental Health Act, it would be able to do so.

## **Mandatory Testing and Mandatory Vaccinations are Coming**

It is clear from numerous comments made by senior personnel at the World Health Organization, the CDC, several high-profile medical journals, prominent academics, and various influential medical establishments that governments – ALL governments – will adopt a mandatory approach to both testing and vaccination.

This will likely be advertised as a free, voluntary service but anyone who falls into the non-compliant, “reluctant” category will forfeit certain rights and privileges. It is already known that travel on many airlines is conditional on being Covid-tested. Those who test positive cannot travel and are required to self-quarantine.

Imagine a scenario where no-one can leave their home unless they have tested negative for the so-called virus. Such tests would need to be repeated every few weeks to ensure that this “highly contagious” virus had not been contracted by someone else in the home. This is insanity, of course, but the public has been conditioned to accept these medically nonsensical measures because “we are all in this together.”

The mainstream media will increasingly portray “reluctant” citizens as irrational and selfish, as people who have no regard for the common good and who are prepared to put everyone else’s life at risk by not taking the test and the vaccine. Shrill cries of denunciation on our television screens will sway many who would otherwise avoid the test and, in particular, the vaccine. Only a courageous minority will hold firm.

Alas, this minority will be under siege. If the government decides to lock them away, they will receive little or no sympathy from others. Many will be glad to see such anti-social cranks and misfits getting what they deserve.

Few will pause and ask themselves what the vaccine actually contains. No-one will want to be told, or would dare to believe, that a vaccine cannot be developed for a virus which has never been isolated – and which very likely doesn't exist. Nor will they ask why millions will race to inject into their bodies a substance that has never been tested! It defies belief.

The history of vaccines is peppered with horror stories – see our earlier papers on this gruesome topic. But worse still, it is littered with evidence that the vaccine industry is thoroughly corrupt, lying shamelessly about the supposed efficacy of its products and systematically suppressing a mountain of data which would reveal the harm they are doing. Recent advances in genetic engineering have allowed them to concoct a whole new range of potions which can alter the chemical behavior of our cells and insert new sequences into our genetic code. The industry openly boasts of its ability to do this, even though the medium-term to longer-term implications of such changes are unknowable.



**Beate Bahner describes how she was treated**

“When the police did arrive, I told them I felt threatened. They brought the handcuffs out and pushed me to the ground with massive force... then they drove me around the corner to the psychiatric clinic. There were four police officers there, three nurses, and a doctor... I was thrown to the floor again, having my head hurled onto the stone floor from a metre (3 ft) height, which nobody reacted to...Because I refused to move, they physically carried me to the doctor, who asked me "why I felt threatened", even though they all know perfectly well who I am. I was told I would not be given a lawyer. Then I was forced to spend the night lying on the floor in some high-security Guantanamo psychiatric clinic ...There was no toilet, no sink, though they did allow me water, and there was a bell I could ring, though they ignored it after the third time I pressed it.”

Not even an industry operating in accordance with the highest standard of ethics could be trusted with such technology, and yet millions of naïve parents are prepared to allow the ruthless pharmaceutical companies which dominate the market to inject their children with vaccines that could cause sterility or harm their immune systems.

The legal case for mandatory vaccination is being made with a view to capturing the rational minority and forcing them to surrender their bodily integrity. It has been clearly set out in a recent paper in the *Journal of Medical Ethics* (20 August 2020) by three Oxford academics – T Douglas, L Forsberg and J Pugh. In their argument they rely heavily on the assumption that, if the existing Covid restrictions are ethical, then mandatory vaccination, being no more invasive, is also ethical. Here is how they put it:

“...free movement and association are severely constrained by measures such as quarantine and isolation, whereas compulsory vaccination or treatment would likely involve only a moderate interference with bodily integrity; and ... the strong precedence given to bodily integrity in the case of treatments and vaccines for pandemic control is difficult to reconcile with existing law on testing for pandemic disease and on mental health treatments.”

- **Compulsory medical intervention versus external constraint in pandemic control**

Their reference to “mental health treatments” is significant. They reason that, if it is ethical to compulsorily incarcerate and medicate a person with a mental disorder, both for his own good and for the good of the community, then it must be no less ethical to compulsorily medicate a person for Covid-19, both for his own protection and the protection of the community.

In the following passage they refer to a person as “capacitous” if, despite having a mental disorder, they have decision-making capacity:

“Non-consensual treatment of capacitous individuals under the Mental Health Act for the purposes of the protection of others is analogous to the case of compulsory medical intervention for pandemic control... Indeed, if anything, it might seem that considerations of harm suggest that we should be *more* willing to interfere with people’s bodies in the case of pandemic control than in mental health... the law need not always reflect morality; there can be perfectly good pragmatic or political reasons for regulating one type of intervention more stringently than another, even though the interventions are similar in their moral justifiability.”

There it is, the profound Oxford argument for discarding the long-established principle of bodily integrity and forcing the entire population to receive a potentially dangerous vaccine. Sceptics will add that the vaccine is not just *potentially* dangerous but harmful by design. However, lest the legal and ethical case against this abomination be improved in some way, the canny authors add that there can be “perfectly good pragmatic or political reasons” for doing it anyway. So there, that settles it. It took three nerds from Oxford about 6,000 words to express what the Nazis managed to condense down to three: Arbeit macht frei.

As I write this I am reminded of a quote by Charles Kingsley, author of the famous children’s book, *The Water Babies*. On a visit to Ireland in 1860, he wrote home to his wife expressing his utter contempt for the Irish peasants: “I am haunted by the human chimpanzees I saw along that hundred miles of horrible country... to see white chimpanzees is dreadful; if they were black one would not see it so much, but their skins, except where tanned by exposure, are as white as ours.”

## Culling the Herd

The Ruling Elite, who are behind this plan to drastically cull the “herd” – the masses of humanity – see everyone outside their occult bloodlines as “white chimpanzees.” In their twisted, Satanic philosophy, the murder of tens of millions of people is entirely acceptable. The end justifies the means. If huge numbers of people must die to facilitate the creation of a New World Order, then so be it. Toward this end they have formulated three broad strategies – pestilence, famine, and war. All three have been used in the past, nation by nation, as and when required. This time, however, they plan to use all three together – on a worldwide scale.

They even boast about this in an episode of *The Simpsons* cartoon series, which aired only a week ago (seemingly on 31 October / Halloween). In this episode, the lazy lump called ‘Homer’ plans to vote early and get Trump out of office. However, he falls asleep in his hammock and dreams of the coming chaos. When his wife returns she is furious because he forgot to vote. As he sits up dazed in his hammock he recalls the scenes that he saw in his dream. 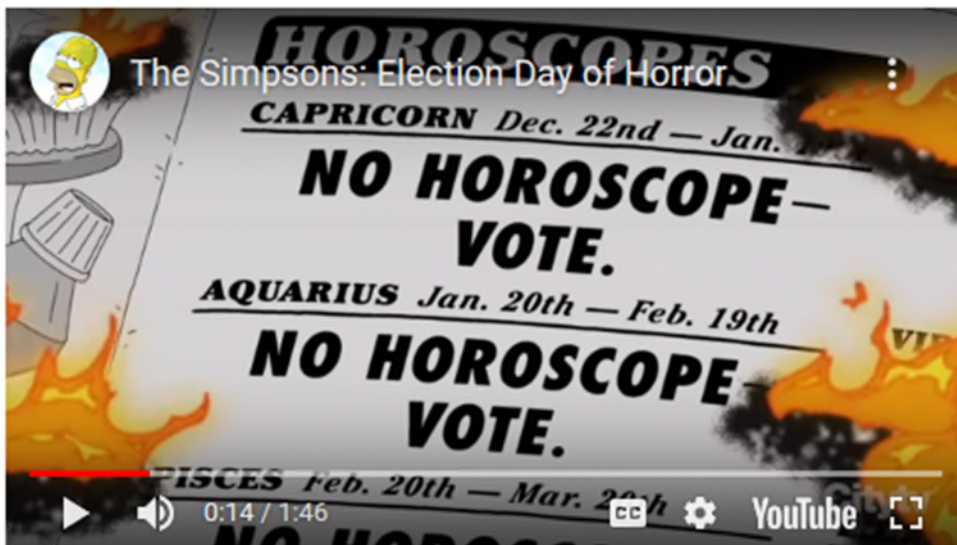
The episode opens with the dawn of Election Day.

### **Predictive programming**

This episode of *The Simpsons* is an exercise in what is sometimes called 'predictive programming', where an undiscerning audience is conditioned to accept, at a subconscious level, the inevitable manifestation of the 'fictional' narrative portrayed on their television screens. The Illuminati are telling their intended victims what they are planning to do. We can see the arrival, simultaneously, of their three great agents of change – pestilence, famine and war. The horseman on the left is the harbinger of death, possibly the Antichrist.

We have already had a foretaste of the work they are planning under 'Pestilence'. The Covid-19 *pandemic* has been used to condition the masses to accept that large-scale biological war can be waged against them, resulting in millions of deaths. We know this certainly did not happen with Covid-19, but we also know that entire nations are now bracing for the possibility that it will. In the process the masses have been conditioned to believe that the ONLY solution, the ONLY way to return to NORMAL, is to develop an effective vaccine and make everyone take it. This will open a potential avenue for pestilence on an unimaginable scale.

In their quest for normality people are prepared to surrender the most basic freedoms. As Huxley put it in *Brave New World*, “Anything for a quiet life.” The so-called Brave New World that Huxley describes is the proposed New World Order where “science” – technocracy – controls the whole of mankind and ensures everyone’s “happiness”, primarily through the use of narcotic drugs and erogenous pleasure. To get there, however, the world must endure the trauma of the Nine Years War. Much of the mass killing in *Brave New World* was achieved through the use of “anthrax bombs”. Seemingly it was these ghastly fatalities which persuaded everyone who survived the War to accept the ‘technocracy of happiness’.

## Huxley’s description

Here is how Huxley described it toward the end of the book:

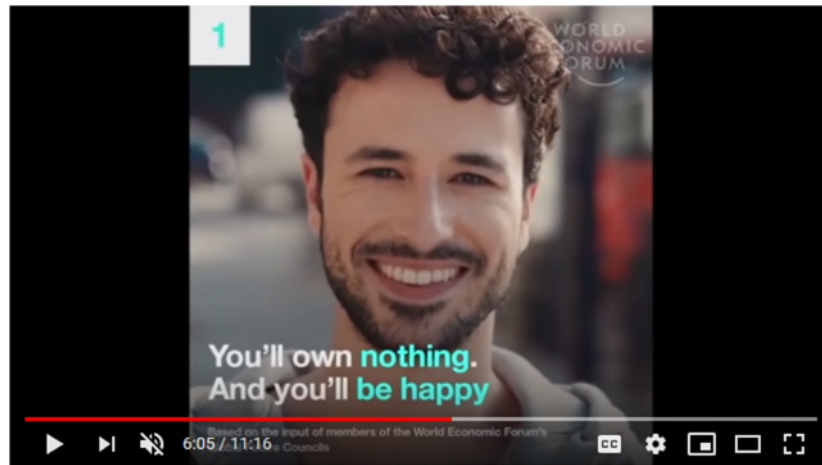
“**Universal happiness** keeps the wheels steadily turning; truth and beauty can’t. And, of course, whenever the masses seized political power, then it was **happiness** rather than truth and beauty that mattered. Still, in spite of everything, unrestricted **scientific** research was still permitted. People still went on talking about truth and beauty as though they were the sovereign goods. Right up to the time of the **Nine Years’ War**. That made them change their tune all right. What’s the point of truth or beauty or knowledge when the **anthrax bombs** are popping all around you? That was when **science** first began to be controlled – after the **Nine Years’ War**. People were ready to have even their appetites controlled then. Anything for a quiet life. We’ve gone on controlling ever since. It hasn’t been very good for truth, of course. But it’s been very good for **happiness**.” – *Brave New World* by Aldous Huxley, chapter 16

Huxley envisaged a Nine Years War to achieve the transition from the ‘old’ world order to the New World Order. Interestingly, the planned transitional gap between the goals set out in two famous UN policy documents, *Agenda 21* and *Agenda 2030*, is 9 years.

In 2016, the World Economic Forum released a short video which made 8 predictions about the world in 2030:



Prediction No.1 was straight out of Huxley's *Brave New World*:



(Why will you own nothing? The WEF plans to achieve this via The Great Reset, which we will discuss below.)

We have already examined Predictions 2 and 4 in previous papers (see #214 and #202):



The fourth prediction is part of the 'Famine' agenda. The Elite are planning to reduce the availability of meat, especially red meat, and thereby make it much too expensive for the average family to afford. This is why they are developing so many 'tasty meat' substitutes. 
### **The Famine Strategy**

We are already seeing indications of the way they plan to do this. Increasingly cows and other large domestic animals are being classified as anti-green, consuming too much of the earth's resources and creating so-called 'greenhouse' gases. Meat processing factories are being shut down because of alleged Covid-19 outbreaks, while Covid-type outbreaks are supposedly affecting other forms of animal husbandry. For example in Denmark recently 1.5 million mink were marked for extermination because they had 'contracted' (if not incubated!) a new form of Covid. This turns farming itself into a breeding ground for new diseases, requiring strict controls on what can be produced and in what amounts. Mink are not food, of course, but similar bogus claims can be made to shut down the farms which produce the food we need, such as beef, turkey, and chicken.

Some years ago a large proportion of the cattle population of the UK was slaughtered on the grounds that the national herd was infected with a new disease called BSE (*bovine spongiform encephalitis*). The cattle were more likely poisoned by toxins in their processed diets than by a transmissible disease. The massive culling of the national herd to deal with new viruses – including the ever-mutating, ever-ingenuous Covid-19 – may be used, not only in the UK but in many other countries, to drastically reduce the availability of meat for human consumption.

The hoax known as ‘manmade global warming’ will probably be used to limit the grazing available to sheep, forcing farmers to rear them in purpose-built pens at much greater cost. Sheep may even ‘contract’ their own version of BSE since *that* disease was supposed to have originated from scrapie, which is found only in sheep and goats.

Perhaps the greatest threat to date to the world’s food supply is weather modification technology. The US military and many other countries have weapons which can generate extreme weather conditions and destroy crops. These “storms from nowhere”, along with extended periods of drought, unseasonably heavy rainfall and extreme changes in temperature, have inflicted considerable damage in recent years on US food production.

**Living under a blanket of 5G radiation Americans will now be subjected to much higher levels of EMF exposure and microwave heating than ever before. It will be possible to create Covid-type outbreaks in selected areas simply by turning up the power in designated transmitters. One can only guess how this huge electronic matrix will affect livestock and pollinating insects.**

A great deal more could be said about the steps being taken by the International Dictatorship to reduce the world’s food supply. For example, GMO crops are nothing but a trap designed to transfer control over certain cereals and staples into the hands of big corporations. This will affect not only the safety and nutritional quality of the crops concerned, but their availability and price.



One of the simplest ways to create havoc in the food supply chain is to bring down the electricity grid for a day or two. Much of the frozen food in commercial stores, processing facilities, and domestic homes would be destroyed. This is not something we tend to think about but a 2-day blackout could cause serious food shortages in big cities and towns and result in great distress for low-income families. Replacement stocks could take a week or more to arrive and looting could be widespread.

### **The Great Reset planned by the World Economic forum**

In our paper, **The Coming Heist will be Called *The Great Reset*** (#235), we covered the implications of ‘the great reset’ planned by the World Economic Forum. The ‘reset’ will impose on a fragile, unsuspecting world a new economic system that will replace Capitalism. The Elite believe that if they can create sufficient mayhem and instill enough fear, they can lure the masses into accepting a ‘solution’ that will effectively abolish private property and neutralize money as a store of value. In short, they are planning to use the coming financial crisis to implement full-blown Communism.



Under Communism, the state owns all domestic housing. The individual lives only in rented accommodation, approved by the state, and works at a job controlled by the state. In the USSR few families received more than a subsistence wage, so there was little opportunity to save. And if one did manage to accrue some additional cash, there were very few consumer goods available to purchase. The whole of society was effectively enslaved by the Kremlin and surveilled continually by the secret police. Dissidents were arrested in the middle of the night and sent to the gulag. Many were shot or worked to death.

## Communism and The Great Reset

The Elite plan to use The Great Reset to force the nations to accept a form of soviet-style Communism. Mass surveillance will be achieved via technology. Dissidents will be identified and quietly eliminated (being classified as ‘deaths from Covid’). The coming crash will enable the ultra-rich to buy up the choice means of production at fire-sale prices, while countless small and medium-size enterprises in private ownership will simply collapse. Those people who are fortunate enough to be employed will work either for the state as ‘public servants’ or for mega corporations owned by the same people who control the state. Everyone else will survive on a state allowance or unemployment benefit known as Universal Basic Income (UBI). And it *will* be basic. The middle class will no longer exist.

The Davos Gang, led by Klaus Schwab – the public ‘face’ of The Great Reset – are confident that the worldwide financial collapse, which they have spent decades engineering – to be triggered, perhaps, by what Schwab called a “cyber pandemic” – will cause immense suffering and widespread panic. Faced with the prospect of massive social unrest, huge unemployment, escalating crime, and unimaginable poverty, the vast majority will accept the Davos deal. The deal itself will likely include many if not all of the following elements:

1. The transfer of all fiscal policy decisions from sovereign states to a central world government. This will effectively turn countries into counties, administrative units within a state that comprises the entire earth.
2. The abolition of all currencies and the introduction of an electronic payment system connecting all parts of the world. This new method of settlement may be called a “digital currency” for a time, but it will really be nothing more than a glorified PayPal. One’s UBI will be paid into an online account and all transactions recorded. There will be no other way to make or receive payments. Private barter may even be outlawed on the grounds that it facilitates criminal activity.
3. Since people won’t have an income to tax, there will be no income tax. Workers will see this as a benefit, but their wages will probably never rise very far above the UBI.
4. Since all savings will be wiped out, existing mortgages and other debts will be unpayable. These will be “forgiven” – another pseudo-benefit – provided one transfers the underlying asset (collateral) into state ownership. Those who own their homes outright will probably be allowed to retain them but all such properties will be hit with painful annual residential taxes. Since those who fail to pay these taxes will risk forfeiting their homes, many will opt instead to hand the property to the state and avoid eviction.

5. The threat of deadly viral pandemics will continue to be used as a tool to frighten and control the “herd”. Acceptance of the deal will include unqualified consent to all state-sponsored medical tests and vaccines.

6. Acceptance of a code of ethics for all humanity, based on universal tolerance of human diversity, will be mandatory. No-one will be able to claim that their religion is uniquely true or that their understanding of ‘God’ is the only correct one. Hate speech in all its forms will be punished. Abortion, homosexuality, same-sex marriage and gender diversity will be treated as natural, morally neutral human activities.

7. Everyone will be required to participate in a universal Social Credit system. This is already operating in China. Real-time surveillance will enable the state to monitor the location and online activity of every citizen. Those who spend time, online or physically, with ‘obedient’ citizens will gain social credit points, as will those whose online activity – websites visited, items purchased, etc – conforms with the norms and values espoused by the state. On the other hand, mildly inappropriate behavior will result in a loss of social credit points. Only citizens with sufficient points will be able to avail of certain services or travel more widely. Those whose ratings fall below a certain threshold will be transferred to a re-education facility.

8. The prospect of euthanasia will be incorporated into the concept of a personal carbon footprint. Using the lie of global warming the deal will make it possible to assign to each person – at some future date – a number of carbon points which they can use in their lifetime. Once his or her quota is exhausted, the individual will be expected to say, “I have lived a good life” and step into the termination chamber.

9. Since 1-8 above require some means of online electronic identification in real time, everyone will be required to wear or carry a microchip device. The question of whether the chip will be implanted may not be addressed in this phase of the Plan. The ‘deal’ may be allowed to run for a few years before everyone is ordered to accept an implantable chip. This will likely be linked to a requirement to accept the new ‘World Leader’ as the savior of mankind. This would appear to correspond to what the book of Revelation calls “the mark of the beast”.

### **The Fourth Industrial Revolution**

This totalitarian takeover is being touted as The Fourth Industrial Revolution. In other words, it is being sold to the people as an inevitable historical process which mankind should embrace and not resist. This, of course, is mainstream Marxist dogma, the lie known as Historicism. The first industrial revolution came with the invention of the steam engine; then came electrical power and the immense range of new applications that it enabled; and thirdly, computerization, which produced the so-called information age. The Fourth Industrial Revolution is meant to comprise the amalgamation, and thus the exploitation, of artificial intelligence, genetic engineering and nanotechnology. With this so-called revolution, the world will move beyond the information age into that of Transhumanism, where even our own bodies can be genetically and cybernetically ‘enhanced’, producing longer life, vast increases in personal potential, and the ability to shape our own destinies.



This psychopathic dream is based on the Luciferian lies which beguile the minds of the Wicked. Supposedly it is Satan’s way of setting man free from the laws and restrictions mandated by God. If he goes about it in the right way, they claim, man can even become a god in his own right. Once he learns to make full use of his imagination and harness the incredible promise and potential of advanced science and futuristic technology, there will be no limit to what he can achieve.

Alas, in their fallen state, a great many today believe these lies. Satan has only one objective, to enslave mankind. He already owns and controls the minds and hearts of the Elite. Since they are completely within his power he can use them to implement his dark plan for mankind as a whole. The great advances in technology are being used by him, not to aid and comfort humanity, but to furnish the Wicked with a powerful set of tools to weaken, encircle and enslave the nations.

### ***Dark Winter and Shielding***

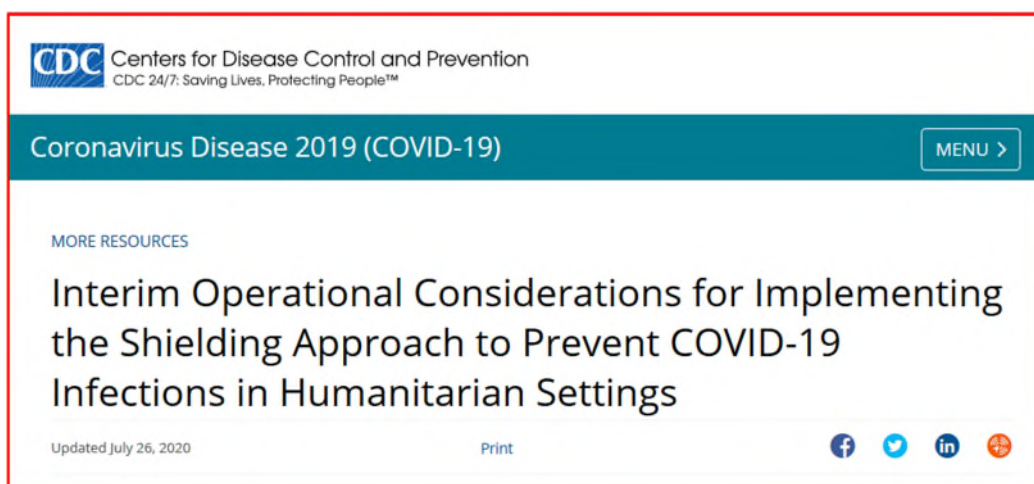
We now arrive at two additional terms which the Elite – Satan’s band of earthly servants – have been pushing into the public domain over the past few months. These are “dark winter” and “shielding”.

During the final Presidential Debate on 22 October, Joe Biden said, rather ominously, “We’re about to go into a dark winter. A dark winter.” Other high profile commentators have also used this strange expression. It echoes a troubling remark made by the Pope at a public gathering in December 2015:

“While the world starves, burns, and descends further into chaos, we should realise that this year’s Christmas celebrations for those who choose to celebrate it may be their last“.

As a leading figure in the coming New World Order, the Pope knows where all of this is heading – “the world starves, burns, and descends further into chaos” – but he may not know the actual details. He may have believed that the Covid hoax (or a similar event) was scheduled to start in 2016, in which case Christmas of 2015 would have been the last truly celebratory Christmas that mankind would experience. In other words, the winter of 2016 seemed to him, at the time, to be the “dark winter” which the Illuminati were planning for mankind.

The other word that we are now hearing is “shielding”. This is the cunning euphemism that the CDC is using to denote a draconian control policy which employs, among other things, isolation facilities and internment camps.



The public is largely unaware of the policies already in place which make it perfectly plain that large numbers of Americans – men, women and children – will be locked away in quarantine centers for six months or more. These are not policies designed to cater for some future, hypothetical situation, possibly confined to a few small regions, but a nationwide program that is set to be implemented in 2021.

If you doubt this, please go to the CDC website and read the document called **Interim Operational Considerations for Implementing the Shielding Approach to Prevent COVID-19 Infections in Humanitarian Settings** (dated 26 July 2020). We will look at a few direct quotations from the document to show what the US government is planning to do to tens of thousands – if not millions – of loyal, patriotic Americans. We examine the quotations in the same sequence as they occur in the document.

“This approach has never been documented and has raised questions and concerns among humanitarian partners who support response activities in these settings.”

At the very outset they admit that what they are planning to do has “raised questions and concerns” among experienced professionals in the field of humanitarian relief. Why? Because it is illegal.

“The shielding approach aims to reduce the number of severe COVID-19 cases by limiting contact between individuals at higher risk of developing severe disease (“high-risk”) and the general population (“low-risk”). High-risk individuals would be temporarily relocated to safe or “green zones” established at the household, neighborhood, camp/sector or community level depending on the context and setting. They would have minimal contact with family members and other low-risk residents.”

The shielding approach involves isolation at household or neighborhood level, but also at camps appointed for this purpose. These camps are misleadingly called “green zones” as though they were fun places to be. Actually, as we shall see in a moment, they will be ugly and distressing places, like existing refugee camps in Africa and Asia.

Who will end up in these camps? Anyone deemed “high-risk” by the government. This means the government alone, using tests and criteria of its own devising, will decide who gets hauled away for six months. Entire families could disappear.

“the shielding approach suggests physically separating high-risk individuals from the general population”

The shielding approach does not simply “suggest” physical separation from the general population, but actively requires it! And it will be rigorously enforced. The phrase “strict adherence” is used three times in the document.

“A group of shelters such as schools, community buildings within a camp/sector (max 50 high-risk individuals per single green zone) where high-risk individuals are physically isolated together.”

Since each camp will hold no more than 50 internees, there will be no need to build dedicated isolation facilities. Existing schools and community buildings will serve just as well. As we noted in a previous paper, schools across America are already designed to meet high security standards, with tall wire fences, reinforced windows and doors, and restricted access.

Why will internees be sorted into groups of 50? Well, we know that the Enemy likes to mock the Word of God, so possibly this division of the “flock” is a blasphemous parody of **Luke 9:13-14** – **“But he said unto them, Give ye them to eat. And they said, We have no more but five loaves and two fishes; except we should go and buy meat for all this people. For they were about five thousand men. And he said to his disciples, Make them sit down by fifties in a company.”**

The more one explores the pattern of factual material relating to this highly organized Communist takeover of America, the harder it is to deny that the forces behind it are truly evil.

“One entry point is used for exchange of food, supplies, etc. A meeting area is used for residents and visitors to interact while practicing physical distancing (2 meters). No movement into or outside the green zone.”

And there it is again – “one entry point.”

The document refers only once to “visitors” – because there won’t be any. The last sentence makes this fairly obvious: “No movement into or outside the green zone.”

“The shielding approach advises against any new facility construction to establish green zones”

The shielding approach is intended to be low key. New facilities would attract too much public attention. Where “green zones” are operational they will almost certainly display no outer sign of their purpose. The local community may not know that the nicely painted building off the main road is holding 50 people against their will, and that there are several others just like it within a five mile radius.

“Currently, we do not know if prior infection confers immunity.”

This statement is evidence that the “green zones” are internment camps in the true sense. The captors alone decide who leaves and who stays. No-one can get well because no-one is ill. Once the state decides you are “high-risk” – such as a Bible-believing Christian or an outspoken critic of the ruling regime – then you are fair game.

“Dedicated staff need to be identified to monitor each green zone. Monitoring includes both adherence to protocols and potential adverse effects or outcomes due to isolation and stigma. It may be necessary to assign someone within the green zone, if feasible, to minimize movement in/out of green zones.”

The coy wording of this provision conceals an iron fist beneath the velvet glove. For “dedicated staff” read armed guards. These will “minimize movement” in and out of the “green zones” – You can be sure.

“Additionally, many camps and settlements host multiple nationalities which may require additional separation, for example, Kakuma Refugee Camp in Kenya accommodates refugees from 19 countries.”

“Plan for an extended duration of implementation time, at least 6 months.”

“The national capacity in many of the countries where these settings are located (e.g., Chad, Myanmar, and Syria) is limited.”

Could it be stated any more plainly? These “green zones” are refugee camps for Americans who will be arbitrarily selected and locked away for at least six months by their own government.



“Herd immunity (the depletion of susceptible people) for COVID-19 has not been demonstrated to date. It is also unclear if an infected person develops immunity and the duration of potential immunity is unknown. Thus, contingency plans to account for a possibly extended operational timeline are critical.”

This provision underlines the fact that no-one will be able to leave. It also suggests – meaning it will definitely happen – that the expected minimum stay of six months will be greatly extended.

“...this shielding approach may have an important psychological impact and may lead to significant emotional distress, exacerbate existing mental illness or contribute to anxiety, depression, helplessness, grief, substance abuse, or thoughts of suicide among those who are separated or have been left behind.”

“...there is no empirical evidence whether this approach will increase, decrease or have no effect on morbidity and mortality during the COVID-19 epidemic in various humanitarian settings.”

The document seems to exult in the suffering that these policies will inflict. It’s as though the authors could not resist the opportunity to mock their intended victims. The mockery continues in the second excerpt above where the CDC actually admits they have no “empirical evidence” that this radical “shielding” approach will make any difference whatever!

The next two quotations move beyond mockery into deliberate taunting:

“While the shielding approach is not meant to be coercive, it may appear forced or be misunderstood in humanitarian settings.”

“Most importantly, accidental introduction of the virus into a green zone may result in rapid transmission and increased morbidity and mortality as observed in assisted care facilities in the US.”

This must have been written with a venomous sneer. The shielding approach is *blatantly coercive*. It will not be misunderstood. Everyone who is subjected to this tyranny will know exactly what they are being made to endure. They will know also that it has nothing whatever to do with their well-being.

The second quotation above is chilling. Whenever a document like this uses words like “accidental” we should take it as a veiled reference to something that will definitely happen at some point. These camps will be used to eliminate ‘undesirables’, namely those whom the Communist controllers see as a potential threat to their authority. The list is long. The victims, of course, will die from a sudden outbreak of ‘Covid’ in this supposed place of ‘safety’.

### **The approach in Canada**

The government of Canada has recently called for tenders to build and run a number of much larger internment camps in that country. It is believed that 11 have already been constructed and 9 more are planned. An intrepid journalist would appear to have located one of them, just south of Portage in Manitoba. The locals have expressed their concern, especially at the need for a secure containment fence around a facility that is meant to provide humanitarian relief. [The camp is currently empty.]



## CONCLUSION

Over the many papers in this series we have tried to show the lengths to which Satan will go in his quest to destroy Christianity and impose across the entire earth a wicked totalitarian regime. For a born-again Christian who believes the Word, who – unlike most professing Christians – does not turn End Time prophecy into allegorical nonsense, the Bible is a wonderfully reliable guide. ## APPENDIX A

### Mental Health Act 2001 (Section 12)

**12.—(1)** Where a member of the Garda Síochána has reasonable grounds for believing that a person is suffering from a mental disorder and that because of the mental disorder there is a serious likelihood of the person causing immediate and serious harm to himself or herself or to other persons, the member may either alone or with any other members of the Garda Síochána—

Powers of Garda Síochána to take person believed to be suffering from mental disorder into custody.

- (a) take the person into custody, and
- (b) enter if need be by force any dwelling or other premises or any place if he or she has reasonable grounds for believing that the person is to be found there.

### Mental Health Act 2001 (Section 48)

Mental Health  
Tribunals.

**48.—(1)** The Commission shall from time to time appoint one or more tribunals which or each of which shall be known as a Mental Health Tribunal (in this Act referred to as “a tribunal”) to determine such matter or matters as may be referred to it by the Commission under *section 17*.

(2) A tribunal shall consist of 3 members.

(3) Of the members of a tribunal—

- (a) one shall be a consultant psychiatrist,
- (b) one shall be a practising barrister or solicitor who has had not less than 7 years’ experience as a practising barrister or solicitor ending immediately before such appointment who shall be the Chairperson of the tribunal, and
- (c) one shall be a person other than a person referred to in paragraphs (a) or (b) or a registered medical practitioner or a registered nurse.

## Emergency Measures in the Public Interest (Covid-19) Act 2020 (Section 16)

### Exigencies of public health emergency

16. The Act of 2001 is amended by the insertion of the following section after section 2:

“2A. (1) A reference in this Act to the exigencies of the public health emergency is a reference to the exigencies of the public health emergency posed by the spread of Covid-19 and, in particular, to:

- (a) the manifest and grave risk to human life and public health posed by the spread of Covid-19;
- (b) the necessity, for compelling reasons of public interest and for the common good, for measures and safeguards to prevent, minimise or limit the risk of persons being infected with Covid-19;
- (c) the effect, on the availability of consultant psychiatrists and other persons to perform functions under this Act, of the spread of Covid-19 and of the deployment of the resources of the health services in order to—
  - (i) prevent, minimise or limit the risk of persons being infected with Covid-19,
  - (ii) test persons for Covid-19, and
  - (iii) provide care and treatment to persons infected with Covid-19.

## Emergency Measures in the Public Interest (Covid-19) Act 2020 (Section 20)

“(3A) Notwithstanding subsections (2) and (3), where it appears to the Commission that, due to the exigencies of the public health emergency, a tribunal cannot be appointed in accordance with those subsections, it may appoint a tribunal consisting of one member who shall be a practising barrister or solicitor who has had not less than 7 years’ experience as a practising barrister or solicitor ending immediately before such appointment.”
