

The World is Under Demonic Attack

The Word of God has warned of a time when dark spiritual forces would come against the world and take control of mankind. We are already familiar with the outcome of the first great attack when Satan induced Adam and Eve to rebel against the LORD and strive in their own power to become gods. The history of mankind up to now, a period of six thousand years or so, has shown the long and painful consequences of that awful spiritual betrayal.

During this time, the Enemy sought by every means in his power to prevent the coming of Christ and, thereafter, to conceal the fact that he came and redeemed the world. Murder, violence and deception are his stock in trade. After the passage of two thousand years, the nation chosen by the LORD to bear witness to Him on earth has still not come to a recognition of their horrifying failure to receive their Messiah at his first coming.

They can read Isaiah 53 and still see nothing but their own vain imagination. The glorious truths expressed in those precious words are hidden from a people who have not yet set aside their pride-filled, defiant heart and declared, “Blessed is he who comes in the name of the LORD!”

The demonic forces which have blinded Israel for so long have also been exercising a tight hold over the rest of humanity. The Word of God has been hammered incessantly via reams of scientific criticism, the scepticism of embittered academics, and wave after wave of reinterpretation, mistranslation and rationalization. Meanwhile the serried ranks of preachers and pastors who had sworn to uphold it have slipped quietly from the field of battle and taken refuge in a cosy corner of this fallen world.

How to define a demonic attack

None of this fits the popular notion of a “demonic attack.” The slow weathering of scepticism and unbelief would, of itself, appear to be sufficient to achieve this dismal outcome. But the Word of God is *not* a philosophy or a doctrine! It is not a compendium of propositions to which we give our assent or which we evaluate according to some human standard of perfection. The Word of God is the very voice of our Creator! It speaks to us as nothing else can, and those who stand in its power are protected and upheld by the One who spoke it into existence.

Men have drifted far from the truth of the Bible because they have been exposed from an early age to an alternative voice, the Sibylline whispers of the legions of demons whom Satan has trained to beguile our minds. Our fallen imaginations provide fertile ground for the seeds of disbelief and vain introspection which are scattered continually by these malign beings.

Jesus told Peter that he prayed for his protection from Satan’s malicious plan “to sift him like wheat” -

“And the Lord said, Simon, Simon, behold, Satan hath desired to have you, that he may sift you as wheat: But I have prayed for thee, that thy faith fail not: and when thou art converted, strengthen thy brethren.” (Luke 22:31-32)

As a target of Satan, Peter was under demonic attack. We can see from this passage that Jesus did not cancel or oppose this sifting process but instead gave Peter the strength he needed to endure it. We cite this incident, not to suggest that a born-again believer will necessarily be “sifted” in this way, but to show that this malign supernatural being is constantly watching for an opportunity to catch us off guard.

We are familiar with the way this works at an individual level, but what happens when an entire nation is caught off guard? We are witnessing this today. America, Canada, Australia and New Zealand, along with a host of European countries, are being “sifted like wheat.” Their populations are being tossed to and fro by forces they cannot understand and, try as they might, they are unable to repel this intense spiritual assault.

Peter had the prayers of Jesus to sustain him, but these nations have long decided that they don't need Jesus. So what are they to do? They don't seem to realize that, without Jesus, they are naked and helpless.



The occult helmsmen

After they sinned, Adam and Eve were keenly aware of their nakedness. The shame they experienced was akin to the humiliation that these nations are having to endure. Their citizens are beginning to see that their sovereignty is an illusion and that their destinies are decided by people in high places whose identities are unknown to them. In their nakedness they fear being driven into a corner where even greater dangers lurk and so they submit themselves naively to the paternalistic policies devised by their respective governments.

Lacking any connection with God, they are driven by fear. Entire populations have succumbed rapidly and passively to the sweeping mandates imposed by their political leaders, mandates which threaten, not just their economies and their social fabric, but even their health and the health of their children. Their citizens are no longer thinking as individuals but have surrendered both their dignity and their autonomy to the mob.

We can see here how a tiny percentage of the populations of these countries are holding the reins and making the nations stampede. The Word of God draws attention to this principle in the Epistle of James when it speaks of great ships which are **“turned about with a very small helm, whithersoever the governor listeth.” (James 3:4).**

It is not for nothing that Mao Tse Tung, the mass murderer who ruled China, virtually unopposed, from 1949 to 1976, was known as “the Great Helmsman.”



The role of genocide

This relatively small group of people – the Cabal – are at the helm. They got there by employing considerable guile and deception, skills acquired over many generations through their service to Satan. Some of their most senior members are so heavily imbued with the spirit of darkness that they function as direct channels of communication between Satan and his horde of earthly servants. In the final analysis the plan being followed by the Cabal is a plan devised by Satan himself.

For readers who are disinclined to believe that genocide is part of this plan, genocide on a worldwide scale, they should ask themselves why Satan would settle for anything less. He has hated mankind from the outset. Since man was made in the image and likeness of God, Satan wants to remake this special creation in his own image and likeness. In pursuing this goal he intends to eliminate a large part of humanity and re-engineer those who remain. The series of ‘Covid’ injections would appear to be a central part of this plan, where modified DNA, including DNA from animal sources, will be inserted into the cells of compliant human beings.

This may be why these injections are being given on a phased basis. The ‘transformation’ may need to be gradual, allowing time after each injection for the respective genetic modification to take effect. Over a period of several years, a subset of humanity will be rewired neurologically so that, when the process is complete, their thoughts will be whatever thoughts the Enemy has placed for his own purpose into their re-engineered minds.

Satan’s counterfeit of man

This is the great End Time objective that Satan is pursuing, as set out in chapter 14 of the book of Isaiah. He wants to mimic or counterfeit all that God has done and to undo or eliminate any remaining vestige of His natural order. Thus he dreams of fulfilling his greatest desire – **“I will be like the most High” (Isaiah 14:14)** – by remaking mankind in his own image and inducing this re-engineered ‘creation’ to worship him.

We cannot say for certain why those who take the mark of the beast will forfeit all hope of salvation, but we do know that anyone who goes too far down the road of Satan’s ‘transformation’ will arrive at a point where they are unable to repent. While some may reach that stage sooner than others, the Word of God makes it perfectly clear that ALL who receive the mark will have done so.



The Cabal – the Children of Wickedness – are working day and night to implement their plan. Many who serve the Enemy at the highest levels are so heavily demonized that it is doubtful whether much of their original human personality now remains.

Practitioners of Freemasonry and Kabbalah have been tricked into believing that, by allowing one or more of the fallen angels to connect with their souls, they have obtained a supernatural gift or reward. But nothing could be further from the truth. The Word of God tells what is really happening. After they open a door to one of these entities, perhaps unknowingly through a rite of initiation, the demon they have admitted then prepares them for the next step, which may not take place for several years or even decades:

“When the unclean spirit is gone out of a man, he walketh through dry places, seeking rest, and findeth none. Then he saith, I will return into my house from whence I came out; and when he is come, he findeth it empty, swept, and garnished. Then goeth he, and taketh with himself seven other spirits more wicked than himself, and they enter in and dwell there: and the last state of that man is worse than the first. Even so shall it be also unto this wicked generation.” (Matthew 12:43-45)

The first unclean spirit gains entry and sets up a base of operation. Presumably the individual is still able to go about his normal life, unaware that a harmful entity is clinging onto him. Later, after the entity has grown tired of its habitation, it wanders off “seeking rest” but is unable to find any – because there is no rest for the wicked. So he returns to his human victim and ponders what else he can do to find relief from his empty existence. He goes forth once again, perhaps after several years, and invites seven other unclean spirits to return with him to his victim. It is implied here that, without the assistance of the first unclean spirit, the other seven – who are more wicked than he is – would have been unable to gain entry. Finally, as the Word of God says, **“the last state of that man is worse than the first.”**

We have no reason to believe that the wicked generation to which Jesus refers has somehow disappeared from the earth. Rather, the Word of God warns that the opposite is the case, that **“in the last days perilous times shall come” (2 Timothy 3:1)**. The Apostle went on to compare these demon-infused men of the End Time with the powerful Egyptian magicians who opposed Moses:

“Now as Jannes and Jambres withstood Moses, so do these also resist the truth” (2 Timothy 3:8)

Principalities and Powers

The men and women who are ruling the earth today are controlled by demonic entities, just as the Bible warned. They are subject to “principalities and powers,” the high-ranking demons who use them to carry out Satan’s plan here on earth. As generational Luciferians, their minds and bodies have been conditioned over time to work with the powers of darkness. Thus for the most part they can function normally in the presence of this intense demonic energy. If the same dark entities found their way into the average person, the individual would go crazy, just like the demon-possessed child in Matthew chapter 17. Jesus was referring to the strength or high rank of that demon when he said, **“this kind goeth not out but by prayer and fasting” (Matthew 17:21).**

It is important to understand that the New World Order will be an international empire run exclusively by generational Luciferians.

In my experience, even among Christians who recognize and understand the deadly threat posed by the New World Order, there are a great many who do not grasp this basic fact. The New World Order will be a totalitarian nightmare, a brutal regime managed and directed exclusively by high-ranking servants of Satan. The cruelty and depravity unleashed by these demonized tyrants will far exceed anything seen in recorded history.



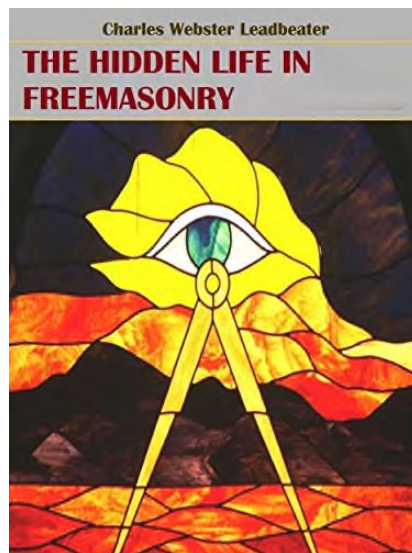
Many of the people who are currently collaborating to impose this brutal regime will occupy senior executive positions in the coming One World Government. This means that some of the monsters who will preside over the End Time terror – as prophesied in the Bible – are already appearing on our television screens and in our newspapers. This fact alone should tell us that current national leaders are capable of endorsing acts of extreme cruelty while appearing, in the eyes of the world, to be little more than greedy, fork-tongued politicians. In short, the evil that is set to manifest fully in the coming years is already here but, until now, has been carefully hidden behind a respectable façade of political, financial and corporate institutions.

Behind the shining white teeth and Gucci suits

In light of this, it is easy to see how the Ruling Elite could plan and execute a worldwide vaccination program which would kill countless millions of people and enslave the rest. This is a prospect which, to educated minds, must surely seem preposterous but which, in the context of Bible prophecy, is a deeply troubling prospect that we dare not ignore.

The Ruling Elite compete among themselves for the most prestigious positions in their exclusive hierarchy. Many advance on the basis of bloodline alone or personal aptitude, but a few are promoted through the rank or status of the supernatural entity that controls them.

For example, as we stated in a previous paper, high-level Freemasons aim to 'attach' themselves to an angelic being in order to advance. In *The Hidden Life in Freemasonry*, C W Leadbeater states, with reference to Masons of the 33rd Degree: "The 33^o gives two such splendid fellow-workers – spirits of gigantic size...splendid beyond all words...most of all they convey a sense of irresistible, though benevolent, power..." Remember, Leadbeater was writing only for Freemasons, so this horrifying secret will never be confirmed openly.



There is nothing unusual about this occult quest for power. Mediums and psychics seek 'spirit guides' to direct them. Witches and wizards invoke similar supernatural entities, while shamans and kahunas will often 'marry' a spirit in a ritualistic manner in order to mark the binding nature of their relationship.

There is nothing "benevolent" about these beings, as Leadbeater would have us believe. Rather they often cultivate an air of 'holiness' and philanthropic candour in order to deceive their human victims and win their trust. For example, Brian Cleeve, a successful writer and a well-known figure in Irish broadcasting in the 1960s underwent a major spiritual change when, around age 56, he began to discern a presence trying to communicate with him. An agnostic at the time, he was taken aback by this intrusion but the entity won his trust. The teachings he received over the following years became the basis for three books which we would classify today as New Age.

Likewise, an Irish civil servant – Paddy McMahon – was approached by two spiritual guides in 1978. McMahon was aged 44 at the time. He placed no confidence in the voices initially but the entities persisted and eventually gained his trust. McMahon agreed to share their ‘wisdom’ with the world and published several books promoting their neo-pagan philosophy.

These men were sincere in their convictions and in their motives, but they were utterly deceived. The entities which approached them were probably quite low in the hierarchy of demons. The Ruling Elite, however, as generational Luciferians, have long sought a strong supernatural connection with demons at the higher levels. This fits perfectly with Satan’s plan because he wants his top lieutenants, the most senior and most supernaturally endowed of the fallen angels, to occupy the highest positions in the echelons of world power. Among these are the “princes” mentioned in chapter 10 of the Book of Daniel.

We are only addressing this unsavory topic to show that the billionaires and political leaders who are scheming together to bring about a ‘New World Order’ are indwelt and directed by these demonic entities. If humans alone had devised this wicked scheme we could hope for the errors and oversights that often accompany a large-scale human enterprise, but this plan has been devised by a formidable and highly experienced non-human intelligence. We dare not treat it lightly or assume that something so ambitious is bound to fall asunder at some point.





Point of no return

We have seen ample evidence over the past two years that the Elite will stop at nothing to achieve their goal. If we look for a date or an event which might qualify as a ‘Rubicon’ moment, then it was probably 19th November 2021 when the Chancellor of Austria, Alexander Schallenberg, announced that all of its citizens must receive the Covid ‘vaccine’ injection by 1 February 2022.

This date happens to be the pagan feast of Imbolg. There are four such feasts in the annual occult calendar, each of which requires human sacrifice. Presumably, as other European countries follow the Austrian example, some of them, we suspect, will select 1st May as their target date. This date is known as *Bealtaine* or Beltane, another of the major feast days in witchcraft.

The countless deaths and adverse reactions caused by the Covid ‘vaccine’ are proof that it is dangerous, and intentionally so. An article published in the medical journal, *Circulation*, on 8 November 2021 should convince even the strongest advocates of the vaccine that it dramatically increases the risk of inflammation in tissue surrounding the heart (*Circulation* is one of the top cardiovascular journals in the world):

Schallenberg is an Austro-Hungarian noble family.

The family hails from [Sankt Ulrich im Mühlkreis](#), where it is known since 1190. *Heinricus de Schalinberc* is mentioned in 1260, adopting the name after the [Schallenberg Castle](#). In 1636 the Schallenbergs were raised to [baronial](#) rank and in 1666 they were raised to [comital](#) rank in the [Habsburg Hereditary Lands](#). The family received the Hungarian [Indigenat](#) and were recognized as nobles of the [Kingdom of Hungary](#) by the [Diet of Hungary](#) in 1688. From 1720 to 1803 [Rosenau castle](#) ^[de] was owned by the family.^{[1][2][3][4][5]}

The Schallenberg family is among the exclusive group of aristocratic families that have ruled Austria for centuries. Illuminati to the core.

Only monsters could do what the Austrian government did when they issued their edict of 19 November. On the most spurious grounds, with no legal authority whatever, they have made it a criminal offense to reject an unproven, experimental genetic serum. We don't often get to see the resident demon manifest in a public figure, but it does happen. The American lawyer Alan Dershowitz – an arrogant Kabbalist and known associate of predatory pedophile Jeffrey Epstein – had the audacity to make the following claim in an interview on 19 May, 2020, and again, in a more nuanced manner, in a debate with Robert Kennedy Jr on 23 July:

“Let me put it very clearly. You have no constitutional right to endanger the public and spread the disease. Even if you disagree you have no right not to be vaccinated. You have no right not to wear a mask. You have no right to open up your business...if you refuse to be vaccinated the state has the power to literally take you to a doctor's office and plunge a needle into your arm.”

On two occasions during the interview, the demon controlling Dershowitz showed itself for a fraction of a second – first at 3.29 and then, more aggressively, at 3.31 (see above). Many who watched this video probably missed these two remarkable flashes of demonic rage. A normal person cannot do what Dershowitz did – form and erase an expression of rage in a fraction of a second – but a demon can.

Other countries are set to follow Austria’s example

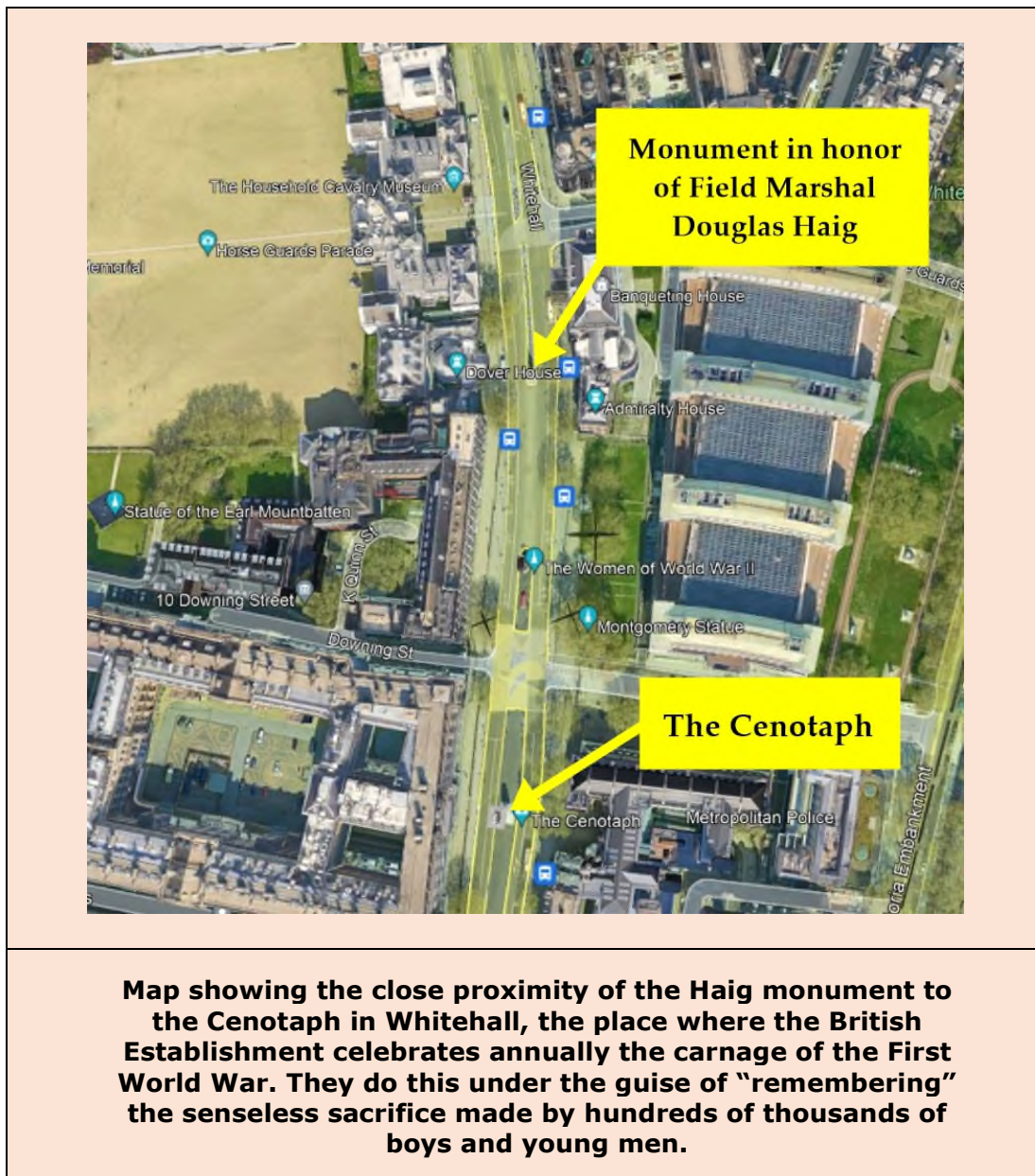
Austria is not alone. The leaders of other countries in Europe, along with those of America, Canada, Australia and New Zealand, are controlled in the same way. They, too, are expected to issue similar decrees in the coming months. As Dershowitz and his demon said: “...if you refuse to be vaccinated the state has the power to literally take you to a doctor’s office and plunge a needle into your arm.”

There is no record of a crime of this magnitude in the annals of recorded history. While the two World Wars were protracted and vicious affairs, involving a staggering loss of life, they mainly engaged the combatants of opposing armies. This wicked inoculation program inaugurates an entirely new form of warfare, where millions of civilians – men, women and children – are attacked in a disguised manner by their own governments. Only time will tell how much harm this demonic attack will inflict – how many will die, how many will suffer terribly from chronic illness induced by this witch’s brew, or how it will affect the autonomy and free will of those who survive.

As Jesus said, we will know them by their fruits. And if their fruit stinks, if it results in the deaths of millions of people, then we must recognize and accept that they are servants of Satan. It is that simple. But society has allowed itself to be duped by these people, to take their phony science, hypocritical humbug and contradictory explanations as plausible ways to justify what they are doing.

Take the case of Field Marshal Douglas Haig who commanded the British forces on the Western Front from late 1915 until the end of the war. He enjoyed a high reputation in his lifetime and his funeral was a day of national mourning. Alas, the Establishment concealed from the public the true character of Field Marshal Haig and, by design, the psychopathic behavior of the leaders who appointed him.

In his book, *British Butchers and Bunglers of World War One* (1988), historian John Laffin speaks of the appalling slaughter of the British troops by their own generals. On p.34 he states:

“The Germans of the XV Reserve Regiment who opposed the 24th Division [at Loos, 1915] could hardly believe that they had such a target. When their regimental diarist came to describe the event he was still verbally breathless:

Ten ranks of extended line could clearly be distinguished, each one estimated at more than a thousand men, and offering such a target as had never been seen before, or even thought possible. Never had the machine-gunners such straight-forward work to do nor done it so effectively...

A German Regimental Diary refers to the 21st Division's sector:

Dense masses of infantry, line after line, came into sight on the ridge, some of their officers even mounted on horseback, and advancing as if carrying out a field-day drill in peacetime. Our artillery and machine-guns riddled their ranks as they came on...whole battalions must have been utterly destroyed. The English made five consecutive attempts to press on...

The commander of a German battalion is reported to have said: “The massacre filled every one of us watching with a sense of disgust and nausea.” The Germans did not fire at the British soldiers who tried to crawl or limp back to their lines...

[Note: Out of a complement of 10,000 men, some 8,200 died in 3½ hours. The Germans lost so few that they didn't record the number.]

Later he reflected on the bloody mindset of these military leaders:

A lot of incompetent generals were 'bad' in a passive sense; that is, they allowed their opponents to dictate the course of warfare. The bunglers among the British and French were actively and wilfully bad; they threw lives away almost as if they had a mission to reduce the national population. Their bungling was callous and culpable and led to butchery... [p.153]

It is suggested that there has been a conspiracy to protect Haig's reputation, a conspiracy of senior army officers mostly. Such a conspiracy is believable. Haig's blunders were so great and his casualties so vast that they reflect on the Army's top leadership as a whole...it was difficult for some officers to accept that such an appalling waste of life could be the result of a few military leaders' faults. To accept this would have been tantamount to admitting complicity in the slaughter... [p.155]

For the duration of the war what the men were expected to endure as frontline soldiers was covered up. The generals used no phrase more revealing than 'difficult conditions'. The Church, in the persons of senior chaplains at the war, probably knew the truth but did not attempt to bring it out. They, as members of the Establishment, did not want to criticise it. With few exceptions, the war correspondents did not write revealingly and critically about what they saw. They consorted themselves more effectively than Army censors could have done. [p.179]

We are grateful to historians like John Laffin, an Australian, who ignored the official line and told the truth about World War One. He could see how the Establishment, the Church of England, the British Military, the press and academia all conspired together to cover up the horror of what happened on the Western Front. The same is happening today, where millions of British citizens are being tricked into taking a dangerous 'vaccine' and none of these vaunted institutions are saying a word. We are seeing a repeat of what Laffin said of the British Establishment in 1914-18, "they threw lives away almost as if they had a mission to reduce the national population."

The same Principality is controlling the UK

Why is this? The answer is obvious. The Establishment today, just like the Establishment in 1914-1918, is controlled by a cabal dedicated to Satan and his works. The same dark spirit, similar to the principality described by the prophet Daniel and the Apostle Paul, is running the UK and, in concert with their counterparts elsewhere, the world as a whole.

For those who resist the New World Order, the option initiated in the Northern Territory of Australia will be used. On 21 November the Chief Minister, Michael Gunner, announced that his state would move from a "lockdown" to a "lockout" strategy. Everyone within the state will have to be vaccinated and those who test positive – or who have been in "close contact" with someone who has tested positive – will be confined to supervised quarantine. His announcement reveals that the quarantine they have in mind is a step beyond self-quarantine at home, but indefinite confinement to a camp operated by the state:

“I contacted the Prime Minister last night. We are grateful for the support of about 20 ADF [Australian Defense Force] personnel, as well as army trucks, to assist in the transfer of positive cases and close contacts, and to support the communities.” – Michael Gunner, Chief Minister of the Northern Territory, 21 November 2021

At the time of this announcement there were 38 “close contacts”. Within 24 hours, according to *abc.net.au*, this had risen to 423, This means that up to 500 people in the Northern Territory are being transported involuntarily by the Army to a remote quarantine camp.

The pictures below are taken from a video posted on BrandNewTube on 15 November 2021. They show what appears to be a large quarantine camp near Port of Brisbane in Queensland, Australia. The camp is enclosed by two sturdy wire fences, the outermost of which is electrified.

The Australian authorities do not deny that Covid quarantine facilities are being built in numerous locations across Australia. For example, *The West Australian* reported as follows on 2 November 2021:

“Queensland will forge ahead with its COVID-19 quarantine camp near Toowoomba [which is near Port of Brisbane], despite reports the federal government wants to scale down a facility being built in Brisbane. The state government is building a 1000-bed facility at Wellcamp, while the federal government is building another 1000-bed quarantine camp in Brisbane, like similar camps in Melbourne and Perth.”

Thus these photos reveal, not so much the existence of remote quarantine facilities in Australia, but their similarity to death camps run by the Nazis during the Second World War.

Is this starting to make sense?

We warned of this last year

In several papers published on this website in the first half of 2020 we warned that this was coming. All of those “close contacts” which Mr Gunner described – easily running into hundreds at a time – will be picked up and shipped off to one of these camps. Whether or not these unfortunate people will ever emerge is a matter of conjecture. What do you think?

Take a look at the draconian powers conferred on the UK government under the Coronavirus Act 2020, as set out in our paper, **Medical Martial Law and Forced Vaccinations**, dated 28 March 2020 (overleaf). The legislation is a tyrant’s dream. It offers carte blanche to annihilate – with a veneer of legality – whoever one chooses whenever one chooses, to remove all opposition in one fell swoop, and to chasten and terrorize those who remain. Dissidents will be easy to identify from their web browsing history and other online activities.

A layman's Summary of the Main Provisions of the Coronavirus Act 2020 [UK]

Any person, including children, can be forcibly detained and isolated by the state for any length of time. This can be done without a court order, without legal representation, and without documented medical evidence. [Some may cavil over our interpretation of the length of time involved, but the Emergency Powers are such that the state can detain anyone as often as it deems necessary.]

The state can forcibly test any person, including children, and remove samples of bodily fluid for that purpose.

It is unclear where the state plans to hold detainees, but it could be hundreds of miles from their home and family. There will likely be no visitation rights, no independent supervision of the care provided, no legal inspection of housing conditions or medical treatment, and little or no documented proof that one's continued detention is medically justified.

The state can impose lockdown conditions on the entire population or on such segments of the population as it decides. Public gatherings, no matter how small, can be made illegal and those who violate this rule can be arrested. It will therefore be impossible for any group – such as a civil rights organization – to protest in the street against this draconian piece of legislation or even to organize indoor meetings to discuss its implications.

The surveillance powers of the state are greatly increased. Whether or not the Act allows the police to enter one's home without a court warrant is unclear. Some of the powers granted to the authorities under the Act are so vaguely worded and so general in nature that householders may not be able to refuse entry without violating some provision or other of the Act.

The Act does not appear to provide for forcible vaccination, but it does greatly increase the power of the state to deem a person mentally incapable and to forcibly medicate them. Relatives of detainees may not be aware that this is happening and would appear to have no right legally to intervene or to request an independent medical assessment.

The state has the power to cremate any person who dies while in detention. It will not be possible to request an autopsy where foul play or maltreatment are suspected. The doctor who signs the death certificate does not need to have seen the victim at any time, alive or dead.

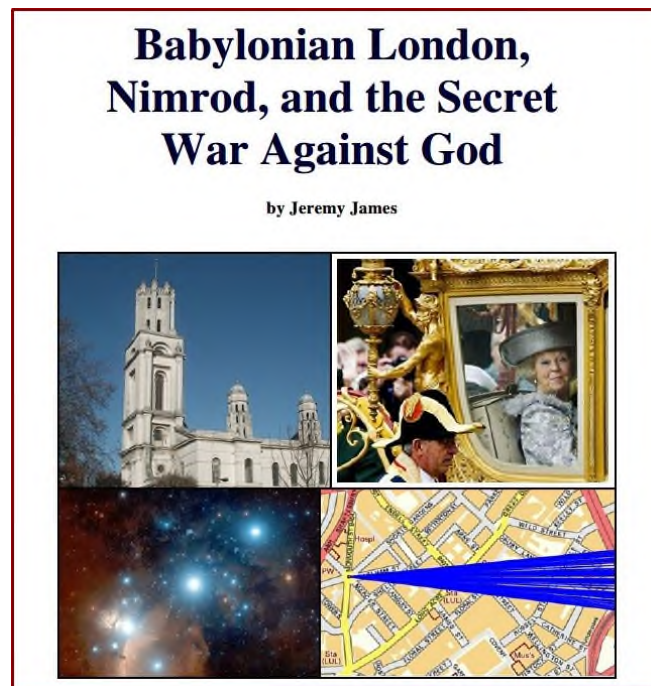
Current provisions in law regarding culpability and duty of care, as they apply to health service workers, are greatly relaxed. In effect, anyone treating, supervising or monitoring a person in detention is indemnified under the Act.

The nerve center

The worldwide plan is directed from London, the modern equivalent of Heliopolis, the Ancient Egyptian city dedicated to celebrating and perfecting the cult of Lucifer (Osiris). Much of the one-world totalitarian philosophy was developed by English writers and academics, men and women who understood the need to disguise what their real intentions were. “And for the rest, those swarms of black, and brown, and dirty-white, and yellow people, who do not come into the new needs of efficiency ? Well, the world is a world, not a charitable institution, and I take it they will have to go. The whole tenor and meaning of the world, as I see it, is that they have to go. So far as they fail to develop sane, vigorous, and distinctive personalities for the great world of the future, it is their portion to die out and disappear.”

- H G Wells, *Anticipations of the Reaction of Mechanical and Scientific Progress Upon Human Life and Thought*, 1902



Charles Darwin, inventor of the Luciferian lie known as ‘Evolution’, is just as frank. If it is to emerge, the great civilization of the future will require that the “savage races” be exterminated:

“At some future period, not very distant as measured by centuries, the civilized races of man will almost certainly exterminate and replace the savage races throughout the world. At the same time the anthropomorphous apes...will no doubt be exterminated. The break between man and his nearest allies will then be wider, for it will intervene between man in a more civilised state, as we may hope, even than the Caucasian, and some ape as low as a baboon, instead of as now between the negro or Australian and the gorilla.”

- **Charles Darwin, *The Descent of Man and Selection in Relation to Sex*, London, (second edition) 1874**

Wells was fully aware of the problems they would face as they imposed their New World Order. The “malcontents” will need to be removed:

“...when the struggle seems to be drifting definitely towards a world social democracy, there may still be very great delays and disappointments before it becomes an efficient and beneficent world system. Countless people...will hate the new world order...and will die protesting against it. When we attempt to evaluate its promise, we have to bear in mind the distress of a generation or so of malcontents, many of them quite gallant and graceful-looking people.” - **H G Wells, *The New World Order* (1939)**

What chilling words these are: “Countless people...will die protesting against it.”

These scheming technocrats are now at the stage where their plan can be implemented in full and they intend to press ahead without further delay. They enjoy total worldwide surveillance of all online activity and can easily identify the people who are likely to “protest against it”.

They have made extraordinary advances in artificial intelligence and genetic engineering, technologies which will greatly facilitate the efficient control and subjugation of the masses – namely those who survive the culling process. They have convinced the majority of mankind that vaccines are a safe and essential means of combatting every kind of disease. 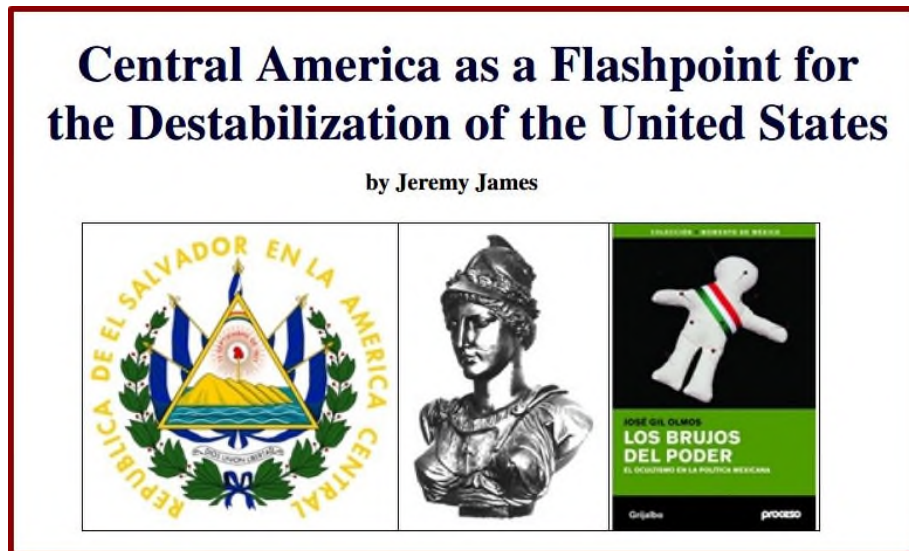

The excerpts given above show just how well the commercial is made and how cunningly it is crafted. Praise his holy name!



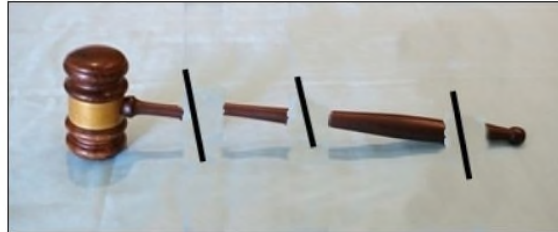

Abstract 10712: Mrna COVID Vaccines Dramatically Increase Endothelial Inflammatory Markers and ACS Risk as Measured by the PULS Cardiac Test: a Warning**Steven R Gundry**Originally published 8 Nov 2021 *Circulation*. 2021;144:A10712**Abstract**

Our group has been using the PLUS Cardiac Test (GD Biosciences, Inc, Irvine, CA) a clinically validated measurement of multiple protein biomarkers which generates a score predicting the 5 yr risk (percentage chance) of a new Acute Coronary Syndrome (ACS). The score is based on changes from the norm of multiple protein biomarkers including IL-16, a proinflammatory cytokine, soluble Fas, an inducer of apoptosis, and Hepatocyte Growth Factor (HGF) which serves as a marker for chemotaxis of T-cells into epithelium and cardiac tissue, among other markers. Elevation above the norm increases the PULS score, while decreases below the norm lowers the PULS score. The score has been measured every 3-6 months in our patient population for 8 years. Recently, with the advent of the mRNA COVID 19 vaccines (vac) by Moderna and Pfizer, dramatic changes in the PULS score became apparent in most patients. This report summarizes those results. A total of 566 pts, aged 28 to 97, M:F ratio 1:1 seen in a preventive cardiology practice had a new PULS test drawn from 2 to 10 weeks following the 2nd COVID shot and was compared to the previous PULS score drawn 3 to 5 months previously pre-shot. Baseline IL-16 increased from 35 \pm 20 above the norm to 82 \pm 75 above the norm post-vac; sFas increased from 22 \pm 15 above the norm to 46 \pm 24 above the norm post-vac; HGF increased from 42 \pm 12 above the norm to 86 \pm 31 above the norm post-vac. These changes resulted in an increase of the PULS score from 11% 5 yr ACS risk to 25% 5 yr ACS risk. At the time of this report, these changes persist for at least 2.5 months post second dose of vac. We conclude that the mRNA vacs dramatically increase inflammation on the endothelium and T cell infiltration of cardiac muscle and may account for the observations of increased thrombosis, cardiomyopathy, and other vascular events following vaccination.
