
$E=mc^2$?

The Enemy uses fear to paralyze his victims. As Christians we must reject fear, walking at all times in the sure knowledge that God is sovereign, the unassailable Rock on which we stand:

"There is no fear in love; but perfect love casteth out fear: because fear hath torment. He that feareth is not made perfect in love." (1 John 4:18)

It may not be easy at times to establish ourselves in that state of "perfect love", but it can be done. We may not be able to do it in our own strength, but we have only to lean on the Lord and trust him to give us the strength we need:

"I can do all things through Christ which strengtheneth me." (Philippians 4:13)

As the Apostle John says, "fear hath torment". It causes discomfort, if not pain. As such it is a poison in our soul, holding us back from untroubled, righteous conduct. When we succumb to fear, we lose the harmony and sense of well-being that enables us to hear what the Holy Spirit is telling us.

This is expressed most vividly towards the end of the Book of Revelation:

"But the fearful, and unbelieving, and the abominable, and murderers, and whoremongers, and sorcerers, and idolaters, and all liars, shall have their part in the lake which burneth with fire and brimstone: which is the second death." (Revelation 21:8)

Those who are ruled by fear are still under condemnation. Spiritually their standing before God is no different from that of murderers, sorcerers, liars and idolators. We can see from this that the fearful are under condemnation because they are <u>faithless</u>. They have no trust in God and never came to faith in Christ.

Fear is a spiritual poison

The Enemy promotes fear in all his endeavors, luring his victims as far as he can from the love and peace that we find only in Christ. The 'big' fears are generally easy to spot and avoid, but the low-level sub-clinical kind can eat away at our peace of mind, generating tiny anxieties that lodge like particles of sand in the gears of our mind, slowing us down and feeding off our energy.



Are monsters lurking under the bed?

A society that lives continually in the shadow of a threat that never abates will adapt to that threat by pushing it to the fringe of conscious awareness. Its members know that the threat continues to exist, but it is stored protectively behind a wall of collective amnesia. The more a society resorts to mental devices of this kind to maintain its equilibrium, the easier it is to manipulate and control.

The Roman Catholic church ran the Inquisition for centuries – picking off victims here and there and disposing of them with great cruelty – for this very purpose. The numbers never needed to be large. The mere knowledge that an innocent person could be picked up at any time, imprisoned, interrogated and possibly tortured, had the desired effect. A society that was intimidated in this way, held in check continually by laws that were both vague and arbitrary, would never muster the courage to challenge its oppressors. Occasionally a doughty individual might emerge but these instances were few and attracted little popular support.

Fears old and new

We like to think that this form of social control is now obsolete, that our modern world is much too savvy and well-informed to succumb to such measures, but this is far from being the case! The powers-that-be continue to foster and augment the old societal fears, while at the same time inventing new ones based on bogus science and false evidence. Some of the latter threats are outrageous — asteroid impacts, raging contagious pandemics, massive solar flares, runaway global warming, and mutually assured destruction from a nuclear war — but, as fear-generators, they undoubtedly influence human behavior.

The Covid hoax was a graphic example of the way rational people can be manipulated by threats that draw heavily on urgent but unsubstantiated claims by persons in authority. When senior politicians, esteemed scientists, and the mass media work together to fabricate a fear that will paralyze most of society, they have a fair chance of success.

In light of the many threats in recent months by Vladimir Putin, president of Russia, to use nuclear weapons if attacked by NATO forces – a fear-generator of the highest order – we wondered how much predictive programming has already been used to drive this fear deep into the subconscious of Western minds and elicit a submissive form of mass behavior.





On 14 March Putin warned that, if the US sent troops into the Ukraine, Russia was ready for nuclear war.



Post-apocalyptic programming

We did a search for "post-apocalyptic movies", namely movies that explored the impact on Western society of a large-scale nuclear war, where all of our standard amenities and utilities had been destroyed or rendered useless, and starvation and disease were rampant. The number of movies in the category 'dystopian/post-apocalyptic' is phenomenal. Some are based on survival in a world destroyed by a nuclear war, while others deal with an equally traumatized environment but do not specify exactly how it came about. In practice it does not matter too much. Take the movie *I Am Legend* (2007) for example. The collapse was caused by a deadly, highly contagious pathogen, but the challenges faced by the survivors were very similar to those obtaining in a post-nuclear-war environment.








Hollywood and other major studios have been producing these movies on an epic scale and many of them were very successful at the box-office. It would be fair to say that 95 percent of the population of the earth has seen several of these movies and have thousands of images stored in the depths of their subconscious which depict a post-apocalyptic, dystopian nightmare. These images would not otherwise have entered the minds of these people. They are too bizarre and far removed from anything we are familiar with in our daily lives. What is more, they are absorbed and predicated on the belief that the world they depict is a real possibility, albeit one we would never expect to experience.








This is old-fashioned propaganda and mental conditioning, where the masses are taught to fear – and visualize in strong emotional terms – a possible future war-like event. In the process they are being trained to accept as valid the many assumptions on which such an outcome is based. These include a belief that explosive nuclear devices exist and that the radiation they allegedly produce can spread over an extremely wide geographical area and contaminate the earth and the atmosphere. In recent years they have added a new assumption, namely that such devices release at the moment they explode a massive electronic pulse that can burn and disable microchips and other microelectronic devices on which modern society depends.


Are these assumptions valid? Few people bother to ask themselves that question. They simply take what they are being told as a scientific fact and that the scenario they are watching is a real, albeit remote, possibility. The movies, in effect, are a series of documentaries designed to 'educate' the public and make them receptive to whatever narrative the government may choose to peddle in a future conflict between nations.


Explosive nuclear devices do not exist

As we have shown in previous papers, explosive nuclear devices do not exist. For readers who wish to examine the basis for this assertion, we refer them to the following papers: #76, #96, #118 and #152:










Rather than repeat the arguments given in previous papers, we will pick just one piece of evidence which shows that the entire "chain reaction" theory, on which the nuclear threat is based, is completely bogus.

The following chart explains what is really happening when a supposed *chain reaction* occurs. The scientists would have us believe that the process continues indefinitely, turning a lump of radioactive material into a staggering quantity of pure energy or, as they like to call it, a nuclear explosion. This is nonsense. Each step in the reaction merely produces a different isotope and heat. That's it. If left to run, the heat will continue to build up until the radioactive material melts – as it did at Chernobyl in 1986 and Fukashima in 2011.

Nuclear Chain Reaction



A chain reaction is a reaction in which the material that starts the reaction is also one of the products and can start another reaction.

A critical mass is the minimum amount of nuclides that provide the number of neutrons needed to maintain a chain reaction

A nuclear chain reaction is pure fantasy. Each neutron ejected at high speed simply knocks a neutron out of a nearby nucleus, producing an isotope and heat. This is what happens in a nuclear power station. A "runaway" or uncontrolled chain reaction would simply melt the uranium metal, as happened at Fukushima, Japan in March, 2011.

In an earlier paper – How to Distinguish Biblical Reality from Satan's Alternative Reality, #96) – we stated:

The world was told that such a device was detonated successfully at a remote test site in New Mexico and later deployed on two occasions in Japan. However there is no credible evidence to support this. Hiroshima and Nagasaki were apparently firebombed, just like seventy other Japanese cities. Neither city was polluted by nuclear radiation and neither city suffered damage consistent with a nuclear blast. The Allies spun the atomic bomb story in order to lay the foundation for a prolonged Cold War between the USA and the USSR.

Without the threat of mutual annihilation, there would have been no Cold War. Moreover, the United Nations – the prototype for world government – would never have been formed without the threat of an all-out nuclear war and the continental devastation that it would cause.

There were other reasons for the atomic bomb hoax. It ensured that the highly profitable arms industry would continue to prosper and enrich the scheming cabal of families that controlled the military-industrial complex. The influence exercised by this cabal would swell enormously during the Cold War and allow them to steer the United Nations toward world government.

The phony end-of-the-world formula

The formula that allegedly expresses the relationship between matter and pure energy is $E=mc^2$, where E means 'pure energy', m means 'mass' and 'c' symbolizes the speed of light (which we are told is 186,000 miles per second).

This formula is world famous. It is quoted extensively in popular culture and its author, Albert Einstein, is fêted universally as one of the greatest scientists who ever lived. We did a check on ChatGPT (the online AI utility) to see how often the formula was used in the TV cartoon series, *The Simpsons*. Here is an extract from its reply:

The equation "E=mc²" is referenced in the television cartoon series "The Simpsons" on several occasions throughout its long run... While it's difficult to provide an exact frequency of its appearance, "E=mc²" has been referenced in various contexts within the show, particularly in episodes involving science, technology, or education-related themes. These references may range from scientific discussions to comedic situations, making it a recurring motif throughout the series.

Just think about this for a moment. The scientific equation that expresses the staggeringly complex process whereby matter is transformed into pure energy is so simple that it can be cited over and over on a children's cartoon show!



The show frequently refers to the dangers posed by a nuclear reactor.

It even suggests that a disaster is inevitable because the Springfield reactor is sometimes manned by people like Homer Simpson. How is this possible? After all, most scientific formulae relating to chemical, mechanical and engineering processes, even the simple ones, are much more complicated than that. The fact that they are never cited in popular culture is testimony to this. Economists often complain that the best way to cut the readership of a serious paper by 90 percent is to include just one equation!

An advertising slogan

In our opinion, the famous equation $E=mc^2$ is nothing but propaganda, an advertising slogan for public consumption. It's as bogus as a bagel without a hole. If Einstein deserves to be ranked among the greatest of all time, it's in the category of shameless conmen.

The giveaway here is the speed of light. To appreciate the argument that we are about to make it is important to note that the unit of measurement known as the meter is an <u>arbitrary</u> construct. *Encyclopedia Britannica* explains how it originated:

"The metre was historically defined by the French Academy of Sciences in 1791 as ¹/10,000,000 of the quadrant of the Earth's circumference running from the North Pole through Paris to the equator."

In short, if the distance between the North Pole and the Equator is divided into 10 million equal segments, each segment will be exactly one meter in length.

We will continue our story with an edited extract from our earlier paper, #96, where we discussed the speed of light.

When the speed of light was measured experimentally it was found to be exactly 300 million meters per second! (Note that the meter itself had been defined several decades <u>before</u> this experiment was conducted.) Now ask yourself, what are the chances that the speed of light should turn out to be exactly 300 million times an arbitrarily defined unit of length? And why should that the unit of length be directly related to the path of the sun over the Equator? Or why should the distance that light can travel in one second be <u>exactly 30 times</u> the distance between the North Pole and the Equator? [According to Google Earth, the actual distance between the North Pole the Equator is exactly 10 million meters (plus or minus 100 metres).]

Scientists in America, who used the imperial rather than the metric system of measurement, were familiar with the speed of light <u>in miles only</u>, namely 186,000 miles per second. As more of them noticed that the speed of light under the metric system was a suspiciously round number, they probably began to ask some awkward questions.


As a result the speed of light has since been officially <u>reduced</u> to a less suspicious (and less Masonic) 299,792 kilometers per second.

The scientific establishment is also trying to hide the embarrassing fact that the length of the unit known as the meter is purely arbitrary by redefining it by reference to a universal constant. And what constant did they choose? The speed of light! The SI definition of the meter in 1983 reads: "The meter is the length of the path travelled by light in vacuum during a time interval of 1/299792458 of a second."


Had the French Academy of Sciences used this format in 1791 it would have read "The meter is the length of the path travelled by light in vacuum during a time interval of 1/30000000 of a second."

The 'speed' of light and the Great Pyramid of Giza

Oddly enough, the number they chose (299792458) happens to be the same as the longitudinal coordinates of the Great Pyramid of Giza – which lies at 29.9792458 degrees north. (Readers who doubt this are invited to check it for themselves on Google Earth.) The number pertains, not just to its base location, but to its exact center. Apparently, having been forced to move away from their chosen magical number, the Cabal chose a replacement number for the speed of light that denoted the exact N-S location of their most important magical structure, the Great Pyramid at Giza. Freemasons and practitioners of Kabbalah always seek out numbers which, in their occult philosophy, are deemed to possess the greatest magical potency.

The assumption that light acted instantaneously

At the time that the French Academy of Sciences defined the unit of length known as the meter it had been assumed (but not proven) that light acted instantaneously. In other words, it had no speed.

However, in order that Satan's alternative system of Physics could get a grip on mankind, this assumption would have to go. If light had no 'speed' or velocity, then it would not be possible to measure the size of the universe. This in turn would make it difficult if not impossible to propose a daring new cosmology — a profoundly anti-Biblical model of Creation — in which the earth was nothing but an insignificant speck in the vast emptiness of 'outer space'.

Most scientists today accept without question the proposition that light has a finite, constant, universal 'speed' and that this has been accurately measured. They see no reason to doubt a "scientific fact" which has seemingly been confirmed thousands of times through astronomical observations of deep space and distant stars. However, they are not aware that the way the so-called 'speed' of light has been measured is fatally flawed.

There are two main methods. The first assumes that the cosmological model of 'outer space' is actually correct. The relevant measurements of c (the speed of light) are based on the supposed orbit of the earth relative to distant celestial objects, such as the moons of Jupiter. However, since the distance of such objects from the earth has already been calculated by reference to the speed of light and uses a cosmology that already makes a number of assumptions about the speed of light, the reasoning employed is clearly circular.

Spinning mirrors

The other principal method of measuring the speed of light is known as the *time of flight* method. Possibly the best known experiment using this method was the one conducted by a team of scientists led by Nobel laureate, A A Michelson, in 1931-33 in Irvine, California. They constructed a corrugated vacuum tube a mile long and 3 feet in diameter and projected a light beam back and forth between a series of mirrors along its length. The measuring apparatus comprised a revolving wheel covered with finely engineered mirrors. The wheel revolved at 512 revolutions per second.

After the beam had bounced back and forth along the tube, covering a known distance, it 'arrived' again at the revolving wheel. During this miniscule time interval, the wheel had rotated a very small distance, causing the beam to be deflected very slightly from its path. Michelson claimed to be able to calculate the speed of light by reference to the angle of deflection, the speed of rotation of the wheel, and the distance the beam had travelled.




Chart produced by Michelson's team to illustrate their experiment.

This was a very crude experiment, with ample scope for error. Michelson himself was an unstable man and in poor health at the time – he was 79 – and yet we are expected to base our understanding of the universe on his system of spinning mirrors.

There are two further methods of measuring the speed of light. The first is cavity resonance, which measures the frequency and wavelength of an electromagnetic standing wave in a vacuum, while the second computes the interference pattern (and thereby the speed of light) by splitting and recombining a beam of laser light. These are technically more precise than the method used by Michelson but they are based on a paradigm that already assumes the speed of light is finite and that it lies within certain parameters.

We must keep the big picture in mind

I would stress that I am speaking only as a layman, but the points I am raising have been raised by others. Once the leading institutions of modern science decided that the speed of light should equal exactly 300 million meters a second, the die was cast. Thereafter they had no choice but to justify what they had done by conducting unconvincing experiments (like those of Michelson) and devising explanations that relied on circular reasoning.

To understand what was really going on we need to keep the big picture clearly in mind. The enemies of the Bible wanted to find a way of undermining the orderly, purposeful structure of the universe described by our Creator in the Book of Genesis. This meant defining a universe in which distances were vastly exaggerated (by a hundred billion billion). It also required a means of expressing and manipulating these extreme distances in consistent mathematical terms. By assigning a finite, constant speed to light, they had both a yardstick for expressing their measurements and, by using optical and radio telescopes, a way of making them seem credible.


Once the universe was arbitrarily enlarged in this way, there was no limit to how big it could be made to appear. Tiny points of light could be interpreted as galaxies many light years across. A radio pulse that was almost imperceptible could be transformed into a black hole so large it could swallow our entire galaxy. Once they had found a bridge between the real world and the world of 'mathematics' (imagination), there was virtually no limit to the size and variety of the celestial objects that they could postulate. Science fiction took over from real science and the Great Cosmological Lie was born.



Many reputable scientists dismissed the new physics as bogus, a meaningless addition to Newtonian Mechanics which only served to suppress the need for experimental proof. Nikola Tesla put it like this:

"Today's scientists have substituted mathematics for experiments, and they wander off through equation after equation, and eventually build a structure which has no relation to reality."

Why light acts instantaneously

There is a very simple way to understand how light is instantaneous. Imagine a narrow lightweight rod which is made of aluminum and fifty feet in length. It is laid out on a tennis court. Person A, at one end, pushes the rod forward by 2 inches. Person B observes the movement of the rod at the other end. It too moves forward two inches. How much time elapsed between the movement at end A and the movement at end B? Answer: None.

If light had a speed, even 186,000 miles per second, all network operations based on its speed would degrade as the distances between the nodes increased. But modern computer systems never become jammed by the increase in the volume of data sent down a fibre-optic cable. However, if light had a "speed", the ever-increasing volumes of data (especially movie data) would gradually slow down its performance. Engineers never need to worry about this because light is instantaneous.

Gnosticism, Kabbalah and Egyptian Magic

The great dream of the medieval alchemist was to turn – "transform" – base metal into gold. Einstein was engaged in a similar alchemical quest – to transform base matter into light. Both goals are grounded in Gnosticism, Kabbalah and Egyptian magic.

If light is instantaneous, then the formula $E = mc^2$ is sheer nonsense. And if the formula is nonsense, then megaton nuclear bombs do not exist. They too are part of a deadly game to frighten mankind and keep the masses under control.

These fictitious entities also have another purpose. Deadly explosive devices certainly exist, notably the vacuum or hyperbaric bombs that can devastate a wide area, but they lack the terror-inducing potential of a nuclear bomb. The enduring fear of nuclear explosions arises from the so-called cloud of long-lasting highly toxic radiation which this unique ordnance is supposed to produce.

If Putin and his cronies go ahead and detonate some of these in Eastern Europe, the news channels will be ablaze with government warnings of impending catastrophe. A deadly cloud of radiation, they will allege, is drifting across Europe and radical measures must be imposed with great urgency. The word 'lockdown' will be repeated ad nauseum and all normal economic and social activity will come to a halt. Farms will be shut down and livestock destroyed. Water will be rationed and only tinned food will be deemed edible. 

The public is now set to believe whatever scare story they generate and to accept the 'health and safety' measures that are likely to be imposed – lockdowns, travel bans, indoor confinement, mask wearing, work closures, special medication, etc. (Sound familiar?) The news broadcasts may include grisly photos of people disfigured by radiation. (Sound familiar?) And the estimated future death tolls will be terrifying. (Sound familiar?)

Given the public threat by Putin on 14th March, they appear to be gearing up to use explosive nuclear devices — not Chernobyl itself — as the alleged source of radioactive fallout.

Numerology and the Cabal's plan for ordo ab chao


Thus far we have seen how the Elite are immersed in occult philosophy. This theme is found all through their works. Since they believe reality is organized on the basis of the occult principle, *As Above So Below*, they are convinced that they can get the results they want only by following astrological charts and numerological patterns. For them, timing is extremely important. If a planned operation cannot take place on a chosen date, as indicated by astrology and numerology, then another auspicious date must be found. It can't simply be carried out a few days later.

The Word of God draws particular attention to the importance of the number 666 in their occult schemes. We can use this insight to speculate as to how they have designed their current plan to achieve "order out of chaos" (*ordo ab chao*). We can be fairly certain about the date this plan began since they like to inaugurate a new cycle with a dramatic symbolic event. In our modern era, we know this event as 9/11. It set in motion a whole series of pre-planned activities which were intended to undermine the existing order. This cycle is still ongoing and is very likely to end with a cataclysmic event that will be just as dramatic, if not more so, than that of 9/11.

If we take 666 as our guide and begin with 9/11, we might be able to hazard a guess as to what this terminal event might be. We are assisted in this task by a short video which the Cabal released in 2012 called *I Pet Goat 2* (We cited this video in a recent paper, #380). The video appears to set out the Illuminati plan to bring in the Antichrist. It was possibly made public in accordance with the occult belief that the magic supporting a planned operation is increased if the victim is told of his fate in advance. Having said that, the video is full of symbolism which most members of the public would not understand.

The early part of the video includes a turbulent sequence depicting the collapse of two massive towers. Commentators online have tended to link this scene to 9/11, but they are only partly right in our opinion. The two towers in the video are almost certainly the Dome on the Rock and the Al-Aqsa Mosque on the Temple Mount in Jerusalem. If so, then the great cycle that began on 9/11 – which saw the destruction of two "monumental structures" – will end with a mirror event, where two other "monumental structures" will be completely destroyed.

The next 3 pages explain why we believe our conjecture cannot easily be dismissed. We are making it public in accordance with the Biblical injunctions to reprove the unfruitful works of darkness (Ephesians 5:11) and to watch for signs and events that align with End Time prophecy (Mark 13:37). 

I don't know whether the G7 will have anything to do with it, or whether it will be the G20. I certainly hope that the IMF will have something to do with it.

So 7/7 is a very important magical number for these people. By alluding to a prophecy in Genesis (Joseph's interpretation of Pharaoh's dream), Ms Lagarde implied that what she was saying was 'prophetic'.

Our Lord told us that, when we see these things begin to come to pass, we should lift up our heads because our redemption draweth nigh:


"And when these things begin to come to pass, then look up, and lift up your heads; for your redemption draweth nigh." (Luke 21:28)
