# Our Governments are Lying: Face Masks cause Real Long-Term Harm to Our Children

We are living in dangerous times. The dangers we face are greatly amplified by the extraordinary inability of the vast majority of the general population to recognize them. Perhaps the most disturbing failure of all is the degree to which parents are content to allow the medical profession, and in particular the pharmaceutical industry, to make decisions affecting their children which have irreversible, long-term consequences.

Of necessity we must trust professionals in relation to matters where we have no special expertise. <u>But we have a duty of care to our children</u>. To the extent that we are able it is incumbent on us to examine the claims made by the medical profession and the pharmaceutical industry as they pertain to our children. A straightforward, commonsense evaluation of the evidence in relation to these claims should enable us to see whether they might be over-stated, untrustworthy, or deliberately misleading.

Every parent should do this, but few seem to bother. This may have been an understandable attitude 50 years ago, but today it is simply irresponsible. The power of the pharmaceutical industry is far greater than it was 50 years ago, and its potential impact on the health and well-being of our children is also far greater. Mistakes in the manufacturing and testing of their products can potentially harm millions of children.

Where standards of accountability should be higher than in any other industry, they are actually <u>lower</u> because the industry has secured a legal exemption from all liability for harm caused by their vaccines. Furthermore, the regulatory framework for the industry, which ought to be staffed by independent personnel, is wholly controlled by persons with close ties to the industry. Experience over the past thirty years or more has shown, time and again, that the political system is easily manipulated by the huge financial inducements that the industry routinely uses to get its own way.

## Your children are in YOUR care

Our children are the most wonderful, most precious gifts we will ever receive! We should be watching over them with the same ferocity and zeal as a mother bear protecting her cubs. Alas, far too many have fallen for the lie that our government "cares" for our children and will do all in its power to protect them. This is nonsense, of course, but a lie is a powerful tool of indoctrination if it is repeated over and over again. Successive governments, as well as the mainstream media, have broadcast this lie for so long that few parents realize that their child, from a political perspective, is merely a statistic.

No Irish politician has ever been held accountable for the harm caused to hundreds (and possibly thousands) of children by vaccines. Even when compensatory awards are made by the courts, the question of liability is always left open.

How many politicians, wielding power today, will be held accountable in future years for the harm caused to our children by the mandatory requirement to wear a face mask in school? As students, they are obliged to sit in class for hours every day with a piece of cloth strapped over their nose and mouth:

"It is now recommended that teachers and secondary school students wear face coverings, similar to those worn in shops or on public transport, when a physical distance of 2 metres cannot be maintained." – update of 7 August to the document *Reopening Our Schools: The Roadmap for the Full Return to School*, published on the Department of Education website.



Even though this requirement is stated in the form of a recommendation, it is being interpreted by school boards as a mandatory requirement lest the school be held liable for Covid-related illnesses among staff or students.

## The Silent Coup

Virtually all information about masks in the mainstream media is propaganda. *The Irish Times* is lying. *The Irish Independent* is lying. RTE, the national brodcaster, is lying. The government is lying. The Department of Health is lying. The Health Service Executive is lying. The lies are so obvious that everyone ought to be able to see them, but they don't. Why? Because in order to see these gross fabrications, one must accept that the people who are running our country are imposters and that, in a sense, a silent coup has taken place.

This is too hard for most of our citizens to accept. They would rather submit like children to a grievous violation of their bodily integrity than face up to the fact – the painful, almost unthinkable fact – that their country has been taken over by a foreign power. They would have to accept that the men and women whom they voted into office have deceived them and that when they claim to serve the nation as a whole they are lying through their teeth.



No-one likes to be deceived. It hurts our pride and our self-esteem. So when a nation of 5 million people are totally duped by a scheming cabal, very few of those 5 million are willing to swallow their pride and admit that the unthinkable has happened.

It didn't occur overnight, but stealthily, over several decades. Bit by bit the Communists took control of the media, the political parties, the religious institutions, the educational system, the health service, and so forth. The top strategists in the Soviet Union boasted in the 1960s that this was their plan. The program itself was financed by the same people who own and control the international banking system. Instead of attacking western nations with physical force, picking them off one by one, they chose instead to infiltrate their principal institutions and bring them all down at the same time. This is what we see happening today.

This slow, incremental approach may seem unnecessarily tedious. After all, it takes sixty years or so to get results. But it is far superior to the traditional system of invasion. Firstly, success is assured since the target nation will not recognize that it is under attack, even as its key institutions begin to collapse. Secondly, the collapse can be timed so that several countries – perhaps a very large number! – can be brought down simultaneously <u>using the same crisis</u>. Some countries will be "ready" before others, but their demise can be delayed until the complete set is lined up. Ireland, for example, could have been taken down in 2009, and Greece in 2011, but both were allowed to retain their independent democratic façade until certain other countries were "ready," notably the US and the UK.



The fuse was lit in early 2020 via the great hoax we know as the Covid-19 pandemic. Even if an unpleasant flu-type virus was causing the short spike in mortality which occurred in some countries in March/April, the official response – with virtually every western country marching in step – was plainly insane. Their respective economies were certain to suffer considerable damage and any expectation that a 'lockdown' might save some lives was erased by the certain loss of life that would result from the sudden contraction in medical services and the toll exacted by social isolation.

## **Governments in lockstep**

The government in every western country was following the New World Order agenda. They did this, not because they were compelled to do so, but because, ideologically, they were recruited to serve this agenda long before they took office. In short, they are voluntarily following the program laid down by the international bankers.

Are we speaking about treason? Of course! But the perpetrators do not see it in those terms. Somehow they have convinced themselves that, if the world is to advance safely into its next stage of 'evolution', then it must replace the existing system of independent sovereign states with an all-powerful world government. And since 99 people out of a 100 would never accept such a system, it must be imposed by force.

They are using phony science and corrupt economics to bring this about. The existing system of fiat currencies and fractional reserve banking is designed to fail. When it does, a huge proportion of the wealth not already in their hands will pass into the control of the Ruling Elite. Other crises are also being manufactured through phony science to reinforce the public perception that 'global' problems require 'global' solutions and that these in turn will need a 'global' government to make them work.

## Schoolchildren forced to wear masks

What has this to do with the requirement that teenage schoolchildren wear masks in class? Everything! It is a watershed moment in this entire program of social control. If rational, well-educated, well-informed western parents – who undoubtedly love their kids – are willing to submit them to this patent abuse, then the battle is lost.



The Ruling Elite must be delighted. They can turn the screw as tightly as they want and their victims say nothing! It wasn't enough to teach little boys that they might really be little girls, or that they might be repressed homosexuals, or that they ought to be watching porn or indulging in promiscuous sex. No, let's go further and make them wear masks like Muslim women, and force them to stay at least six feet away from the opposite sex.

If a lone piece in this perverted puzzle makes no sense, a clear picture emerges when we put the pieces together. Our children are being harmed psychologically by a carefully crafted set of beliefs and practices which impede their normal development. The boys are being feminized, while the girls are being sexualized prematurely and made to believe their bodies are commodities which they must learn to exploit.

It is not hard to see how well this fits into the Marxist plan to weaken and 'transform' western society.

## The Cult

## A professional assesses the harm caused by face masks

The text below is a translation culled from two sources. We had intended to give a shorter version but she makes so many points of substance, and argues her case so persuasively, that we feel our readers would welcome the longer version:

My name is Margareta Griesz-Brisson. I am a neurologist with a practice in Mülheim in Germany and a neurological practice in London. I follow the events in Germany and around the world with growing concern. Corona has turned out to be a moderate flu and the measures [to combat it are] an absolute catastrophe on every level...

We can strengthen our immune system through good food, good water, lots of exercise, socializing, joy, friends, love and plenty of fresh air. Do you notice anything? This is exactly what the government forbids us. And what it recommends in return is hand sanitizer, spacing, and mouth-and-nose covering...

Regarding mouth and nose covering: Humans can live without food for weeks, without water for days, but only for just minutes without oxygen and without breathing. Re-breathing or re-inhaling our exhaled air inevitably results in a lack of oxygen and a deluge of carbon dioxide. However, we know that the human brain is very sensitive to oxygen starvation. There are nerve cells, for example in the hippocampus, that cannot survive for more than three minutes without oxygen. The acute warning symptoms for oxygen deprivation are headache, somnolence, dizziness, difficulty concentrating, delayed reaction times, i.e. limitations in cognitive functioning. However, with chronic oxygen deficiency, these symptoms disappear, you get used to them, [but] your performance capacity remains reduced and the oxygen deficiency in your brain continues to increase.

We know that neurodegenerative diseases take years to decades to develop, so if you forget your phone number today, the malfunction in your brain started 20 or 30 years ago. While you think you've gotten used to your mask and the air you exhale, the degenerative processes in your brain continue to work regardless of the lack of oxygen.

The second problem of the brain is that the nerve cells do not or hardly divide, which means that if the government allowed us to breathe generously again within a few months, the lost nerve cells cannot be restored through cell healing. What's gone is gone.

This is especially important for anxious people who really believe that this mask can protect themselves from the virus. The virus is about 0.08 micrometers in size. The pores of the common masks are 80 to 500 micrometers in size and get bigger with each wash and each subsequent wash. A general mask does not protect against a virus in any way. I don't wear a mask, I need my brain to think. I want to meet my patients with a clear head and a clear mind, not under carbon dioxide anesthesia...

As a neurologist, I must explicitly say that anyone who wishes to do so is entitled to medical exemption from the mask. There is no baseless, false or discourteous statement. Oxygen deficiency damages every brain. It must be the free decision of each person whether they will accept the lack of oxygen in their brains to protect themselves from viruses with an ineffective mask.

Masks are an absolute no-no for children and young people. Children and adolescents naturally have a very active and adaptive immune system and must constantly interact with the earth's microbiome. Your brain is just as insanely active. There is so much to learn. The brain of a child or teen is hungry for oxygen. The more metabolically active an organ is, the more oxygen it needs. In children and adolescents, every organ is metabolically active. Depriving or even limiting oxygen from a child or adolescent's brain is not only dangerous to health, <u>it is also absolutely criminal</u>. Oxygen deprivation inhibits brain development and <u>the damage it causes</u> <u>cannot be reversed</u>. The child needs the brain to learn, and the brain needs oxygen to function. We do not need a clinical study for this – it is simple but indisputable physiology.

Knowingly and intentionally caused oxygen deficiency is an intentional, deliberate health hazard and an absolute medical contraindication. An absolute contraindication in medicine means that this drug, this method, this therapy, or this measure should not be used. To impose an absolute medical contraindication across the board as a coercive measure for the entire population requires clear and serious reasons. These must be checked by the responsible interdisciplinary and independent bodies and authorities and approved unanimously.

If dementia grows exponentially in the nexten years and the younger generation has not been able to reach their God-given potential, it doesn't help to say we didn't need the masks...Please dear colleagues, we all need to wake up. I know how bad oxygen deprivation is for the brain, the cardiologist knows about the heart, the pulmonologist knows about the lungs. <u>A lack of oxygen damages every organ</u>.

...Why do the medical associations intervene to punish doctors who issue medical certificates for their patients? Does the person or physician have to prove that oxygen deprivation is harmful to the person or his patient? What kind of medicine do our medical associations represent? The initial lack of evidence for the effectiveness of these measures has now turned out to be clear evidence of ineffectiveness – and yet the madness continues!

<u>Who is responsible for this crime</u>? Those who want to enforce measures, or those who make it happen, who agree, or who fail to prevent them? Wake up Germany. It's not about masks, it's not about viruses, and it's certainly not about your health. It is about much, much more.

## Our politicians are lying

Please bear in mind that this German neurologist is infinitely more qualified than any politician to expound on this subject! She is rightly accusing the politicians of a crime. She states what we all know to be perfectly true, that wearing a face mask impedes our inhalation of oxygen and our exhalation of carbon dioxide. To do so for hours on end is harmful! What is more, it does absolutely nothing to reduce the risk of either contracting or spreading a virus!

Our politicians are LYING. What is worse, their lies are doing REAL HARM to our children.

Make no mistake – these are lies with a purpose. They are not a product of disordered thinking but a deliberate plan to subdue the population. The WHO swine flu 'pandemic' of 2009 was a complete hoax. In fact it was such an obvious hoax that the Parliamentary Assembly of the Council of Europe held an emergency debate on it in early 2010. They could see that the pharmaceutical industry was running the whole show. The WHO had no interest whatever in health promotion. It's only goal is to generate massive demand worldwide for the phony products sold for huge profits by this venal, avaricious industry.



The hoax pandemic of 2009 was only a dry run. The Elite always knew it might not work. This time they intend to push ahead with the hoax, all the way to the bitter end. And the end they envisage will be bitter indeed, where everyone, without exception, is vaccinated, tagged, tracked, and compliant.

The use of masks was a major innovation. So too was social distancing. The masses were obliged to show in public the marks of their submission. This is not unlike the way the National Socialists in Germany used the Nazi salute and constant repetition in public of the inane chant, *Heil Hitler!*, to bring the masses into line. Everyone was expected to use both the salute and the mantra. Even those who hated to do so felt obliged to conform or risk being ostracized by their neighbors and workmates. They also risked a severe beating from the gangs of Brownshirts who roamed the streets of Germany, sniffing out dissent.

These modes of oppression are being supplemented today, in Ireland at least, by the widespread use of Garda checkpoints on busy roads, causing endless delays, and humiliating their trapped victims who feel obliged to reveal where they are coming from, where they are going, and the purpose of their journey.

This is deliberate. From a medical standpoint it serves no useful purpose, but our Marxist government has directed that the public be further demoralized. Every time a person submits to this form of abuse, his will to resist is depleted. The humiliation is amplified by conducting it in public. What is more, the victim is made subtly complicit in the entire charade by co-operating with the police. In a sense, through his compliance, he is endorsing what they are doing. Thus the oppressed herd, tired and intimidated, is trained to do what it's told.

## **Mass humiliation**

A few days ago the government of Italy ordered all citizens to wear a face mask in public. In effect they are demanding that everyone bear on their face a visible sign of their submission to a national edict that makes no sense. It is nothing other than a Satanic exercise in mass humiliation.



The requirement that Irish schoolchildren at second level wear a mask in class is equally humiliating. Most of them know it serves no purpose. But their will must be broken. They must be taught that "the greater good" overrides their individual autonomy. They are being led across the DMZ into N Korea, where a whole new world of rules and regulations apply. For now, they have only a few rules to obey, but they are being conditioned to accept that the state can introduce many more, and when it does – "for the greater good" – everyone will have to do what they are told.

Mask-wearing is psychologically harmful, especially for a child, whose mind and personality are still developing. If nothing else, a mask diminishes one's personal identity. Burqas and niqabs are used to make the unfortunate Islamic women who wear them subservient and docile. Any parent who thinks their child will not be affected by wearing a mask really needs to look more closely at this sinister subject.

We develop interpersonal skills by spending time with our peers, seeing their faces, discerning their emotions, and being closely involved with them in social situations. It should hardly be necessary to state something so obvious! But, alas, this is where we are today, where parents have been so heavily indoctrinated by government lies and morbid propaganda that they cannot exercise even a modicum of common sense.

## The Irish Marxist regime

## "Be ye not as the horse, or as the mule, which have no understanding: whose mouth must be held in with bit and bridle [*recen*], lest they come near unto thee."

#### (Psalm 32:9)

Isaiah also refers to a bridle in the End Time:

### "And his [i.e. Christ's] breath, as an overflowing stream, shall reach to the midst of the neck, to sift the nations with the sieve of vanity: and there shall be a bridle [recen] in the jaws of the people, causing them to err." (Isaiah 30:28)

We are made in the image and likeness of God. A person lost the right to defile his body when he became a Christian. This applies, not only to fornication, but to tattoos, flesh marks, cross-dressing, and ascetic practices. It applies also to head coverings in church. As the Apostle Paul states, **"For a man indeed ought not to cover his head, forasmuch as he is the image and glory of God:" (1 Corinthians 11:7)**. How much more shameful it is, then, to cover one's face!

It is significiant that the only face covering endorsed by the Word of God pertains to lepers, whose bodily affliction represents the progressive, corrosive power of sin. It shows "the weekly excess deaths (deviation in mortality from the expected level)" for Ireland thus far in 2020. Apart from a small increase in March/April, the graph is perfectly NORMAL.
