

Proof that the C-19 Injections are a Chemical Weapon

It is necessary to review very carefully the material that is continually coming online, purporting to explain what is 'really' happening in the world today. The Enemy has trained and put in place a huge network of 'truth-tellers' whose only purpose is to keep us off balance, confused and looking in the wrong place or in the wrong direction.

Very few people bother to understand what is going on behind the scenes, but the Enemy knows how important it is to keep that small number in check. In recent weeks a number of videos have been appearing online which make a big leap beyond the standard narrative, including the narrative offered by the controlled opposition. In our opinion, these videos pose well-aimed questions which, if they reach a wider audience, will cause many who are sleeping to fall out of their hammocks.

These videos consist of interviews with Poornima Wagh which were conducted by Regis Tremblay and Lee Merritt.

The Interviews with Dr Wagh

The interviews explore Dr Wagh's views on Covid, modern medicine, the discipline known as virology, the Covid 'vaccines', and the manipulation of science to control humanity. While we are unable to cover all of the material that Dr Wagh discusses, or detail the many compelling arguments that she offers to support her position, we will give in the following pages a general outline of what she said. Dr Wagh was born and raised in India. Her father worked for 18 years with Pfizer developing products for the Indian market. In her early teens she began to help him in his laboratory, acquiring in the process a strong 'show me the evidence' attitude which appears to have served her well ever since. Against her parents wishes she entered a career in finance but later switched to science and eventually ended up serving as a laboratory technician in California. Working for many years on tests and procedures on behalf of the pharmaceutical industry, she began to see how many grand scientific theories were built on flawed mechanistic assumptions about human biology, with little hard evidence to support them. She also saw how many of the laboratory tests which were used to justify treatments offered by the pharmaceutical industry were actually bogus.

Through continued study she acquired a doctorate in virology from the London School of Tropical Medicine. She successfully defended her thesis on malaria, which required two years of field research in Africa, despite making it known to the examination panel that she did not believe in viruses.

From her background we can see that Dr Wagh did not follow the traditional path into academia or career advancement but chose instead to conduct a study of those scientific topics which were of greatest interest to her. We are not aware of any scientific publications in her name. By her own admission she has aggravated a great many of her fellow scientists and co-workers throughout her career by continually questioning the accepted medical narrative and seeking hard evidence for conventional theories, for example through the use of Koch's postulates. Only by such rigorous means is it possible to justify the many sweeping claims about efficacy and causality in biology.

An excerpt from one of her interviews

Her stance on Covid is probably best expressed in the following excerpt from one of her interviews with Tremblay:

“There is no SARS-COV2 and there's no COVID-19 and there's no variant – no Gamma, no Delta and no Omicron – and there's certainly no damn Monkeypox. Monkeypox is essentially a side effect of the jabs, folks. There ain't no new virus. If you've been injected with Pfizer or Moderna or Johnson & Johnson or any of those jabs you get Monkeypox – you're essentially detoxifying from your skin.

“So I was contacted by my lab's principal investigator – who's the chief scientist at the lab – and they said they got 1,500 Covid-positive samples from southern California. And we got a huge 1.5 million dollar grant from the NIH to do the isolation of the novel [*alleged new virus*]. We had 20 lab members and we started the process of isolation, purification, characterization and causation the way I described it should be done, the correct way, with Koch's postulates and all.

“We started in late April 2020 and we went all the way to September of 2020...and the reason is my PI, the principal investigator, wanted the tests done three times. She wanted us to do the isolation three times on the 1,500 samples. Because... the first first when we did it we didn't find anything. We just found cellular debris. We didn't find SARS-COV2, we didn't find flu, we didn't find anything. Okay. She was upset that we hadn't isolated SARS-COV2. She was very much wanting to isolate and find the novel virus.

“We did it three times. And we found the same thing, just human cellular debris...And then... we did the Koch's postulates. We used ferrets, a hundred ferrets that we'd injected this material into – you always have to have a control group. That means you take a control group of another hundred ferrets and you inject them with saline solution.

“When we injected the ferrets, okay – this is very interesting. If there’s something deadly, like a virus or something, that makes people sick – they say all these people had high fever, runny noses, pneumonia, blah, blah, blah – well the ferrets should also get those same symptoms. Nothing happened! All were healthy, moving around, very active, vibrant...

“So she sent emails to other universities saying this is what we found. We contacted a hundred universities in this country [USA], of which only six responded. They said, Alright, we’ll replicate this whole process exactly the way you did it. They took about a month and a half to do their studies, and they found the same thing we did. They didn’t find SARS-COV2; they didn’t find the genome; they didn’t find anything. Nothing was found!

“Seven universities then called the CDC. Robert Redfield was the Director... Fauci’s colleague and Trump’s appointee as CDC Director. We called him and said, “Hey, these are the findings.” Two-point-five hours on a Zoom call, back and forth, and he said “Just call it SARS-COV2. I don’t care what you found. You have to call it COVID and SARS-COV2. If you don’t call it SAR-COV2 you’re going to lose your job and you’ll never work in a lab again. I’ll make sure you never work in a lab again. Your lab will be closed down, under-funded, not funded, etc etc.”

“We said no.

“Our group decided to go ahead and publish our findings. And we went to 21 journals... We went through *Science*, *Nature*... The last one we went to was in October of last year, October 2021, the *Danish Medical Journal*. We decided to go outside the country ... we did Scandinavia, they are usually open-minded. First... they gave us a provisional yes, and then they said no. I think the Danish government probably put some pressure – I don’t know what happened.

“Between June of 2020 to early August of 2020, after we found what we found, and the CDC said you have to call this SARS-COV2 blah blah blah, we actually started calling the CDC and asking them to send us an isolated, purified sample, so we could test it, okay. So we could actually do the causation studies and Koch’s postulates. Since they didn’t believe that our samples were any good, we said, Hey why don’t you send us just one or two samples, right? First they said they can’t send it. Then they said they didn’t have any samples, they had no record of any samples, etc etc. And then after two months they just started hanging up on us.

“Finally, in April of 2021, our lab was raided by the FBI. Everything was confiscated – computers, paperwork, graphs. Fortunately we and four other people had saved everything. I had everything saved, including the actual paper copies. I kept those, you know, the drafts, all our work, writings, everything, so we have all of that. We saved that. We can still publish.”



The gist of what she said

Some readers may find this excerpt a little difficult to digest. Dr Wagh is saying that the Covid virus is a hoax, it doesn't exist. Neither do any so-called variants. She and her co-workers made determined efforts to find it in the lab and failed to do so. They got other labs to replicate their findings, using the same rigorous methodology. Again, nothing was found. So they got in touch with the CDC and were told to say that they had found the 'coronavirus' which allegedly causes the symptoms known as 'Covid'. They refused to do this. They also asked the CDC to provide an isolated, purified sample so that their lab could see what they were supposed to find. But the CDC didn't send any samples.

Remember, this woman is a virologist, albeit one who doesn't believe in the existence of viruses. She said 'show me' and they couldn't show her anything. She was not greatly surprised by this turn of events since her own experience as a lab technician had proved to her that the techniques used for decades to isolate viruses were seriously flawed. Lab technicians who claimed to have isolated a virus – any virus – from a sample were actually finding genetic material introduced during the preparation of the sample.

Occam's Razor:

“Entities should not be multiplied beyond necessity.”

Of two possible explanations the simpler is to be preferred.

William of Occam propounded the principle known as 'Occam's Razor' in the 14th century. Crazy theories are in vogue today because this important principle is frequently ignored.

The confusion that this causes has been greatly exaggerated by the use of computers to record and analyze genetic sequences. Once a virus is deemed officially to exist, its genetic sequence is recorded and used thereafter to 'identify' and verify the existence of later viruses. If a sequence is found in a sample which matches part of a known sequence stored in the computer database, the scientists assume the two are related and one has mutated into the other.



No-one can obtain a copy of the SARS-Cov2 genetic sequence

She spoke of the considerable efforts made by fellow technicians and medical researchers to obtain a copy of the genetic sequence of SARS-Cov2 from official sources such as the NIH or the CDC, all of which came to nothing. No sample has ever been isolated. The sample extracted from the lung tissue of a few Wuhan victims was not properly purified. It also resulted in the publication of a genetic sequence for the virus which was nothing more than a computer-generated construct based on a tiny fragment of genetic material taken from the victims.

The Covid test is also bogus. Even though there are four different kinds of test, each tests for genetic material which would ordinarily be found – and harmlessly present – among a large proportion of the human population. Anyone who tested positive but was clearly asymptomatic was a false positive. Where a person was symptomatic, and also tested positive, there was no evidence whatever that the presence of the genetic material caused any of the observed symptoms. No proof for this has ever been offered.

Alarming discoveries by her research team

She began to carry out research of her own and contacted fellow scientists in a number of countries who were also dissatisfied with the official narrative. To date she has assembled a team of 17 volunteers (excluding herself) for this purpose. They obtained vials of the vaccines produced by a number of manufacturers (including Pfizer, Moderna, Johnson & Johnson, AstraZeneca, Novavax, Sputnik V, and Sinovac) and conducted a detailed chemical analysis of each. Their findings are immensely significant.



Firstly, they found that all of the vaccines contain essentially the same ingredients! In short, the ‘product’ was the same in all cases, across all brands. The only differences between them were due to small variations in the amount of each ingredient in the respective vaccines. In all they identified 35 variations.

Secondly, none of the vaccines contained any mRNA or ‘spike protein’. Given that the vaccines are supposed to work by enabling the body to produce spike proteins which stimulate an appropriate immune response, this was a remarkable finding. The pharmaceutical companies were lying. The ‘vaccines’ were nothing more than a toxic concoction made up of heavy metal nanoparticles.

Their findings in this respect are supported by analysis carried out by Dr Daniel Nagase, who is based in Canada (though Dr Wagh did not refer to his work). Dr Nagase conducted a spectroscopic analysis of several vaccines and found no trace of two elements that are always present in organic material, namely phosphorus and nitrogen. Their absence was proof that none of the vaccines contained mRNA.

Dr Wagh said the ‘vaccines’ – ALL of them – are nothing but a mixture of elements that are known to be harmful to human health.

How the ‘Covid’ hoax was perpetrated

Before we discuss these ingredients we will show how Dr Wagh explained the unusual spike in deaths in Wuhan, northern Italy and Tehran in March/April 2020. In her opinion, the powerful microwave frequencies produced by the recently erected 5G transmitters were more than capable of producing serious respiratory symptoms, especially in populations which already suffered from poor air quality – as in Wuhan, the industrial north of Italy, and Tehran.

Populations with a high proportion of heavy smokers, as in these locations, were also much more susceptible to irritation caused by 5G emissions. These three metropolitan areas were also known to have received 1-2 flu vaccines in the previous six months, which may have introduced graphene oxide into their bodies. These stress factors accelerated the deaths of people with underlying co-morbidities and enabled the World Health Organization, the CDC, and national medical authorities to claim – falsely – that a pandemic was on the rampage.

She also said that the death rate was also boosted in many countries by the liberal use of treatment protocols based on midazolam, a powerful sedative, and Dr Fauci's poisonous drug, Remdesivir. Many patients were also forced onto ventilators which only strained their lungs and failed to address the underlying hypoxia (oxygen deprivation). A great many died as a result of these bogus treatments.

Dr Wagh is unequivocal in her condemnation of the CDC and the various criminal organizations behind this daring attack on humanity. She sees it as a major step toward a One World Government and a totalitarian technocracy. The Elite want to kill off a large proportion of the population, she believes, and exercise absolute control over those who remain.

Bogus 'Covid' tests

The public was made to fear this non-existent disease by the flagrant use of a false testing procedure which greatly exaggerated the 'threat' posed by the so-called virus. The genomic test for the 'virus' had actually been developed in 2019, before the virus itself had been genetically sequenced! This is impossible unless the entire 'pandemic' was a hoax. The videos of people falling dead in the street in Wuhan were also fake.



She also referred to several authors who were pressured to retract scientific papers because their research proved inadvertently that the virus was bogus. Any attempt by researchers to publish findings that conflict with the official narrative are repeatedly blocked.

Furthermore, men and women of integrity, who know from their own knowledge and research that the pandemic narrative is a lie, are afraid to speak out because they will lose their jobs or their research grants. Apparently the NIH has a stranglehold over the authorization of grants across all sectors of the medical community in the US. A similar situation appears to obtain across Europe.

Dr Wagh's view of Virology

“Is virology a fraudulent field? The answer is a resounding Yes!”

She says that “virologists never isolated ANY virus.”

The set of symptoms known as ‘Polio’ in the 1950s was not caused by a virus but by DDT and certain other environmental contaminants such as lead arsenate, which was used widely as an insecticide before the introduction of DDT.

The defective method used to ‘isolate’ a virus

Dr Wagh outlined the defective method that for decades has been used to ‘isolate’ viruses. The lung fluid, which allegedly contains lung tissue cells infected by the virus, is mixed with monkey kidney cells and human cancer tissue cells. To this brew they add several antibiotics and antifungals, as well as proteolytic enzymes and bovine calf serum. The resulting cocktail is then left to stand for a week, during which time it begins to disintegrate. The scientists then examine the brew under a scanning electron microscope and locate the lung tissue cells. By this time the cells have been contaminated by the various other ingredients in the mixture. Perversely, any material that leaks from the cells is assumed to be a ‘virus’ that ‘infected’ the cell and produced the Covid-type symptoms in the person from which the lung fluid was extracted.

“They don’t isolate anything. It is just a toxic mess.”

Real science, based on personal hands-on research in the laboratory has been replaced by bioinformatics, the manipulation of biological data on a computer and the formulation of hypotheses which cannot be properly tested. It suits a great many research scientists because it enables them to publish papers in academic journals, qualify for further grants, and advance their careers.





What these deadly ‘vaccines’ actually contain

Dr Wagh and her team of 17 volunteers tested 2,300 ‘vaccine’ vials in total. The ‘platform’ or solvent in which the ingredients were immersed was a synthetic hydrogel adjuvant, a type of gel with a high water content which retains its structure when injected into human tissue. Millions of synthetic lipid nanoparticles are suspended inside the hydrogel. These contain reduced graphene oxide, a substance known to be toxic to humans. The vials also contain “massive amounts” of heavy metals in nanoscale form, including tungsten, osmium, silver, gold, nickel, lead, and aluminum. These too are highly toxic and small enough to cross the blood-brain barrier. The vials also contain particles of silica, or silicon dioxide, which is as hard as quartz. (They are akin to nanoscale particles of glass and just as dangerous.)

There is no mRNA or spike-protein-coded mRNA in any of the vials tested. The pharmaceutical companies have been lying.

When this chemical cocktail enters the body it remains highly stable. It is stored in adipose tissue, as well as other tissue types, causing irritation and inflammation. This chronic micro-level inflammation results in a diverse range of health problems, depending on where the particles lodge. She said the widely reported cases of myocarditis – inflammation of the myocardial tissue surrounding the heart – are caused by the harmful action of these particles in the vascular system. The inflammation reduces blood flow and causes shortness of breath and life-threatening arrhythmias.

Furthermore, the graphene oxide has an extremely weak positive electric charge. Everything in our body, especially our heart and our brain, are negatively charged. The graphene oxide is causing additional irritation by interfering with or ‘short-circuiting’ the electrical transmission within these organs. This is contributing to the high incidence of myocarditis among recipients of the vaccine. [See **Appendix A.**]

The numerous health problems caused by the vaccine are not due to the presence of any biological constituents because there are none. They are due rather to the multitude of inorganic substances which have been deliberately added to the ‘vaccine’. In reality the mixture has no therapeutic value whatsoever since it contains nothing that might mitigate the symptoms of a respiratory illness.

The ‘Covid’ scare – the ‘scamdemic’ – was designed to frighten millions of unsuspecting people into believing their health was in danger and inducing them to take one or more doses of this toxic mixture. Dr Wagh calls it “a chemical weapon.”

‘Speaking out’ is very high risk

Dr Wagh spoke of the worldwide crackdown on scientists who are speaking out about the harm that these supposed ‘vaccines’ are causing. She cited as an example a scientist in the Philippines whose home was burnt down. Many who are working to expose this grotesque attack on humanity are aware that their lives are in danger.

The website RetractionWatch (link below) lists 254 papers which were peer reviewed and published in reputable medical journals but later retracted for unknown reasons. All of the papers referred to Covid, either directly or indirectly, and all gave proof that the official narrative was either flawed, misleading or false.

It is generally believed that the journals or authors in question were coerced into withdrawing their papers.


Why harmful genetic substances were not used

Dr Wagh explained why biological toxins were not used in the ‘vaccines’. The public has been led to believe that gene-editing is so far advanced that very specific modifications can be made to a genome, for example to increase the severity of a harmful bacterium. She said these claims are grossly exaggerated, that living cells are far too complex to be modified with such precision. This is why the Elite are continuing to rely on old-fashioned chemical poisons.

The American people have been subjected to vaccines for the past 120 years or more, she said, with the result that vaccine damage caused to one generation has been passed on to the next. This may affect, not only the genome itself, but gene-expression (epigenetics), where genes ‘activated’ inappropriately or in the wrong developmental sequence in one generation may continue to affect the next generation. The harm caused by vaccines, all vaccines, is cumulative, not only in the individual but in the population as a whole.

A group of scientists in Europe make similar findings

A group of scientists – The Working Group for Covid Vaccine Analysis – published a preliminary report of their findings on 6 July 2022.

The working group describes itself as “an internationally networked working group, with a core team of more than 60 doctors, physicians, pharmacists, scientists, mathematicians, alternative health practitioners, lawyers and journalists. We have pooled our skills and technical expertise to help shed light on what we believe to be the largest pharmacological experiment ever carried out on the human race.”

In their preliminary report they stated:

“Toxic substances were found in all of the samples of COVID-19 vaccines - without exception [and] The blood samples of all the people who had been vaccinated showed marked changes.”

They also stated (p.18) that “the following predominantly metallic elements were unexpectedly detected in the doses from AstraZeneca, BioNTech/Pfizer and Moderna:

- Alkali metals: caesium (**Cs**), potassium (**K**),
- Alkaline earth metals: calcium (**Ca**), barium (**Ba**),
- transition metals: cobalt (**Co**), iron (**Fe**), chromium (**Cr**), titanium (**Ti**),
- Rare earth metals: cerium (**Ce**), gadolinium (**Gd**),
- Mining group/metal: aluminium (**Al**),
- Carbon group: silicon (**Si**) (partly support material/slide),
- Oxygen group: sulphur (**S**)

These substances, furthermore, “are visible under the dark-field microscope as distinctive and complex structures of different sizes, can only partially be explained as a result of crystallization or decomposition processes, [and] cannot be explained as contamination from the manufacturing process.”
