


# Severe Internet Censorship is Now Imminent

The Elite announced their intention to suppress all critical discussion of the New World Order when, on 7 February, the leaders of Freemasonry in the UK took out full-page ads in the leading national newspapers – *The Times*, *The Guardian*, and *The Telegraph* – to declare that they would no longer tolerate criticism of their fraternity.

Their warning, 'Enough Is Enough', was forceful and direct:

"The United Grand Lodge of England believes that the ongoing gross misrepresentation of its 200,000 plus members is discrimination. Pure and simple. We owe it to our membership to take this stance, they shouldn't have to feel undeservedly stigmatised. No other organisation would stand for this and nor shall we."



This "nor shall we" warning was a statement of intent, a declaration of war against all who, up to now, have dared to question and expose the wickedness behind Freemasonry and the New World Order. Before long such criticism will be treated as a 'hate crime' and punished accordingly.

The illustrious Masonic lodge known as the European Parliament is now following through with that threat. A Directive dealing with copyright, which has been under discussion in draft form for several years, is fast approaching finalization. During the past year it has been substantially strengthened by the inclusion of draft provisions which, if retained, will impose a draconian regime of Internet censorship across the EU. This in turn will signal the imminent introduction of a similar form of censorship throughout the rest of the world.

## The Death of Free Speech

If this happens – and it appears unstoppable – free speech will be dead. The unfettered exchange of information, views and opinions that has characterized the Internet over the past twenty years or so will come to a sudden and dramatic end. Thereafter all views and opinions that are deemed to conflict with the New World Order and its vision for humanity will be suppressed. A totalitarian system of censorship, supported by sophisticated surveillance software, will ensure that any material, from any source, that happens to make its way onto the Internet highway will be quickly sniffed out and deleted. In fact most of it, as we shall see, will be suppressed before it even gets that far.

## The EU Censorship Manifesto

The basic philosophy behind all of this was set out in a 'Communication' from the European Commission on 28 September, 2017. Under the title **Tackling Illegal Content Online**, it specified the principal mechanism that would be used to eliminate "illegal content" – which, of course, will embrace any material that the Elite wish to censor or keep from public awareness.

The main elements of the Communication are summarized below:

### Illegal content

In it they say that the significant increase in "*illegal content*" that can be accessed online "*raises serious concerns that need forceful and effective replies...the detection and removal of illegal content online represents an urgent challenge...*"

They signal their intention to target at a later stage online content which, though not strictly illegal, is "*potentially harmful*", such as "*fake news*".

### Trusted flaggers

The Communication highlights the role of what it calls "*trusted flaggers*", which it defines as follows: "*The removal of illegal content online happens more quickly and reliably where online platforms put in place mechanisms to facilitate a privileged channel for those notice providers which offer particular expertise in notifying the presence of potentially illegal content on their website. These are so-called "trusted flaggers", specialised entities with specific expertise in identifying illegal content and dedicated structures for detecting and identifying such content online.*" Note the use of "*dedicated structures*", namely software tools which enable these cyber police to track down undesirable content and erase it from the Internet. Their knowledge and expertise will enable "*faster take-down.*"

While the Communication frequently refers to terrorist activity and sexual exploitation websites as examples of the content they are aiming at, it also includes "*hate speech*" and "*xenophobic content*". Since hate speech can be construed to cover views and opinions which could offend certain categories or groups – such as humanists, feminists, Freemasons, neopagans, Marxists, atheists, homosexuals, transgenders, or abortionists – the restrictive effect of this provision is very wide-ranging.

The "*trusted flaggers*" will have the power to compel website hosting services to "*remove content upon notification from the trusted flagger without further verifying the legality of the content themselves.*" In other words, these invisible policemen can "*take-down*" whatever content they deem inappropriate and there is nothing the website owner can do about it. An appeal to the hosting service would get nowhere.

### **Filtering and surveillance technology**

Any person can complain about a website to a "*trusted flagger*" without having to disclose their identity. The "*trusted flagger*" could then notify the hosting service that a certain URL is in violation of its standards and have the offending material removed immediately. Hosting services will be expected to "*act expeditiously to remove or to disable access to the information*". The Communication also makes hosting services liable if they permit websites to carry content which they could reasonably have known to be illegal. This in turn will place pressure on hosting services to audit the content of websites on their server. As the Communication states: "...*it is in the interest of all parties involved to adopt and implement rapid and reliable procedures for removing and disabling access to illegal information.*" It also draws particular attention to "*the use of automatic detection and filtering technologies [which are] becoming an ever more important tool in the fight against illegal content online. Many large platforms are now making use of some form of matching algorithms, based on a range of technologies, from simple metadata filtering, to hashing and fingerprinting content.*"

It then goes on to call for the development of suitable surveillance technology for use by website hosting services:

*"The Commission supports further research and innovative approaches going beyond the state of the art with the objective of improving the accuracy of technical means to identify illegal content. It also encourages industry to ensure an effective uptake of innovations which may contribute to increased efficiency and effectiveness of automatic detection procedures."*

There is no doubt that this will quickly become mandatory and that the relevant technology already exists. Hosting services that do not use it will likely be penalized in some manner.

### **Immediate action**

How quickly should the content be taken down? The Communication requires immediate action: "*Some voluntary processes such as the Code of Conduct on countering illegal hate speech online have provided indicative targets for removal times, in the case of this Code of Conduct, 24 hours for the majority of cases.*" The Communication underscores the onus on hosting services to act immediately by stating that "*As a general rule, removal deriving from trusted flagger notices should be addressed more quickly.*" The goal they are aiming for is "*fully automated deletion or suspension of content.*"


## The EU Copyright Directive

The legislative mechanism by which this manifesto is being implemented in the first instance is the proposed **Directive on Copyright in the Digital Single Market**.

In an open letter dated October 16, 2017, fifty-seven organizations from across Europe dealing with civil liberties, openness, and freedom of speech wrote to the President of the European Commission, Jean-Claude Juncker, and senior European lawmakers expressing their grave concern over certain provisions in the draft Directive. Their letter included the following statements:


"Article 13 of the proposal on Copyright in the Digital Single Market include obligations on internet companies that would be impossible to respect without the imposition of excessive restrictions on citizens' fundamental rights... Article 13 appears to provoke such legal uncertainty that online services will have no other option than to monitor, filter and block EU citizens' communications if they are to have any chance of staying in business... In particular, the requirement to filter content in this way would violate the freedom of expression set out in Article 11 of the Charter of Fundamental Rights.

The draft Directive also includes a provision which would require website managers to pay a special copyright fee (a 'link tax') to source websites (copyright holders) simply for the privilege of quoting short snippets of text when giving a link to the original news article. The link tax would be an inalienable right, meaning that the source website – mostly news corporations and press agencies – would be unable to waive the fee even if it wanted to.



This Directive is heavily biased in favor of big news corporations, for whom such fees would be a minor inconvenience. For smaller websites the link tax could constitute a prohibitive burden and would make it impossible for many to continue in operation. Even a small blog would be affected by this measure.

## King Jehoiakim burns Jeremiah's scroll



"And it came to pass, that when Jehudi had read three or four leaves, he [i.e. King Jehoiakim] cut it with the penknife, and cast it into the fire that was on the hearth, until all the roll was consumed in the fire that was on the hearth. In its examination of the draft Directive and other related documentation issued by the EU Commission, the Electronic Frontier Foundation stated: "If we lose the battle against the use of upload filters for copyright, we'll soon see a push for a similar mandate on platforms to filter other types of content, beginning with ill-defined "hate speech" and terrorist content, and ending who knows where." [October 16, 2017]. Yes indeed, who knows where?

## CONCLUSION

This is by far and away the greatest threat ever directed at the Internet. It will impose a sweeping system of censorship, supported by sophisticated surveillance software, that will cripple free speech and silence anyone who dares to question the New World Order. A network of 'trusted flaggers' (censors) will be established to hunt down any online content that might possibly offend the ruling Elite. After all, "Enough is Enough" according to the London Masonic fraternity, and further dissent will not be tolerated.

Website hosting services will be compelled to assist in this clean-up operation or suffer penalties, as yet unspecified, if they fail to do so. Non-commercial websites will be unable to report and comment on news and current affairs, giving links and quotations, without paying for the privilege in the form of a prohibitive 'link tax'. Online content that cannot be declared illegal under copyright law will instead be described as 'hate speech' or 'fake news' and banned accordingly. This 'take-down' will be carried out with such speed that few members of the public will realize that a draconian system of censorship is actually in place.

The European Police State is about to be rolled out. Totalitarian regimes always stamp out free speech before taking more oppressive action against a target population.




## **Worldwide implications**

It is important to understand that the European censorship regime will only be effective if it is implemented on a worldwide basis. There is no point in censoring material distributed through an Internet platform based in Europe if the same material can be uploaded to a platform based elsewhere, such as the US or Canada. This can only mean that the Elite are planning to impose the same regime everywhere, very likely within a short period of time. The European Police State is therefore a prelude to one that covers the face of our flat, stationary earth. [When this nasty system is in place, online material discussing our flat, stationary earth and the hoax known as 'outer space' will be suppressed as fake news. This is exactly the kind of information they want to 'take down', while sites marketing child pornography will continue to flourish.]

George Orwell was struck by the complacency of the British public in the years leading up to World War II. Despite many strong indications that Germany was preparing for an all-out European war, they could not bring themselves to accept that such a calamity could come so soon after World War I. As Orwell put it: "Only in the English-speaking countries was it fashionable to believe, right up to the outbreak of the war, that Hitler was an unimportant lunatic and the German tanks made of cardboard." The pastors and elders of the church in the English-speaking world today are just as blind – wilfully blind – to the horror of what is unfolding. Christ asked us to "Watch!", to pay close attention to world events as the end time approached, but these people are fast asleep. At what point will they wake up and take notice?



## **Abortion and Censorship**

Last week the people of Ireland approved the introduction of legislation that would allow an unborn child of three months to be murdered in the womb, simply on the grounds that the mother did not want to give birth to the child. They did this knowing that the government would also legislate for late-term abortions – up to six months – on vaguely specified mental health grounds. During the lead-up to this hideous event church leaders in Ireland did virtually nothing to alert the public to the catastrophic spiritual consequences of what they were about to do.

There were no street protests, no public displays of anger, no revulsion at the prospect that thousands of innocent children would be killed for convenience. They did not appoint church teams with experienced leaders to promote the pro-life position in their local communities. They refused to preach God's Word on this issue, preferring instead to frame their pallid reservations in the language of the UN and human rights. They did not take out ads in the press. They didn't even bother to produce posters and leaflets which set out the Biblical position or refute the many disgraceful lies told by the government and repeated ad nauseum in the media. In short, with a few notable exceptions, the preachers and pastors of Ireland did nothing to oppose the wickedness of abortion. (We can be grateful for the tiny groups of believers here and there who, despite the appalling lack of leadership, went forth diligently, day after day and week after week, to canvass voters who had not yet made up their minds.)



### The Freemasons of Westminster

Never in history has a nation voted to murder a sizeable proportion of its own children. The British Elite must feel a little peeved that Ireland has, in this matter at least, surpassed them in wickedness. Perhaps this is why, later this afternoon, the House of Commons will debate for three hours a motion to repeal sections of the 1861 Offences Against the Person Act, which criminalized abortion. This ceased to be a criminal offense under the 1967 Abortion Act in England, Scotland and Wales, but still continues to be an offense in Northern Ireland (the six counties of Ulster which constitute part of the United Kingdom).

The Elite could have embarked on a campaign of disinformation and deceitful propaganda in N Ireland, similar to the one employed in the Republic, with a view to persuading the majority of voters in that part of the UK that abortion was a human right and a woman's choice. But that would have taken a few years. They are clearly anxious to press ahead as quickly as possible with their Luciferian agenda and are prepared to deny the Northern Irish electorate any say in the matter. Instead of introducing fresh legislation to facilitate abortion, akin to the 1967 Act, they can simply repeal the legislation which made it a criminal offense in the first place.

The people of N Ireland have kept out abortion for far too long. The Masonic 'Angel of Light' is not pleased. Enough is enough. The lambskin luminaries in Westminster seem determined to call a halt to their impertinence.

If the Elite can do something like this, riding roughshod over a self-governing province and threaten to thrust aside a law which has protected its people since 1861, then their cynical suppression of free speech across Europe should hardly come as a shock to anyone.

These rebellious people will no longer tolerate a Biblical point of view.
