


# Sirius, Coronavirus, and *Canis Major*

We will introduce this paper with a simple quiz. What do you think the two images shown above represent? We will return to this question later in the paper.

When people lose their ability to think rationally, there is no point in trying to reason with them. The best one can hope for is a realization on their part that there may be more to the “official story” than they are being told.

Regular readers of the papers posted on this website will know that we gather the facts as carefully as we can and try to show how they fit into the bigger picture. We must never lose sight of the bigger picture since we already know what it is. God in His mercy has shown it to us in His Word. This is why it is so important that Christians read and re-read the Bible and in particular those passages which relate to the End Time.

The world is currently in the middle of a carefully contrived crisis which the Children of Wickedness have engineered with considerable craft and cunning. Since this crisis is set to get worse, we need to understand how the public is being manipulated, and implacable attitudes shaped, by ‘facts’ and reports which have little or no scientific basis.

## PART ONE

In earlier papers we have shown that the official account of the Wuhan plague is inconsistent with all that we know about epidemics and disease. If Covid-19 is highly contagious, as alleged, then why has it had little or no impact on countries close to China, such as Taiwan, Vietnam, Laos, Cambodia and Mongolia? Why hasn't it had a severe impact on a densely populated country like Japan, with the highest proportion of "at risk" (elderly) people in the world? Tokyo is less than 9 hours flying time for Wuhan, the centre of the outbreak. Hundreds of businessmen flew between these two commercial hubs every week. The virus would therefore have "hit" Japan in early January (In fact its first official case was diagnosed on 14 January). Using the mortality projections being made by scaremongering specialists like Imperial College London, Japan should have had at least 20,000 deaths from the virus by the end of March. What was the actual figure? – 52. Yes, 52, out of a total population of 127 million. Bear in mind, Japan has an unusually high cohort of elderly citizens, the category normally deemed most vulnerable to coronavirus infections. In addition, the population density per square mile in Japan is considerably higher than it is in, say, the US, so the rate of contagion should be much greater.

### Belarus

Population 9.5 million. No lockdown, not even social distancing. Number of deaths ascribed to Covid-19? – only 204 (as of 24 May). Most died from other causes but happened to test positive for Covid-19.

As of 24 May, the average number of Covid-19 deaths in Japan per million of the population is 6. The corresponding figure for the UK is 541! If you have any doubts about these figures, check them at <https://www.worldometers.info/coronavirus/> -

None of this makes any sense. A virus cannot distinguish between populations in this way. There is clearly another factor at work.

## Looking at Europe

Let's look at Europe as a whole. We will use the figures from the EUROMomo website. The charts in respect of 19 countries are shown in **Appendix A**. Up-to-date figures are submitted regularly by individual countries. When tabulated they allow long-run trends to be identified, thus allowing "excess deaths" to be computed. All of the charts take account of excess mortality above the normal range in the period January 2017 to April 2020. Spikes above the dotted red line on each chart ("substantial increase") would be considered significant.

We can break these 19 countries into four sets, based on the extent to which the excess death rate in March/April 2020 varies from recent historical trends:

How is it possible for half the countries in western Europe to have effectively side-stepped a "highly contagious" disease, while a quarter suffered a significant spike in excess deaths?

In order to answer this question, we will look at two of these "major increase" countries – Italy and the UK (England). Each will tell a very disturbing story.

## Italy

Everyone has heard of the high death rate from "Covid-19" in northern Italy, notably the region around Brescia and Bergamo. Our TV screens were full of images of accumulating coffins as space was hastily sought in local cemeteries to accommodate the mounting death toll. The rate was so great, we were told, that corpses had to be cremated.

According to the medical experts the air quality in the region was poor, aggravating respiratory tract infections and weakening the immune systems of the high risk elderly population. However, the air quality in Lombardy is not much different from the air quality in many parts of Europe, where the number of "Covid-19" deaths was virtually zero. Furthermore, Italians, even those in the northerly regions, traditionally eat a diet which is conducive to good respiratory health. There was really no reason why elderly people living in the region should be more susceptible to "Covid-19" than the elderly living around Dusseldorf, say, or Warsaw, or Lyons, or Bratislava, or anywhere else for that matter.

Here are some crucial facts which we were not told, and which very likely will never be disclosed in the mainstream media.

Firstly, according to FluTrackers.com, the region around Brescia experienced a severe outbreak of respiratory illness in the period 9 September to 18 October, 2018. In total 878 cases of pneumonia were reported, hundreds of whom had to be hospitalized and given emergency treatment. The cause of this unprecedented epidemic was never properly identified, though many experts offered their opinions. Initially it was believed that Legionella bacteria may have been carried through the air by emissions from industrial cooling towers, but evidence for this was scant. Besides, even if Legionella was involved, it could not have accounted for the scale of contamination.

The average age of those afflicted by the outbreak was 65. Since the infection was bacterial and not viral, patients could be treated successfully with antibiotics. This meant the final death toll was relatively low.

The next undisclosed fact is also relevant. In October 2019, 185 thousand doses of flu vaccine were delivered to Bergamo.

Many commentators believe the seasonal flu vaccine may have caused “viral interference” with the Covid-19 virus, increasing its virulence. It has also been suggested that the flu vaccines delivered to northern Italy were prepared in a canine cell line which contained other coronaviruses (At least three different coronaviruses have been identified in dogs). For example, Flucelvax by Novartis is made, not in the traditional chicken egg cell line, but in canine kidney cells.

The third important fact is probably the most alarming of all. Judge for yourself. It too is not generally known, despite its obvious relevance in *any* genuine analysis of the so-called Covid-19 pandemic in northern Italy.

A local newspaper carried the above headline on 18 January 2020. It reads: “Emergenza Meningite, Vaccinate 34mila persone tra Brescia e Bergamo” – “Meningitis emergency, 34 thousand people vaccinated between Brescia and Bergamo.”

### **From the newspaper report**

“Sono quasi 34mila le persone vaccinate in poche settimane contro il Meningocco C, con punte del 70% del target previsto... Ben 40 medici di base del territorio hanno aderito a questa operazione senza precedenti...”

*Translation of above:* “Almost 34 thousand people vaccinated against Meningocco C in a few weeks, with peaks of 70% of the expected target... As many as 40 general practitioners in the area have joined this unprecedented operation...”

Please take a moment to let this sink in. Meningitis is a dangerous disease. It comes in two forms, bacterial and viral. The bacterial form is far more dangerous. The newspaper report is telling us that 34,000 people in the region of interest to us – Brescia and Bergamo – got this free vaccine in an “unprecedented operation” just a few weeks before the famous ‘Covid-19’ outbreak.

So, in addition to coping with a serious unexplained epidemic in September 2018, tens of thousands of people living in the region, especially those in the older age bracket, were burdened with a flu vaccine a few months before the ‘Covid’ outbreak, along with a vaccine to combat meningitis. With the arrival of a seasonal flu virus, the potential for “viral interference” is obvious, not to mention the possible residual impact of latent pathogens following the 2018 epidemic.

If you are eighty years old, with an underlying co-morbidity (which impairs the immune system), these factors could constitute a death sentence. This certainly proved to be the case for thousands of elderly people in the region. It is difficult to dismiss the possibility that the people of Brescia and Bergamo were unwitting guinea-pigs in a vile human experiment.

### **UK (England)**

The excess death rate in England is so great that *The British Medical Journal* drew attention to it on 13 May, and even used the word “staggering” in its heading. It stated that:

“Only a third of the excess deaths seen in the community in England and Wales can be explained by Covid-19, new data have shown.”

One may need to read this statement a few times to appreciate just how much it conflicts with the standard narrative – the full report may be found in **Appendix B**.



The report stated that “over the past five weeks, care homes and other community settings had had to deal with a ‘staggering burden’ of 30,000 more deaths than would normally be expected, as patients were moved out of hospitals that were anticipating high demand for beds. Of those 30,000, only 10,000 have had Covid-19 specified on the death certificate.”

The matter was discussed at a high-level meeting of medical and other professionals in the UK on 12 May. While it was acknowledged at the meeting that some of these “excess deaths” might have been the result of under-diagnosis, “the huge number of unexplained extra deaths in [family] homes and care homes is extraordinary.” A representative from the University of Cambridge said, “this rise in non-Covid extra deaths outside the hospital is something I hope will be given really severe attention.”

### **“really severe attention”**

It is seldom that an organ like the *The British Medical Journal* carries an expression as dramatic and crisis-laden as “really severe attention.” It is obvious that the authorities are dumbfounded by this finding. In just a few weeks, around 20,000 more people died in the UK from standard (non-pandemic) illnesses than would normally be expected. The excess is too great, by far, to be dismissed as a statistical spike. So, what is going on?

There would appear to be three possible explanations:

- (a) The sharp reduction in health services available to non-Covid patients caused many of them to die earlier than might have been the case if they had been hospitalized. Regarding this possibility the professor of epidemiology at the London School of Hygiene & Tropical Medicine stated: “Some of these deaths may not have occurred if people had got to hospital. How many is unclear. This issue needs urgent attention, and steps [need to be] taken to ensure that those who would benefit from hospital treatment and care for other conditions can get it.” This comment would suggest that there were few at the meeting on 12 May who believed that reduced hospitalization could account for such a high figure.

- (b) Thousands died unlawfully, whether through neglect or euthanasia.
- (c) Thousands were fatally harmed by an unknown environmental agent.

The second possibility is not as outrageous as it might first appear. We have already discussed in a previous paper (#167) the systematic murder of over 650 patients at a hospital in Gosport over a ten-year period. The medical profession in the UK and elsewhere has for decades been sympathetic to the view that human life should end when people have ceased for many years to make a productive contribution to society. They are effectively seen as “useless eaters” whose continued existence is a drain on the economy and serves no useful purpose. The English ruling classes have long held this view:

**“We should facilitate, instead of foolishly and vainly endeavoring to impede, the operations of nature in producing this mortality; and if we dread the too frequent visitation of the horrid form of famine, we should sedulously encourage the other forms of destruction, which we compel nature to use. In our towns we should make the streets narrower, crowd more people into the houses, and court the return of the plague.”**

- Thomas Malthus, *Essay on Population*, 1798

## **“Please make comfortable.”**

The famous ‘Liverpool Pathway,’ an end-of-life care program in the UK which came dangerously close to enabling euthanasia, was grounded in this utilitarian philosophy. We saw how it manifested in the “Please make comfortable” instruction which was used at Gosport. When a new patient was admitted the doctor on duty wrote “Please make comfortable” in the patient’s medical chart, thereby enabling the nurses caring for the patient to certify his or her death without consulting further with the doctor. Using this protective license, a team of nurses at the hospital were able to murder hundreds of patients over a period of several years without detection. The murder rate was horrifying – one patient every 5 days – but possibly just as horrifying was the extent to which the British medical establishment went to cover it up. In fact, the cover-up continues to this day since the media won’t touch the story and not one person has been jailed.

## **“Do not resuscitate” (DNR)**

A similar if less cynical procedure is used in Ireland, known by the term, “Do not resuscitate” (DNR). Even though there is no legislative basis for this practice, it is believed to be widespread. Under it, a doctor can indicate, either in writing or simply by word of mouth, that the nurse is not to resuscitate the patient using CPR should he or she go into cardiac arrest. In effect, the nurse has sole discretion to decide whether a patient lives or dies.

A member of Dáil Eireann raised this matter with the Minister for Health on 21 May. He was concerned that the high number of Covid-type deaths in a nursing home in his constituency may have been due to the liberal use of the DNR option. It is a mark of how prevalent this practice has become that it is now being raised in Dáil Eireann. Normally Irish deputies steer well clear of anything that might embarrass the Government – there has been no political opposition in Ireland, and therefore no accountability by the Executive, for over twenty years.



### **“an unbelievably serious matter”**

In raising the matter, Deputy Fitzpatrick said: “A HIQA report from a number of years back referred to the fact that "do not resuscitate" orders were written on the medical charts of patients in some nursing homes without the consent or knowledge of the next of kin. This is an unbelievably serious matter and the only response to this is more openness and public debate on the issue.”

The Minister did not deny that this was happening but said he would “consider” the matter!

In a damning review of DNR in Ireland in 2018, the website *irishhealth.com* stated:

Currently, there are no Irish medical guidelines, nor is there any legislation that covers this particularly sensitive area. It means that the decision can be taken by just one healthcare professional, without any input from the healthcare team involved or the family of the patient. That is a most unsatisfactory situation. Furthermore because the healthcare professional who issues the DNR order may be reluctant to formally record it in the patient's record, it may be passed on verbally to staff and relatives may never even know that CPR was not attempted on their loved one.

The third possibility – where thousands are fatally harmed by an unknown environmental agent – must also be taken into account. It is difficult to say what this might be, other than 5G.

## **Manipulation and Deception by our Governments**

In summary, the situation in both Italy and the UK is a cause of real concern. In each instance we have identified factors which could have contributed to the high excess death rate, factors which have nothing to do with a pandemic disease. If the Elite are determined to press ahead with their ‘lockdown’ and associated system of social control – social distancing, contact tracing, official testing, vaccine passports, home entry, family separation, remote quarantine, and compulsory vaccination – then they must be able to maintain a high “excess death” rate by one means or another. Quite possibly all of the factors we have identified are being used, as and when the occasion requires.

### **The Gosport murders and the official cover-up**

For readers who may still doubt the willingness of the architects behind the coming New World Order to employ pathological methods of this kind, we would recommend that they re-read our paper on the Gosport killings (#167). We are not dealing here with normal people but with a power-hungry consortium whose morals are no different from those of the Nazis.

Conscience and compassion are alien words to these people, a sign of weakness. In their philosophy, the end justifies the means. They are convinced that the population of the world must be reduced to 500 million or so, otherwise the earth will be “overrun” by useless eaters. In order to achieve that reduction, a centralized system of world government is required. Since sovereign nations are not going to voluntarily surrender their independence, they believe it is necessary to create a series of major crises to convince them that a centralized world government is essential. If they are to achieve the desired effect, these crises must be sufficiently traumatic that no alternative solution is even considered. Massive economic distress, widespread social unrest, and a high death toll are seen as a sure path to success.


That’s what the planned “pandemic” is all about. It’s a massive exercise in mind control and social manipulation. And it’s getting results.

## PART TWO

The Ruling Elite are described in the Bible as “the children of wickedness.” Their god is not the God of Abraham, Isaac and Jacob. They despise the Word of God and they loath the living Word, Christ Jesus. As practitioners of the “old religion” they worship and serve the Adversary and the ‘host of heaven’ – mostly through the pantheons of ancient Egypt, Babylon, Greece and Rome. The various ‘gods’ in these pagan religions are essentially the same high-ranking demonic entities, but expressed in different, albeit similar, forms from one culture to another.

In our recent paper, *The Gods of Ancient Egypt and the Mark of the Beast* (#229), as well as in several papers cited therein, we have shown how the magical system of Ancient Egypt is shaping and guiding the minds of the Ruling Elite. The city of London is, esoterically, a modern version of Heliopolis, the City of the Sun, while the religious system which the British Empire spread across the world is basically that of Ancient Egypt but expressed in the form of Freemasonry.

Before we give a concrete example of this, we will return briefly to our opening quiz:

Some readers may have guessed that the image on the right is that of an early NASA ‘satellite’, but few will have identified the image on the left. It is supposed to be a photo of a virus taken by a mass spectrometer in 2018 (Note the coiled serpent beneath the pyramid!) In our opinion, both are fictional.

Since we have already dealt with this theme at some length in previous papers, such as #118 (*The Illuminati are Using Sham Science and Bogus Theories to Deceive Mankind*), we will not pursue it further on this occasion. However, he will ask our readers to treat with suspicion the claim that the image on the left is a virus and to consider instead the possibility that it is just one of the many tricks that the Elite are using to confuse mankind and create a false reality.

We'll return briefly to this ‘virus’ in Part Three.

We will now address, using a concrete example, the way the gods of ancient Egypt are worshipped today in Freemasonry.

Since this practice has been shrouded in secrecy for hundreds of years, it has not been possible until recently to put the two side by side and prove they are connected. While much evidence for this pagan practice may be found in Masonic writings, not to mention the regalia and insignia used in certain lodges and rites, the smoking gun, as it were, has not been easy to find. This is why the following example is so important, enabling sceptics to see for themselves that Freemasonry is the religion of Ancient Egypt in a thinly disguised form.

Regarding the above, Wikipedia says:

The major feature of the Egyptian Room is the frieze which depicts the funeral procession and burial rites of the scribe, Ani, together with the after-death trials of his soul before the gods. These scenes come from a version of what is popularly known as "The Book of the Dead", but which, in fact is entitled "The Book of Coming Forth By Day" – that is, the day of the after-life. Such papyri were intended as "guide books" for the soul in its after-death condition so that it could negotiate the perils which it would be encountering in the world beyond the grave. The Egyptian texts, which have been found in tombs from around 1600 to 1300 BC assume that the dead person's *ka* (or spirit body) will encounter various trials (including demons of various forms), before facing judgement and (hopefully) resurrection into a new life.

The Papyrus of Ani, from which the vignettes around the Room have been accurately reproduced, was acquired by the British Museum about 1935 and had been written in the 18th Dynasty (about 1450 BC) for Ani, "Veritable royal scribe, scribe and accountant of the offerings of all the gods, governor of the granary of the Lords of Abydos, scribe of the offerings of the Lords of Thebes". His wife Tutu, a member of the royal college of singers in the temple of Amen-Ra at Thebes had died some years before him, but she appears in some of the vignettes...

That section of the frieze in the east, over the throne for the Master of the Lodge, shows the judgement in which the dead man's soul, represented by his heart, was placed on a balance and weighed against truth and righteousness (Maat), represented by a feather.

The balance is held by the jackal-headed god, Anubis. If Ani's heart is heavier than the feather he is condemned. However, if he is found righteous "His heart is found righteous coming forth from the balance" and he is taken before Osiris in the Hall of Truth.

Freemasons, especially those in the higher degrees, worship the gods of Ancient Egypt. For years they have concealed their allegiance to this pagan religion, but today they are much more open about their veneration of Ra, Maat, Osiris, Anubis etc, whom they revere as divine beings.

Freemasonry despises Christianity and has been working stealthily for centuries to destroy it. All newly inducted Masons are taught that it is alright to deceive – both the public and each other – to protect the Craft. They swear a blood oath never to reveal what Freemasonry is all about.

In the lower degrees they are taught to believe that Jesus Christ was a “good man”, but certainly not the Son of God. As they advance up the ranks, the lies deepen and the darkness grows more intense. The above excerpt from Wikipedia mentions that the scenes in question are taken from the *Egyptian Book of the Dead*. In his authoritative *Encyclopaedia of Freemasonry*, Mackey quotes approvingly from *The Book of the Dead*, showing how central it is to Masonic philosophy. In fact he cites the following passage at length in order to prove that the initiations and gods of Freemasonry are those of Ancient Egypt:

“Says Thot to Osiris, King of Eternity, I am the great God in the divine boat; I fight for thee; I am one of the divine chiefs who are the TRUE LIVING WORD of Osiris. I am Thot, who makes to be real the word of Horus against his enemies. The word of Osiris against his enemies made truth in Thot, and the order is executed by Thot. I am with Horus on the day of celebrating the festival of Osiris, the good Being, whose Word is truth; I make offerings to Ra (the Sun); I am a simple priest in the underworld, anointing in Abydos, *elevating to higher degrees of initiation*; I am prophet in Abydos on the day of opening or upheaving the earth. I behold the mysteries of the door of the underworld; I direct the ceremonies of Mendes; I am the assistant in the exercise of their functions; I AM GRAND MASTER OF THE CRAFTSMEN WHO SET UP THE SACRED ARCH FOR A SUPPORT.” (See *Truth*.)

From this we can see that, to high-level Masons, the “TRUE LIVING WORD” is the pantheon of gods who sail in the Solar Barque or “divine boat” – Thoth, Osiris, Horus, Ra and the rest.

The gods of ancient Egypt – the very demons who opposed Moses – are worshipped today in cities and towns across America. The same demons are also worshipped in England, Scotland, Ireland, Canada, France, Italy, Germany, Netherlands, Sweden, Austria, Poland, Australia, New Zealand, South Africa, Brasil, Mexico and, according to the list of ‘Masonic Grand Lodges’ in Wikipedia, more than a hundred other countries.

Freemasonry is the unspoken religion of the Anglo-American ascendancy who control the wealth and ruling institutions of the world and who are bringing in a New World Order.

The reflecting pool expresses the principle, “As above, so below.”**

## PART THREE

In this part we intend to show how the matters discussed in Parts One and Two are related. For readers who are not yet familiar with the strange world of astral duality in which the Elite spend their lives, a world full of symbolism and ritual activity, the following information may seem too fantastic to be true. However, for those who have learned the importance of the magical principal, *As above, so below*, in the Babylonian-Egyptian-Masonic religion, the connection we are about to reveal will make a great deal of sense.


As we have already noted, the city of London is a modern ‘City of the Sun’, akin to Heliopolis in Ancient Egypt. In our earlier paper, *Babylonian London, Nimrod, and the Secret War Against God* [#56], we gave many examples of the way the obelisks, spires and steeples of London are arranged to represent the constellations in the night sky. These star patterns are known as asterisms, while the obelisks and spires are, as the Bible tells us, *Asherim* or shrines to the pagan god, Baal/Satan.

"And he [Josiah] brake in pieces the images [**Hebrew: Matstsebah, obelisk**], and cut down the groves [**Asherim**], and filled their places with the bones of men. Moreover the altar that was at Bethel, and the high place which Jeroboam the son of Nebat, who made Israel to sin, had made, both that altar and the high place he brake down, and burned the high place, and stamped it small to powder, and burned the grove [**Asherah**].” - **2 Kings 23:14-15**

The principle, *As above, so below*, would seem to require that the terrestrial or earthly representations of the celestial bodies reflect in some manner their stature or prominence in the night sky. In our earlier paper we speculated that, since the brightest star in the northern sky is Sirius, which lies in the constellation *Canis Major*, and since the largest of the massive *Asherim* of London is the Fire of London Monument, the latter might be related in some way to Sirius.


If so, then it might also be associated with certain other *Asherim* to form an asterism of *Canis Major*, the constellation in which Sirius is located.

We give some charts below showing the structure of this asterism:




**Images of the Asterism known as Canis Major.**

On the basis that the Fire of London Monument corresponded to Sirius, it was possible to identify the other 13 Asherim in the asterism, as follows (Sirius is #7):

These *Asherim* comprise some of the biggest monuments in London and are among the most significant of their type in the world. Cleopatra's Needle, for example, a massive 69 foot obelisk on the bank of the Thames, was first erected in Heliopolis in Ancient Egypt around 1450BC. As we noted in our earlier paper [#56] the Seven Dials Column is also steeped in occult significance. The Fire of London Monument, at a massive height of 202 feet, is the tallest free-standing stone column in the world. At over 130 feet, the Duke of York column is another colossus. Temple Church is dedicated to the Knights Templar, precursor to the Freemasons, while its column is supposed to mark the spot where the Great Fire of London (1666) was finally extinguished.

The photos overleaf will give the reader a better idea of the magnitude and stature of these buildings and monuments. Given that they went to such lengths to construct this asterism, we may safely conclude that *Canis Major* and Sirius itself are especially significant to the Illuminati.

## Sirius

The key element is Sirius, the brightest star in the night sky and the star most esteemed in ancient Egyptian mythology. It is the famous “dog star.” As such it represents the savage dog that Nimrod used for hunting and killing both animals and men. Nimrod himself, as the Bible tells us, was the first great rebel in the post-Diluvian era, a ruthless leader who defied the will of God and tried to establish a system of world government. In the eyes of the Illuminati – the Babylonians of our modern era – the coming Antichrist will be the ultimate embodiment of Nimrod and his ideals.






Sirius was greatly prized by all Egyptians – royalty, military, the priesthood, and the common people – since its appearance above the horizon at dawn marked both the start of the Egyptian New Year and the commencement of the annual Nile inundation.

This theme – appearing above the horizon at dawn – is embodied in the occult architecture of London, the City of the Sun. As we demonstrated in #56 (see chapter 15), the Asherim of London are arranged by reference to a set of circles spread across the city, each with an obelisk at its center. All of these circles have the same radius, namely 3,111 feet (This may be why the Fire of London Monument has exactly 311 steps). Since they all have the same radius, they inscribe a right-angled triangle – which is ‘sacred’ in the iconography of Freemasonry – whose hypotenuse is in all cases 4,399 feet long. That number is highly significant in the numerology of Babylon since its factors are 666 x 6.606.

Sirius itself was closely associated with both Isis and Osiris, and seemingly was deemed almost as potent in the night sky as the sun in the daytime. In esoteric terms, therefore, the earthly ‘representative’ of Sirius, the Fire of London Monument, must in some way express the notion of deity. In order to see how this concept is handled in Freemasonry, we turn to what many Masons regard as their ‘scripture,’ the work known as *Morals and Dogma of the Ancient and Accepted Scottish Rite of Freemasonry* (1871) by Albert Pike.

Perhaps more than any other Masonic writer, Pike reveals the extent to which Freemasonry is rooted in Kabbalah, the system of magic acquired and developed by apostate Jews based in Babylon around the time of the Captivity and later codified by various Cabalist mystics. It explained creation as a process involving 10 ‘divine numbers’ or ciphers, the 22 letters of the Hebrew alphabet and, as Pike notes, “a triangle, a circle, and a square.” He goes on to say that, “All truly dogmatic religions have issued from the Kabbalah and return to it: everything scientific and grand in the religious dreams of all the illuminati, Jacob Boehme, Swedenborg, Saint-Martin, and others, is borrowed from the Kabbalah; **all the Masonic associations owe to it their Secrets and their Symbols.**” (*Morals and Dogma*)

The esoteric circles which determine the placement of the *Asherim* of London would appear to correspond to the various “spheres” or Sephiroth in the Kabbalah Tree of Life. The highest sphere is called Kether or “Crown.” Above the Crown is Ain Soph or “Endless Light,” the Godhead itself, of which nothing can be said. Thus Kether or Crown, the first emanation of God, is the one from which the whole of creation derives, the primordial source.

The following quotation from Pike describes the ultimate Babylonian conception of Deity:

The Cause of Causes made ten Numerations, and called the Source of Spring KETHER, Corona, the Crown, in which the idea of circularity is involved, for there is no end to the out-flow of Light; and therefore He called this, like Himself, endless; for this also, like Him, has no similitude or configuration, nor hath it any vessel or receptacle wherein it may be contained, or by means whereof any possible cognizance can be had of it.

From the chapter on the 28<sup>th</sup> Degree (p.485)

The “Corona” or Crown is a source or spring of creative Light, uncontainable and endless. The Corona is the “Cause of Causes,” the foundation of being. Pike virtually identifies it with Ain Soph when he says, “...the CROWN...is the Throne of the Infinite, that is, its first and highest Seat, than which none is higher, and because Ain Soph resides and is concealed therein: hence it rejoices in the same name.” (p.480)

If one were to represent this Corona, this radiant Sphere of perfect Light, in a physical form, it might look like this:




And where do we find this Corona? On top of the Fire of London Monument:


The Fire of London Monument was erected in 1677, so the answer to this question must lie in decisions taken in more recent times.

In our last paper (#231) we referred to the Opening Ceremony at the 2012 Olympics in London. As an occult extravaganza brimming with Illuminati symbolism, it was designed to celebrate – in a disguised way – the coming New World Order. The Closing Ceremony ended with a fiery Phoenix, symbol of the New World Order, hovering above a partially submerged sphere from which flames were projecting. The five rings of the Olympic logo in the photo below – circles of equal size set in a blazing star – were possibly a reference to the Tree of Life.

## **CONCLUSION**


### Excess Mortality in 19 EU countries 2017-2020





#### ***Covid-19: “Staggering number” of extra deaths in community is not explained by covid-19***

Only a third of the excess deaths seen in the community in England and Wales can be explained by covid-19, new data have shown.

The Office for National Statistics (ONS) data, which cover deaths in hospitals, care homes, private homes, hospices, and elsewhere, show that 6035 people died as a result of suspected or confirmed covid-19 infection in England and Wales in the week ending 1 May 2020 (where deaths were registered up to 9 May), a decline of 2202 from the previous week.

Although the number of deaths in care homes has fallen for the second week in a row, more covid related deaths are being reported in care homes than in hospitals and are tailing off more slowly.

However, David Spiegelhalter, chair of the Winton Centre for Risk and Evidence Communication at the University of Cambridge, said that covid-19 did not explain the high number of deaths taking place in the community.

At a briefing hosted by the Science Media Centre on 12 May he explained that, over the past five weeks, care homes and other community settings had had to deal with a “staggering burden” of 30 000 more deaths than would normally be expected, as patients were moved out of hospitals that were anticipating high demand for beds.

Of those 30 000, only 10 000 have had covid-19 specified on the death certificate. While Spiegelhalter acknowledged that some of these “excess deaths” might be the result of underdiagnosis, “the huge number of unexplained extra deaths in homes and care homes is extraordinary... this rise in non-covid extra deaths outside the hospital is something I hope will be given really severe attention.”

He added that many of these deaths would be among people “who may well have lived longer if they had managed to get to hospital.”

### **Underlying causes**

David Leon, professor of epidemiology at the London School of Hygiene & Tropical Medicine, agreed. “Some of these deaths may not have occurred if people had got to hospital,” he said. “How many is unclear. This issue needs urgent attention, and steps taken to ensure that those who would benefit from hospital treatment and care for other conditions can get it.”

Also at the briefing was Jason Oke, senior statistician at the Nuffield Department of Primary Care Health Sciences at the University of Oxford, who explained that equivalent data on excess deaths in Scotland were classified by the underlying cause of death—including dementia, as well as circulatory, cancer, and respiratory causes. In the first week after lockdown a spike in deaths occurred from all causes, but “we now have a return to normality for all except dementia,” he explained. He called for the ONS to report on excess deaths in a similar way.

Responding to the latest figures, Jennifer Dixon, chief executive of the Health Foundation think tank, said, “Today’s data show that action to tackle the coronavirus pandemic in social care has been late and inadequate, and has highlighted significant weaknesses in the social care system due to decades of neglect and lack of reform. Covid-19 has ultimately magnified the human impact of decades of underfunding in the sector and policy neglect.”

In total, England and Wales have recorded 34 978 covid-19 deaths from 28 December 2019 to 9 May this year. More than 22 600 of the deaths occurred in hospitals and 7400 in care homes.
