

The False Nephilim Theory is Designed to Cause Confusion

Satan is preparing a similar deception for mankind, but it will be cruel and humorless. The shock he has in store will cause most of the population of the earth to drastically revise their understanding of reality. Their basic religious beliefs will be ripped from their moorings as news of an alien invasion spreads across the earth.

Ample evidence


We have seen ample evidence that a great deception of this magnitude is being prepared. Countless movies, TV shows, books and magazines have conditioned the masses to believe that “something like this” could actually happen. In addition, we are being treated to regular news reports of bizarre UFO sightings and encounters, as well as unusual phenomena which many “experts” claim may be due to extra-terrestrial activity.

Former military personnel come forward as “whistleblowers” from time to time, alleging that the US government is withholding from public scrutiny the ample evidence in its possession which proves beyond doubt that ETs and UFOs exist. Recently yet another of these “whistleblowers” came forward, claiming that actual spacecraft fragments had been retrieved, as well as intact vehicles. He said that US defense contractors had determined that, based on their unique atomic structure and other physical features, the parts were designed by a “non-human intelligence.”

The individual concerned represented the National Reconnaissance Office on the Unidentified Aerial Phenomena Task Force from 2019-2021 and later represented the National Geospatial-Intelligence Agency on the same task force.

His statements, which were supported by documentation, were made on-the-record before Congress in April 2023 and were cleared for open publication.


This alone should tell us that his testimony is part of the long planned alien disclosure. If he was genuinely releasing highly sensitive information, with obvious implications for national security, Congress would not have authorized its release.



ETs, UFOs, and a new term – UAPs

In order to make the subject matter sound less repetitive, the term ‘UFO’ (‘unidentified flying object’) has been replaced by UAP – ‘unidentified anomalous phenomenon’. Clearly, NASA and the various intelligence agencies want the public to start thinking in a new way about UFOs (now UAPs) and to set aside any lingering scepticism.

While the UFO phenomenon has received considerable attention for decades, it was not until 2014 that a reputable and seemingly impartial international institution invited the public to set aside their doubts and seriously consider the possibility that UFOs might be real after all.



The Jesuits take center stage

The endorsement in question issued from the Jesuits, with informal approval from the Vatican. The Pope had conveniently asked the seminal question during a homily which he gave a few months before the book appeared, thereby giving the authors a degree of legitimacy.

Since we have already examined this book – *Would You Baptize an Extraterrestrial?* – in an earlier paper (#62), we will look only at those passages which give a vivid depiction of the psychological shock which the Elite intend to deliver by this means, namely a worldwide ET invasion hoax.


Taking 'Christianity' as their starting point, they ask whether an enlightened ET would even want to be a Christian:

"So far we've been assuming that ET would *want* to be Christian and would *want* to be baptized – we've been assuming that Christianity is a club that ET would want to join." [p.264]

The flippancy here is jaw-dropping. The redemption of mankind through the blood of Christ is reduced to little more than a principle of social organization. Christians are simply members of a "club" that the visiting ETs will be invited to join.

The same condescending attitude to Biblical truth may be found throughout the book. The incredible sacrifice that Christ willingly made to redeem us from the fire of God's righteous wrath is completely ignored. The gospel of salvation is not explained anywhere, nor is its importance even acknowledged. Instead baptism, which in the Catholic Church means infant baptism, becomes the magic card that allows one to join the club. They even described Christianity as a "social structure":

"Christianity is a big social structure that has no choice but to depend on and make use of the language and concepts of science..." [p.148]



The Jesuit authors then take another speculative leap and postulate the possibility that the ETs may actually have a club of their own, a club that is just as acceptable in God's eyes as the 'Christian' club found here on earth. What is more, we might be so impressed by their "recognizably Christ-like" nature that we may feel a deep urge to be baptized or initiated into *their* club:

"As a Jesuit who is inclined to "find God in all things," I am thrilled when I find God somehow already present in unexpected places...But how should I respond when the shoe is on the other foot – when it is ET who is surprised and thrilled to find God somehow already present in me?" [p.269]

"To put it more simply: If we encountered an alien culture, and we recognized that something recognizably Christ-like was somehow already present there, should we be willing to enter into that culture's rite of initiation? Should we allow ourselves to be baptized by an alien?" [p.269]

A grotesque perversion of the Gospel

They even spell out the bizarre implications of what they are proposing, namely that Christianity will come to be seen as a quaint relic left over from early life on planet Earth and that "the ultimate unity of truth" will reveal a pan-cosmic, inter-stellar religion that embraces all lesser expressions of truth. Man will stand beside "friendly and enlightened" ETs and "smile benignly on Christianity and baptism," knowing that they were nothing more than "native customs" in the great plan of cosmic evolution:

"We could join with friendly and enlightened ETs in smiling benignly on Christianity and baptism, seeing them as amusing native customs that happen to be meaningful and important to some of the locals here on planet Earth, and give up on the quaint belief that the God of the whole universe decided that Earth was something special and took up residence here in human form." [p.283]

This is a grotesque perversion of the Gospel and a deliberate mockery of the most fundamental Christian doctrine, namely, that Jesus Christ was the incarnate Son of God. This glorious truth is dismissed as a "quaint belief." Christianity itself is scornfully portrayed as an "amusing native custom." The passage also makes forceful use of the Heliocentric Lie which reduces earth to a mere speck in the black depths of 'outer space.'



The Carl Sagan Medal was awarded to Jesuit priest, Guy Consolmagno in 2014, presumably as a reward for co-authoring *Would You Baptize an Extraterrestrial?* It was a very public endorsement of his work by the architects of the coming New World Order.

Note how the obverse celebrates "the host of heaven," which the Word of God expressly forbids:

**"And hath gone and served other gods, and worshipped them, either the sun, or moon, or any of the host of heaven, which I have not commanded"
(Deuteronomy 17:3)**

Satanists dismiss Christianity as a “quaint belief”

For anyone who doubts the poisonous implications of the Nephilim theory, in particular the way it supports the coming UFO deception, the statements by these Jesuits – on behalf of the Vatican and the New World Order – should be a loud and painful wake-up call.


The Satanists who control the wealth of this world, courtesy of their demonic master, are determined to crush Christianity, to dismiss it as a “quaint belief”, and replace it with a cosmic, neo-pagan religion that embraces all lesser expressions of truth.


We have already addressed the Ancient Alien hypothesis in a number of our previous papers, including papers exposing the Outer Space/Big Bang model of Creation. All of these false teachings work together to produce the counterfeit reality that Satan needs to execute his great End Time deception.

This is why the Enemy continues to taunt Bible-believing Christians with the Nephilim theory. It sounds ‘biblical’ and appears to explain certain passages in the Bible which the critics claim are poorly understood. It is important, therefore, that Christians become familiar the Nephilim hypothesis and why the arguments on which it is based are seriously flawed.

A Nephilim case study

For this purpose we have chosen a case in support of the Nephilim theory which is both concise and passionate. It is set out in a book published in 2018 by authors Steven Bancarz and Josh Peck, both of whom profess to have been deeply involved in the New Age before converting to Christianity. The book is called ***The Second Coming of the New Age***. Its subtitle is *The hidden dangers of alternative spirituality in contemporary America and its churches*. The Foreword was written by Michael Heiser, a well-known champion of the Nephilim hypothesis.





***Ancient Aliens* is a television series which first aired in 2010 and has been running ever since. To date it comprises over 230 episodes. Remarkably it has aired continuously on the History Channel, as though it dealt with authentic historical material.**

The series refers over and over to the supposed role of ETs and UFOs in the production of ancient archeological structures and artefacts. It is heavily influenced by the writings of Erich von Daniken, Zecharia Sitchin, Graham Hancock, Charles Hapgood, and the psychic Edgar Cayce. The claims are often outlandish and have no scientific basis but they are "supported" by endless innuendo, speculative arguments, eccentric theories, and illogical conclusions. The viewer is led to believe that the images streaming across the screen offer legitimate "evidence" of the claims made by the narrator.

The *Ancient Aliens* series is nothing but propaganda for the New World Order, where science fiction, mythology and hoary fables are presented in a documentary format on a channel which purports to deal only with proven historical facts.



As former New Agers who know how to skilfully debunk the many false doctrines taught by Gnostics and Neo-pagans, Bancarz & Peck should have been able to untangle the patent fallacies behind the Nephilim theory. Instead they leap to its defense and dismiss the sceptics as narrow-minded fuddy-duddies who “twist the meaning of the Scriptures” in order to propound what we know as the Sethite theory:

“To make the Sethite theory fit, we would have to twist the meaning of the Scriptures, even in the original Hebrew, that define angels (Job 38:4-7), giants (Genesis 6:2-4), and man (Genesis 6:1-7). The Sethite theory just does not add up when it is compared to the rest of the Bible without completely rewriting the Scriptures themselves. This is dangerous because it keeps the believer away from the truth.” – *Bancarz & Peck* [p.283]

That’s a very strong statement indeed! According to these authors the position we outlined in our papers #49 and #125 – see below – cannot possibly be correct.



We would encourage our readers to re-read #125 since it explains in detail why the Book of Enoch, which is the most cited source in support of the Nephilim theory, is misleading and unreliable on every level.

It will be helpful at this point to summarize the two positions:

The Nephilim Theory


Proponents of this theory hold a variety of opinions regarding the details, but the theory as a whole usually includes the following elements:

The beings described as *Nephilim* in Genesis chapter 6 were powerful giants, the physical offspring produced by sexual intercourse between human women and the group of rebellious angels mentioned in Jude 1:4-5 and 2 Peter 2:4-5. They caused havoc on earth, engaging in the wholesale genetic manipulation of countless species and killing large numbers of righteous men. Eventually their depravity reached the point where God decided to wipe them all out in the Flood. Only the bloodline of Noah and his family was unaffected by this pollution of the human gene pool. After death the Nephilim had no place to go. Their spirits roamed the earth seeking humans whom they could possess and use as surrogate forms of habitation.

The Sethite Theory

The immediate descendants of Adam and Eve divided into two groups, the sons of Seth and the sons of Cain. The Sethites feared God and sought to follow the path of redemption which was taught to them by Adam. The Cainites, on the other hand, remained in rebellion against God and struggled to assert their authority on earth. Instead of keeping separate from the Cainites, as they had done initially, the Sethites were lured into inter-marriage with them. As a result the pure line of Seth began to decay. Satan ensured that the offspring of these marriages were unusually successful – becoming mighty men or *Nephilim* – and thus perpetuated the wicked practise of inter-marriage. The wickedness on earth increased to the point where God decided to destroy all of mankind in the Flood. The eight people he preserved in the Ark were descended from families which had no involvement with the Cainites.

We'll now look at how Bancarz & Peck try to refute the Sethite interpretation of Scripture. We could deal extensively with each of their points but, since we have already covered the ground in detail in previous papers, we will confine ourselves to just a few salient observations in each case.



Giants


“The word “giants” is translated from the Hebrew word *nepil*, meaning “bully” or “tyrant,” which comes from the word *napal*, meaning “to fall.” Isaiah 14:12 uses the same word, *napal*, for our English word “fallen” to describe Satan. A common word used today for these fallen tyrants, or giants, is Nephilim. The New International Version Bible refers to these beings as Nephilim, whereas the King James Version refers to them as “giants.” In our modern vernacular, the word is the most common and recognizable word referring to the giant offspring of the fallen angels and human women.” – *Bancarz & Peck* [p.284]

The pair tumble headlong into a well-known logical fallacy. They set out to prove that the word Nephilim means “giants” but only get as far as “bully” or “tyrant”. They assume it had to include the key attribute “giant” because the most dangerous bullies and tyrants in ancient times must have been giants. The whole theory leans heavily on sloppy, disingenuous reasoning of this kind.

Hybrids

“Interestingly, the definition of *napal*, “to fall,” can also mean “cast down, die, fall, fallen, inferior, be lost, perish, rot, throw down,” among others. The Nephilim were fallen, inferior, and lost beings that perished with no hope of salvation. They were not fallen in the sense that the angels who created them were fallen. The angels once had a high estate in Heaven, but disobeyed God and then became fallen. The Nephilim, on the other hand, were fallen right from the start. They were not men created with a hope of redemption. They were born fallen. In a spiritual sense, they were dead upon creation.” – *Bancarz & Peck* [p.284]

In this passage the authors argue that the Nephilim were born with no hope of redemption. If readers accept this assertion, then they have already assumed that the fathers were fallen angels. This does not constitute proof that the Nephilim were angel-human hybrids but, by portraying them as beings of the most wicked kind, readers are drawn to the view that they must have been generated by fallen angels. This is why their name is derived from the Hebrew word *napal*, meaning “to fall.” Once again we find the most spurious connections being made between statements in the Bible and speculative theories of the *Ancient Aliens* variety. So far the authors have offered absolutely no evidence that angels mated with human women and produced hybrid giants!




Demons

“If the Nephilims’ souls did not have the ability to have eternal life and were dead upon creation, what would happen to their souls when they died? It is possible that what we know today as “demons” are the disembodied spirits of the dead Nephilim. If the souls and spirits of the Nephilim were not created by God and could not achieve eternal life, there would be nowhere else to go when they died...This would suggest that the dead Nephilim would be cursed to remain on the Earth until the Judgment. They would be what we refer to today as “demons.”...This shows that demons and fallen angels are different altogether.”

– Bancarz & Peck [p.284-285]

Here the pair indulge in a classic bait-and-switch. The reader expects to be given further proof that angels mated with humans to produce giant physical hybrids, but instead he is asked to speculate on the fate of these hybrids after they die. In order to follow this speculative line of reasoning he must accept, if only hypothetically, that the Nephilim were real historical entities.

He is then offered a tantalising tidbit, the notion that demons must be the spirits of dead Nephilim, which would explain why demons are so keen to possess humans. This too is idle speculation but cunningly framed to fit the Nephilim theory. After all we know that demons *do* exist and that they *do* seek to possess humans. Therefore the Nephilim theory must be true. This is the kind of hop-skip-and-jump ‘exegesis’ that proponents of the Nephilim theory often use to distract readers from the plain fact that Scripture simply does not say what they are trying to make it say.



Fallen angels

“It is well documented in the Bible that demons (or devils, unclean spirits, etc) like to possess people and taken control of their physical bodies if they can. Fallen angels, on the other hand, have a type of body that is far superior to our human bodies... This seems to mean that fallen angels have no immediate need for a physical human body... If demons are the disembodied spirits of the Nephilim, it explains why they would want to possess humans in the first place.” – *Bancarz & Peck* [p.285]

Here they try to reinforce the notion that the fallen angels could not possibly have any interest in possessing or inhabiting human bodies since their own bodies are “far superior.” In saying this they are ignoring the fact that the fallen angels will retain their bodies into eternity and that their interaction with humanity could not entail a loss of their angelic substance. The Bible clearly teaches that their aspiration to control or “possess” a living person is motivated by a desire to harm their victims and, if possible, to lure them into the abyss which God has prepared for all of the fallen angels.

It is sometimes argued that Scripture never confirms that the demons expelled by Jesus and his disciples were fallen angels, but this is not so. We are told on a few occasions that Jesus ordered the demons he was expelling to remain silent and not to call out his name. Consider, for example:

“And there was in their synagogue a man with an unclean spirit; and he cried out, saying, Let us alone; what have we to do with thee, thou Jesus of Nazareth? art thou come to destroy us? I know thee who thou art, the Holy One of God. And Jesus rebuked him, saying, Hold thy peace, and come out of him.” (Mark 1:23-25)

And devils also came out of many, crying out, and saying, Thou art Christ the Son of God. And he rebuking them suffered them not to speak: for they knew that he was Christ. (Luke 4:41)

How did the demons *know* that Jesus was Christ, the Holy One of God? Because they had seen him in heaven. The spirits of dead Nephilim, on the other hand, which these authors allege were the demon entities in question, would have had no idea who Jesus was!

Angelic attachments in Freemasonry

We should bear in mind, also, that members of esoteric societies, having made a compact or agreement with Lucifer through oaths, rituals and initiations, actually want to be connected or “attached” in some way to powerful angelic beings, not Nephilim hybrids. They hope by this means to obtain wealth, power and influence here on earth. Such people seldom exhibit the outer disturbances that we normally associate with spirit possession.

Here is how Charles Leadbeater, an associate of Helena Blavatsky, described the role of these so-called angelic attachments in Freemasonry:


“In Freemasonry also we invoke angelic aid, but those upon whom we call are nearer to our own level in development and intelligence, and each of them brings with him a number of subordinates who carry out his directions.”

“We must consider heedfully the relation with the Angelic kingdom into which these higher Degrees bring us, for it is a matter of the utmost importance. At the moment of his Perfecting, there is attached to the Sovereign Prince of the Rose-Croix [seemingly the 18°] a splendid crimson Angel – a Being of beauty, dignity and power beyond the utmost stretch of our imagination.”

“The 33° gives two such splendid fellow-workers – Spirits of gigantic size as compared to humanity, and radiantly white in colour... They are splendid beyond all words, and radiant with living love, though most of all they convey a sense of irresistible, though benevolent, power...”

**– C W Leadbeater, *The Hidden Life in Freemasonry*,
*The Theosophical Publishing House, 1926***

The fallen angels will deceive their victims for decades if necessary, luring them on with false promises and mystical lies, appearing all the while to “serve” them when, in reality, they are engineering their spiritual destruction.



Angelic ‘marriage’

“This verse [Matthew 22:30] is sometimes used to say that all angels in existence have never and will never take part in marriage. Such a statement is a mistake and a misinterpretation. This verse explains an attribute of only “the angels of God in heaven” – not of every angel. The angels that took part in the unholy union with human women [Genesis 6] are not angels of God nor do they reside in Heaven anymore. The angels in Heaven have never committed this terrible sin. In ages past, when certain angels decided to marry women and have children, they fell from Heaven and thus became what we refer to as “fallen angels.” We can read more about this in Jude 1:6-8.”

– *Bancarz & Peck* [p.286]

Once again the authors are assuming that their Nephilim theory is correct and therefore the traditional interpretation of Scripture must be wrong. In Matthew 22:30 Jesus states:

“For in the resurrection they neither marry, nor are given in marriage, but are as the angels of God in heaven.”

They argue that, when Jesus included the words, “**in heaven**”, he was referring only to the holy angels, but this is defective reasoning. The war in heaven in Revelation 12:7 is proof that the fallen angels continue to have access to part of heaven. Revelation 12:8 confirms this when, following their expulsion from heaven in this war, it states: “**...neither was their place found any more in heaven.**” If they had “**a place**” in heaven then Matthew 22:30 applies to them also.

In short, angels do not marry and never married at any time in the past. They had no need for marriage since they were all created by God at the same instant in time. No angels have been created subsequent to that amazing event. They do not possess a means of reproduction and are therefore unable to mate with one another or with human women.

‘Physical’ angels

[Referring to Jude 1:6-8] “It is possible that the fallen angels not only forsook God and Heaven, but also forsook their heavenly spiritual bodies for a type of physical body they could use to operate within our physical dimension... the fallen angels were fornicating with flesh that was different from their own, meaning humans. There are a lot of theories of how this could be possible, but apparently the fallen angels have some sort of physical bodies at their disposal.”

– *Bancarz & Peck* [p.288]

This, too, is fallacious. The instances in the Bible where holy angels appeared to men cannot be taken as evidence that they possessed a physical body. Jesus did not incarnate in a human body until he was conceived in the womb and brought forth at birth in a stable in Bethlehem. The ‘body’ he possessed when he came to Abraham in the plain of Mamre was a simulation. He could eat and drink through this simulation but he was not a physically incarnated human being. This is why Bible scholars have called him “the Pre-incarnate Christ.” The two angels who were with him possessed similar bodies.

The Word of God clearly states that angels are created spirits (Psalm 104:4 and Hebrews 1:7). When they were sent on a mission by God to interact with mankind, they were divinely enabled to do so. Fallen angels do not possess this ability to simulate human flesh. If they did, they would have gone on the rampage long ago and destroyed all life on earth.




Abraham looking toward Sodom, Gomorrah, and the cities of the plain after the LORD God destroyed them.

Soul vehicle

“This can make sense when we think of what we are. Humans are really spiritual beings, soul and spirit, that have been put into physical bodies so we can operate within physical reality. Our physical bodies are a type of vehicle for our souls and spirits to exist as intended within this dimension. It make sense that if another type of spiritual being, like an angel, wanted to operate in our physical dimension, he would need a type of physical body, too. This body would be different from ours, as we were created lower than the angels (Hebrews 2:7). The angel’s body would be more powerful and able to do things that the human body cannot. The “flesh” of the angel’s body would be different from human flesh.”

– *Bancarz & Peck* [p.288]

The idea here is straight from the New Age. The Gnostics have long taught that the physical body is merely a vehicle for the soul. As the authors state, it is seen as an accessory that our soul needs “to operate in our physical dimension.” The occult doctrine of reincarnation rests on the principle that the physical body is only a temporary “covering” and that the transmigrating soul can successively occupy a long series of such coverings on its supposed journey toward god-realization.



This is not Biblical. Humans are tripartite beings, consisting of a physical body, a human soul, and a human spirit. We have no idea how these three work together to express our humanity, but they do. Our body is more than a vehicle for the soul. Since we are made in the image and likeness of God, it is intrinsic to who we are. This is why Jesus will raise believers on the last day, providing each with an immortalized physical body.

Unlike angels, we are not complete in the eyes of God without our physical body:

**“For he is not a God of the dead, but of the living:
for all live unto him.” (Luke 20:38)**

Noah and his “generations”

“In Jude, we learned that the fallen angels corrupted the human flesh by mating with them. It seems that Genesis 6:9 [“**Noah was a just man and perfect in his generations**”] is telling us that Noah and his descendants were the only people in the world who were completely uncorrupted. The rest of the world had been corrupted by mating with fallen angels and the Nephilim. Noah’s entire bloodline, beginning with Adam, was completely pure and perfect, meaning that no one had ever mated with a fallen angel or Nephilim.” – *Bancarz & Peck* [p.289]

The corruption of the world before the Flood was spiritual, not physical:

**“And GOD saw that the wickedness of man was great in the earth,
and that every imagination of the thoughts of his heart
was only evil continually.” (Genesis 6:5)**

Why do Nephilim theorists twist this verse? It is not speaking of a physical disposition, and certainly not a process of genetic deterioration. Wickedness is SPIRITUAL, not physical. The Word of God is telling us that man’s heart was corrupt, that it was filled continually with evil thoughts spawned by his wicked imagination.

Noah was perfect in his generations because neither he nor his antecedents had gone down the Cainite path or intermarried with any of them. He had never learned their ways nor been exposed to their rebellious attitude. Since he had kept his heart pure, the LORD described him as “**a just man.**”

The ‘new’ Nephilim

“We know there was an original influx of Nephilim before the worldwide Flood destroyed them all. Is it possible there will be another influx of Nephilim and, if so, could we possibly be seeing it within our lifetime? This has been the focus of much study in the field of Bible prophecy, though opinions are split on the issue.”

– Bancarz & Peck [p.290]


We can now see where all of this is leading. They want us to believe that, if it happened before, it can happen again. The Nephilim theory is really a clever way of trying to manipulate the interpretation of End Time prophecy.

This is why so many ‘Prophecy Conferences’ – which claim to be Biblical – give credence to the Nephilim theory and preach about it continually. Christians who fail to test everything against the unbending standard of God’s Word are easily deceived by the many false and misleading assertions made by speakers at these conferences. Why watch *Ancient Aliens* when you can go along and listen to Tom Horn and L A Marzulli, plus a host of others, as they plough the same field on behalf of the New World Order? These men are playing fast and loose with God’s Word, brazenly bending it in whatever direction they choose, and drawing on the fables found in *The Book of Enoch* to generate their own End Time theology.


CONCLUSION

Satan is a fearmonger and much of the fear he generates is based on deception. Significant advances in media technology have greatly expanded the potential for inducing anxiety, uncertainty, and a pervading sense of insecurity among the general population.

Until about 1900 governments were always viewed with suspicion. The people knew from hard experience how quickly and how easily they passed laws to exploit the weak and enslave the vulnerable. However, since 1900 or thereabouts, governments have greatly improved their image. They have convinced the masses, especially in the West, that they serve the people and that, despite their many flaws and shortcomings, they work only for the betterment of society. The increased use of welfare, along with a constant stream of positive coverage in the media, has made this possible.



As we have demonstrated in many of our papers, this is a grievous misconception. Governments are as venal and exploitative today as they ever were. They also co-operate with one another in ways we have never seen before. This second characteristic should have set off alarm bells, but it appears to have had the opposite effect. The public assumes that increased international co-operation will mean greater political stability, fewer wars, reduced social tension, and greater economic benefits for everyone. A political theorist, Francis Fukuyama, even published a bestseller in 1992 called, *The End of History and the Last Man*, which was based on the premise that mankind had finally come of age and that, henceforth, the rational management of society on an international scale would ensure perpetual peace and prosperity for all.



God in His Mercy allowed us to see, via the Covid hoax, that all governments are now working together to increase their control over all sovereign states. One didn't need to be an astute observer of human behavior to see that the simultaneous shut-down of all nations in March 2020 was a carefully planned event. State coercion and social control reached a level never seen before in peacetime. Immense harm was inflicted on millions of people in response to a grossly exaggerated health threat, with much the same rules, the same procedures and the same pseudo-scientific explanations being applied everywhere. Never before had so many nations co-operated in this way, despite the fact that the measures they were imposing were highly controversial, potentially harmful, and entirely unjustified in medical terms.

The hoax worked so well that the masterminds behind it appear to be planning a similar one, where vaccinations will be mandatory and dissidents will be jailed.

The approaching End Time ET/UFO Deception

The Nephilim theory will be part of yet another hoax, where billions of people will be told that the earth has been invaded by aliens from outer space. The deception – if the Illuminati actually attempt it, which seems almost certain – will likely shake the foundations of all religions and cause vast numbers to adopt the New Age cosmic ideology.

The masses have already been heavily conditioned to believe this lie. Furthermore, the Nephilim theory will have prepared millions of professing Christians – an important target group – to believe everything they are told once the hoax gets rolling. These in turn will draw in many more who are still sitting on the sidelines.



Most of the so-called *Prophecy Conferences* over the past twenty years or more have been teaching Christians to believe the fables in the Book of Enoch. They now have an understanding of End Time prophecy which is sharply at variance with what we are told in the Word of God. This may explain why so many no longer believe in a Pre-Tribulation Rapture. If it were true, they figure, then the Book of Enoch would have mentioned it.

The Nephilim Theory (NT) is dangerous for many reasons. We cover much of this in our previous papers, in particular #125 (***The Book of Enoch is a Dangerous Demonic Snare***). Here is just a short list of the ways it misleads the unwary and distorts the Word of God:

1. The NT takes attention off the innate wickedness of man in his fallen condition. *The Flood was the method that God used to cleanse the earth of defective genetic material. If that dangerous group of fallen angels had not misbehaved, there would have been no need for the Flood.* Thus the sinfulness of sin is trivialized.

2. In many versions the NT teaches that an unspecified proportion of mankind today is still polluted by the Nephilim seed. This leaves room for the development of a genetic test in the coming years which will purport to identify these *Untermenschen*. The ‘clean’ sectors of society will be urged to deal with this defective group, perhaps via mass sterilization or genocide.
3. The NT ostensibly provides a Biblical framework for an End Time scenario involving ETs and UFOs. Thus the people best equipped to discern and reject the ET invasion hoax, namely professing Christians who claim to be Bible-literate, may prove to be its most ardent advocates.
4. The NT allows for the possibility that secret technology existed in ancient times, developed by the Nephilim, which continued to be employed after the Flood. The Enemy is already using this hypothesis to detract from the miracles of Jesus and other Biblical figures. It is argued instead that advanced technology, unknown to the masses, had enabled these seemingly miraculous healings and similar activities to be performed.
5. The NT is a Gnostic doctrine based on an interdimensional model of Creation, or “planes” of existence, where “higher beings” – those who possess the Gnosis or secret knowledge – are able to travel back and forth between these dimensions. The Jesuit book by Consolmagno and Mueller explicitly alludes to the existence of this knowledge, where ETs from a higher dimension arrive on earth and teach a Cosmic philosophy which far transcends the primitive truths taught by earthly religions, including Christianity.

We could cite many more. The NT is like the Joker in a pack of cards, making capricious and unpredictable changes the moment it is played. Just about every aspect of Biblical theology can be pulled out of shape and made to seem inadequate or defective by the admission of this theory in one of its many forms.

We would urge Christians everywhere to weigh this issue carefully and satisfy themselves that the case we are making is soundly based.
