

The Open Persecution of Christians in Ireland is About to Commence




Brownshirts marching in Nuremberg, 1929

The old *Catholic Encyclopedia* gave a bitter assessment of the Penal Laws in Ireland in the 18th century: “The law presumed every Catholic to be faithless, disloyal, and untruthful, assumed him to exist only to be punished, and the ingenuity of the Legislature was exhausted in discovering new methods of repression.”

These oppressive laws, which were aimed primarily at Catholics, imposed severe restrictions on employment, education, religious practise, and ownership of land and property. Catholics were not allowed to vote and any public expression of dissent could result in a beating by local law enforcement or the landed gentry. The Crown aimed by this means to produce a populace that was impoverished, illiterate, and submissive. The servile and downtrodden masses were forced to adjust to their servitude and survive as best they could. Their resources were so meagre and their strength so depleted that, when the Great Famine struck in 1845, it wiped out 12 percent of the population and forced more than twice that number to emigrate.

The Crown never lost its grip on the country. When Independence came in 1922 the same hidden hand continued to exploit the 'liberated' nation, starving it of capital and using it as a source of cheap labor and agricultural produce. Economic development in Ireland between 1930 and 1960 was virtually at a standstill and emigration was abnormally high for most of the period.




The puppet regime in Leinster House

The Crown continues to run Ireland today through its puppet regime in Leinster House. The politicians pretend to operate along conventional party lines but for the past 25 years they have pushed nothing but corporatism and the cynical Marxist ideology of the New World Order. The drive to mock and deride Biblical values is common to all parties, and policies aimed directly at the destruction of 'old Ireland' and its traditional Christian ethos are routinely approved by both Houses. Even where highly controversial legislation is debated, contributors take care never to offer serious factual rebuttals of the irrational, and frequently absurd, arguments put by the government. There is no Opposition in either House and even so-called moderate members shamefully avoid any reference to the Marxist nature of the agenda that the government is pursuing.

The grotesque absence of good faith at parliamentary level is ignored by the media. The national broadcasters and print moguls merrily peddle whatever propaganda the government and their corporate sponsors devise. The national 'debate' in 2015 on 'same sex marriage' was an artfully choreographed farce, while the moral catastrophe of 2018 has no historical precedent. Never in history has any country voted to murder a proportion of its own children. The rate is currently in the region of 10%, similar to levels of child mortality in the Great Famine. Of those who were eligible to vote in the Abortion Referendum only one person in five went to the polling station and voted 'No'.

A dumbed-down population

As difficult as it is to believe, the vast majority of the population is still not aware, nearly eight years after the event, that the Marxist magisterium in Leinster House approved a bill in 2015 which allowed any person over age 18 to ‘change’ their legal gender. There was no medical requirement of any kind or a need to submit written evidence of a distressing psychiatric condition. The same person could change it again a few years later if he or she so decided. What is more, the change would be incorporated into the official certificate of birth held by the General Register Office.



We made the above submission to the Department of Justice, Equality & Law Reform on 10 November 2019. The arguments set out in that submission should be considered alongside the views expressed in this paper.

We see in this roll-call of iniquity an infantile inability to question authority. Parents of children who had to wear face masks in the classroom for 5-7 hours a day during the Covid hoax, or who have been subjected to hours of school-approved LGBT propaganda, are unable to raise even faintly intelligent questions about government policy. When parents are indifferent to the threat that the state poses to the welfare of their children, we ought to be greatly concerned about the future intrusion by the government into the rights and liberties of ordinary people.

The Marxist program to date has been consistently anti-Christian. This is perfectly logical, of course, since the coming New World Order is intended to usher in the Antichrist. Thus Satan's little helpers are busy wrecking the repository of moral values which have sustained our island for over a millennium. From their vipers' nest in Leinster House they devise new ways to undermine our nation and feed it bit by bit to the globalists who control the World Economic Forum.

What would happen if the *peons* woke up?

The plan they are following was drafted by the Masonic ascendancy who run Britain. No doubt their Irish toadies are paid handsomely for passing laws which facilitate the progressive enslavement of the Irish people.

But what if, heaven forbid, a representative number of Irish citizens were to raise their hands and ask some pertinent questions about this poisonous agenda? 


Leinster House, seat of the Irish legislature, replete with Masonic obelisk.

We should hardly be surprised that a common solution to this potential problem has already been identified by the Masonic-Marxist cabal in London. In the old days, in Nazi Germany for instance, the prevailing power base consolidated control through the use of thuggery and intimidation. The Brownshirts or *Sturmabteilung* roamed the streets and viciously pummelled anyone suspected of harboring a critical opinion of the Nazi Party.

Some of their methods of intimidation were surprisingly effective. For example, anyone who failed to make the Nazi salute and proclaim “Heil Hitler!” – smartly and respectfully – had his teeth kicked in. It wasn’t long before everyone got the message. The entire clientele of a busy café would jump to attention and make the salute if even one Brownshirt appeared at the door and made it himself.

The Marxist cabal have modelled their solution on the Brownshirts. A group of ‘enforcers’ will be authorised by the state to intimidate anyone they suspect of harboring critical views of the ruling regime and its perverted moral agenda. The police will be obliged to treat their vexatious complaint as evidence that a crime has been committed and arraign the victim before the court to prove his or her innocence.

After the *Sturmabteilung* were eclipsed by the SS, the tan shirt, which was worn by the 8 million members of the Hitler Youth, continued to serve as an instrument of state intimidation.

Who are these enforcers? Well, under the proposed new law – the Criminal Justice (Incitement to Violence or Hatred and Hate Offences) Act – they will comprise every left-wing extremist, disaffected layabout, embittered homosexual, and deluded transgender – to name but a few! – who object to the views and opinions expressed by the victim. And have no doubt, he or she IS a victim. Their views will be deliberately misconstrued by the enforcers and presented to the court, under the law, as provocative expressions of hatred toward a given person or segment of society.

The then Minister for Justice, Helen McEntee, inadvertently revealed what the new Hate Speech legislation is really about! An astonishing faux pas. Anyone accused of ‘hate speech’ will be shut down, shut up, isolated and afraid to speak! That’s the whole idea. She was removed from her post four weeks later.

Under this wicked legislation the vast chasm between a moral opinion and a hateful act is entirely obliterated. Also, since the “crime” exists solely in the mind of the complainant, the presumption of innocence is also set aside. No member of law enforcement, in pursuance of his duties, could possibly have uncovered evidence that a “crime” had been committed. The evidence is entirely subjective, buried deep in the offended psyche of the complainant.

Any law of this kind is blatantly anti-Christian. The members of society who are most likely to express views that conflict with the perverse morality devised by the Marxists are those who ground their worldview in the Word of God. Under this type of legislation a pastor who preaches a sermon condemning abortion, sodomy, or the genital mutilation of children could be victimised for doing so. If the sermon is uploaded to the church website, which is a common practise, the complainant could describe it as hate speech aimed at a worldwide audience – and his or her “description” of this would be treated as evidence by the court!

Historians describe the *Brownshirts*

The law could be used in a co-ordinated way by the NGO goons who are funded by George Soros to launch a nationwide attack on a given denomination or religious group. It could also be used to intimidate, harass and oppress any person or group that dared to express anti-Marxist opinions via the Internet.

- (5) A person guilty of an offence under this section shall be liable—
- (a) on summary conviction, to a class A fine or imprisonment for a term not exceeding 12 months or both, or
 - (b) on conviction on indictment, to a fine or imprisonment for a term not exceeding 5 years or both.

**Penalties under the Act: A fine of up to €5000
and/or a prison sentence of up to 5 years.**

We are moving from the creeping persecution of Christianity which has characterised the Irish political agenda over the past 15 years or so to a much more overt form, where law-abiding Christians can be dragged before the courts for openly endorsing the moral and spiritual tenets of the Bible.

We have set out details of the Irish legislation in **Appendix A**. Read it and weep. This filthy violation of the freedom and dignity of Irish Christians is almost unreal in its arrogance. It proves, if proof is needed, that the architects of the coming ‘New World Order’ will stop at nothing to impose their totalitarian nightmare. Similar draft legislation is currently before the legislatures of several other countries, including (we understand) New Zealand, Australia, the Netherlands, Brazil, Canada, and the United States. The coming censorship of free speech, enforced by law and supplemented by draconian penalties, will be a co-ordinated worldwide phenomenon.

The proposed legislation also violates the Irish Constitution which, in its Preamble, expressly declares that its provisions are intended to be consistent with (“In the Name of”) the laws of God (“the Most Holy Trinity”) Whom its authors profess to be the final “authority” when determining the justice and morality of men and nation states (“*all actions both of men and States*”) -

*In the Name of the Most Holy Trinity, from Whom is
all authority and to Whom, as our final end, all
actions both of men and States must be referred...*

What a wonderful Preamble! We know of no other Constitution which asserts that it has been framed in the name of the Triune God.

The Preamble goes further when it states:

*We, the people of Éire, Humbly acknowledging
all our obligations to our Divine Lord, Jesus Christ*

The recognition given here to the authority of Jesus Christ would also appear to be unique among legislative and constitutional documents.

It is abundantly clear from the Preamble, plus numerous provisions here and there throughout the Constitution, that the values and morality that it aspires to embody are those of the Bible. So, when in Article 6.1 it guarantees the right of citizens to express freely their convictions and opinions, subject to public order and morality, it did not envisage that this proviso would limit in any respect the expression of “convictions and opinions” based on the Bible:

*the state guarantees liberty for the exercise of the
following rights, subject to public order and morality: –
(i) the right of the citizens to express freely their
convictions and opinions.*

Once again we can only marvel at the seditious intent and jaw-dropping arrogance of the government! These closet Marxists pretend to have the authority to bypass the Constitution and impose a system of censorship across our nation which criminalizes anyone who espouses or promotes Biblical values. Victims of this law, faithful defenders of God’s Word, could be locked away for five years!

CONCLUSION

The Penal Laws crushed the spirit of the Irish people. The Crown got what it wanted, an impoverished, uneducated mass of obedient serfs. To their credit the Irish managed to claw their way out of the abyss and by 1960 had a functioning democracy, a well-educated population, and a Christian Constitution. The baleful hand of the Luciferians was never far away, however, and today the country is being defiled once again by the dark cabal who control the UK. (It is not much comfort to know that the same cabal is conducting a similar campaign across most of Europe, Australasia and North America.)

This Bill, if and when it passes into law, will remove the presumption of innocence from all who have the misfortune to be attacked by its provisions. Innocent men and women, law-abiding individuals in all respects, will be dragged before the courts for a ‘crime’ which exists only in the mind of their accuser. Even those who are not convicted by the court will have to endure the indignity and the strain of defending themselves against a serious criminal charge. This is a crime in itself, a crime sponsored and enabled by the state, whose laws and Constitution have been hijacked by a mercenary cabal of Satanists.

Decent people will be made to grovel and a great many will buckle under the pall of fear and intimidation which this wicked 'Act' is designed to engender. As the former Minister for Justice brazenly implied, anyone accused of 'hate speech' under this 'Act' will be shut down, shut up, isolated and afraid to speak!

The Act even empowers the state to enter the home of the "accused" – who has not been found guilty of a crime – and confiscate his computer and storage devices. The state will also be empowered, under its 'search warrant', to conduct an extensive examination of the victim's home in its quest for relevant material.

If Satan himself had drafted this vile piece of legislation it would hardly have differed one jot from the hideous screed produced by the government.

As a Christian I cannot accept this 'Act' as valid legislation. It is a mandate for tyranny. All who had a hand in producing it and getting it through the legislature will answer for their conduct on Judgment Day.

APPENDIX A

Criminal Justice (Incitement to Violence or Hatred and Hate Offences) Bill 2022

The Bill has not yet passed into law. The text we are considering is the one approved by the lower House (the Dáil) on 26 April 2023. Its main provisions are expected to be approved in full by the Seanad.

Under the Act “hatred” means hatred against a person or a group of persons in the State or elsewhere on account of their protected characteristics or any one of those characteristics. These characteristics comprise:

race, color, nationality, religion, national or ethnic origin, descent, gender, sex characteristics, sexual orientation, or disability.

The terms ‘hate’ or ‘hatred’ are not defined.

It shall be a defense in court if the accused did not know, and had no reason to suspect at the time the alleged offense was committed, that the material concerned was likely to incite violence or hatred against a person or a group of persons on account of their protected characteristics.

A person convicted under the Act – being a person who failed to convince the court that he or she did not act from a hateful motive – could be fined up to €5000 and/or receive a sentence of up to five years in prison.

It is also an offense under the Act to be found in possession of material covered by the Act which was not disseminated but which, in the opinion of the court, was not intended for personal use only. Thus a person whose home library or home computer included several volumes dealing with the serious adverse effects of the homosexual lifestyle or the harm caused by transgender genital mutilation could be found guilty of an offense under the Act. The inclusion of this provision implies that the state has the power to enter and search the home of the accused. Personal property, including computers and storage devices, can be confiscated as ‘evidence’. Section 5 of the Act deals with the issuance of ‘Search Warrants’ for this and related purposes.
