

# Three Prescient Voices Warn of Genocide

The Enemy persists. If we purify our minds, quieten our emotions, and look into the silent depths of our being, we will finally see truth in all its glory. We just need to develop greater spiritual discipline and then, one day, perhaps after many years, the great enlightenment will hit us. But the Word of God rejects heart-based seeking and self-discovery of any kind: **“A fool hath no delight in understanding, but that his heart may discover itself.” (Proverbs 18:2)**

By various tricks and devices, the false teachers continually try to bring us back to the heart. If only we could unravel its secrets, then everything would be revealed. The Word of God takes this deadly lie and pounds it into dust: **“The heart is deceitful above all things, and desperately wicked: who can know it?” (Jeremiah 17:9).**

This is every bit as bad as it sounds. In our natural state, in our innermost being, we are **“desperately wicked.”** We are so thoroughly damaged by sin that we cannot comprehend the darkness inside ourselves. Men in their pride reject this assessment and imagine instead – with barely a shred of evidence – a splendid future for themselves.

## **Christ is our Light**

Despite our wretched condition, God Himself seeks us out and, through the power of the Holy Spirit, offers the gift of salvation. For those who know they are lost, the words of the Gospel are the sweetest and most refreshing sound they will ever hear. But for those who continue to live in their rebellious state, who refuse the gift of salvation in Christ, only darkness remains – abiding, unending, immutable darkness.

Christ alone is Light. As believers, we have been set free. We are no longer slaves to Satan. This has been made possible only through our faith in Christ – **“Who hath delivered us from the power of darkness.” (Colossians 1:13)**

We stand before our heavenly Father, not in our own righteousness – because we have none – but in the imputed righteousness of Christ. The Son of God is our bridge between salvation and darkness. He is the narrow way which seemingly fewer and fewer lost souls are striving to find.

Those who cross the bridge of Christ have found the Light. It is their task thereafter to preach the Gospel and mark the way. We are now repelled by the darkness that once held us captive, and feel – or should feel – a deep urge to expose it. As the Word of God says, we are to **“have no fellowship with the unfruitful works of darkness, but rather [we are to] reprove them.” (Ephesians 5:11)**

### **False pastors**

If Christian pastors today truly hated this darkness, they would be very busy indeed, earnestly exposing the works of those who reject the Light. But most of them have little or nothing to say. Their main interest is in the world, but they call it “normality.” If people would only take the vaccine then normality would return. Like the flocks they purport to pastor, they crave normality.

The Enemy is exploiting the fallen condition of the human heart by dangling “normality” like a giant carrot before a herd of donkeys. They bray impatiently for what they once had. Whoever holds the carrot can lead these donkeys wherever he likes.

For the believer, however, nothing has changed and nothing will change. From the day he crossed the bridge, his heart has been guided by a desire for just one thing. He is like Jeremiah who, having just witnessed the utter destruction of Jerusalem, could say: **“It is good that a man should both hope and quietly wait for the salvation of the LORD.” (Lamentations 3:26)**

The Enemy is using the worst of the wicked, including families he has trained and nurtured over many generations, to accomplish his grisly ambition. These people – those at the top of Satan’s grand pyramid of power on this earth – have seemingly committed the sin that cannot be forgiven: They have blasphemed against the Holy Spirit:

**“Wherefore I say unto you, All manner of sin and blasphemy shall be forgiven unto men: but the blasphemy against the Holy Ghost shall not be forgiven unto men. And whosoever speaketh a word against the Son of man, it shall be forgiven him: but whosoever speaketh against the Holy Ghost, it shall not be forgiven him, neither in this world, neither in the world to come.” (Matthew 12:31-32)**

**“Verily I say unto you, All sins shall be forgiven unto the sons of men, and blasphemies wherewith soever they shall blaspheme: But he that shall blaspheme against the Holy Ghost hath never forgiveness, but is in danger of eternal damnation” (Mark 3:28-29)**

John, in his first letter, was likely referring to this same sin when he said: **“There is a sin unto death: I do not say that he shall pray for it.” (1 John 5:16)**

If Satan has chosen the worst of men to lead his rebellion, as one would expect, then they are likely to comprise those who have committed the sin unto death. They are likely to have engaged in blasphemies so extreme, so repugnant to the Person of the Holy Spirit, that they have put themselves beyond redemption. If such people exist on this earth, and the Word of God implies that they do, then they are the ones at the helm, the ones whom Satan has selected to oversee his plan to destroy Christianity and enslave mankind. They are the architects and overseers of the coming New World Order.



Such people will have no conscience or even an atom of compassion. As individuals they are about as wicked as a man can be. They are undoubtedly a danger to everyone else, but this danger is greatly magnified when they work together for a common purpose. The LORD destroyed the tower of Babel and split mankind into a large number of linguistic groups so that these men could not successfully come together and conspire against their fellow man. But time has moved on and the clock of history is ticking. We are now in the fourth age of Daniel, when this wickedness is scheduled to burst forth with a ferocity never previously known on earth.

Why do Christian pastors continue to ignore the existence of such men? Why do they continue to deny that they are conspiring together to destroy Christianity? Why do they fail, against all the evidence, to expose their works – the works of darkness – and equip the saints to deal effectively with this baleful threat? We have only to look at the many websites on the Internet which purport to uphold fundamental Bible truth to see how tame and innocuous, if not deceitful, these men really are.

## **The Fourth Kingdom**

When Daniel was shown the phases in world history that would culminate in the horrors of the fourth kingdom, he was greatly shaken: **"As for me Daniel, my cogitations much troubled me, and my countenance changed in me: but I kept the matter in my heart."** (Daniel 7:28)

As born-again believers we are expected to be familiar with these passages of Scripture and to discern as best we can the conditions and circumstances under which these prophesied events might arise. We are not to say, *Oh, they are far in the future*, when Satan **now** possesses all the technology he needs to inaugurate his reign of terror and when the kingdom concerned – a revived Roman empire, led by direct descendants of the same families that ruled ancient Rome – is **now** dictating world events at every level.

They set up the UN – the United Nations – to fulfil the dream of Nimrod and unite the nations. **UN Agenda 21** and **Agenda 2030**, which have been endorsed and adopted by 193 countries, are nothing less than a detailed program to secure for a small elite complete control over the world's resources and, by this means, an iron grip on all humanity.

This is a blueprint for the Fourth Kingdom, a tyranny engineered with immense cunning, under the guise of science and 'progress' and carefully contrived lies. Daniel gave a disturbing picture of where it will lead:

**“The fourth beast shall be the fourth kingdom upon earth, which shall be diverse from all kingdoms, and shall devour the whole earth, and shall tread it down, and break it in pieces.” (Daniel 7:23)**

The Word of God tells us that sorcery will play a big role in the great End Time debacle. The word in the Greek text is *pharmakeia*. The Enemy will use it to bring the masses under his spell, to weaken them both spiritually and physically, and open them step by step to his many enticements.

Today the *pharmakeia* industry is out of control, bypassing on a whim the most basic standards and safeguards, and working openly with national governments to compel the hapless masses to ingest its products. The Nuremberg Code is being trampled underfoot and the right of the state to violate one's bodily integrity is now enshrined in national and international law. When has anything like this ever happened before – on a worldwide basis?

## Massive-scale depopulation

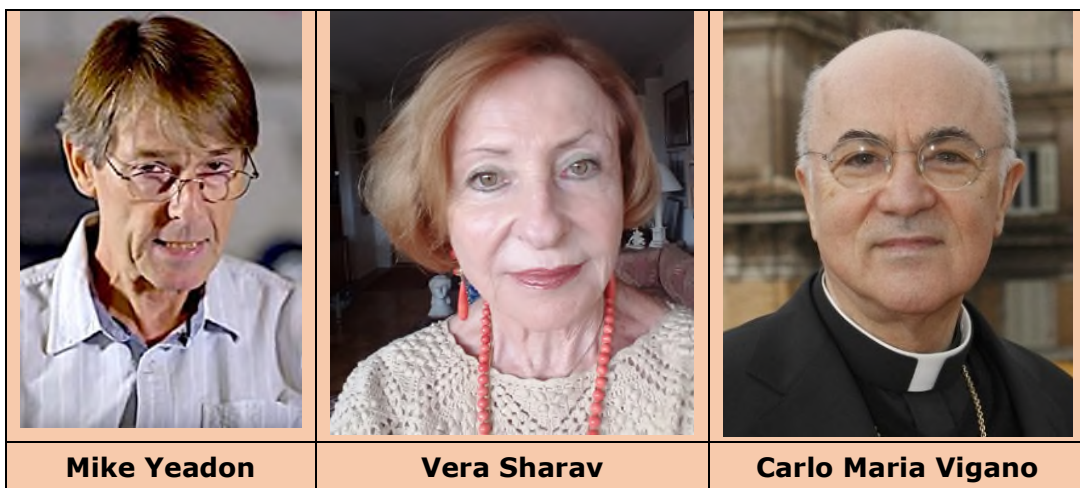
Very few within the industry have had the courage to speak out and warn the public of the tragedy that is now unfolding. One of these is Dr Mike Yeadon, former vice-president and chief science officer with Pfizer. In an interview published on 25 March he stated:

“I have absolutely no doubt that we are in the presence of evil... I must return to the issue of ‘top up vaccines’ (booster shots) and it is this whole narrative which I fear will be exploited and used to gain unparalleled power over us. *Please* warn every person not to go near top up vaccines. There is absolutely no need for them... yet they’re being made by [big] pharma, and regulators have stood aside [i.e. no safety testing]. I can only deduce that they will be used for nefarious purposes. For example, if someone wished to harm or kill a significant proportion of the world’s population over the next few years, the systems being put in place right now will enable it. It’s my considered view that it is entirely possible that this will be used for massive-scale depopulation.”

This is truly jawdropping. He is warning of a possible plan to murder tens of millions of people. This is the kind of industrial scale killing that the Word of God foretold would occur in the End Time – see Revelation 6:8.

This man is not alone. Other respected scientists and medical professionals have warned of the deadly risks associated with mRNA technology, especially if it is used as a weapon against society. In a world where evil did not exist, such a possibility would not need to be considered. Alas we don’t live in a world where evil does not exist but in one where evil is endemic and where crimes against humanity can easily be concealed behind a veil of technology.



This possibility was recently examined in an interview given by Vera Sharav. She was a child of Jewish parents living in Rumania during the Second World War. Many of her friends and relatives were murdered in the Holocaust. Her family was hauled off to a concentration camp in the Ukraine where her father died, but Vera and her mother survived.

She has lobbied for many years for curbs on the growing power of the pharmaceutical industry. From her family's experience of the Nazis and their methods, she can see where the draconian rules of the Covid plan are leading mankind:

“Medical mandates today are a major step backward toward a fascist dictatorship and genocide... whenever doctors join forces with government and deviate from their personal, professional clinical commitment to do no harm to the individual, medicine can then be perverted from a healing, humanitarian profession to a murderous apparatus.” [Source: [www.youtube.com/watch?v=5\\_Af9GDaklQ](http://www.youtube.com/watch?v=5_Af9GDaklQ)]

She spoke of “the pivotal role played by the medical establishment, the entire medical establishment [in the Holocaust]. Every step of the murderous process was endorsed by the academic and professional medical establishment.”

She mentioned also the T4 ‘euthanasia’ program which was used to murder thousands of ‘unwanted’ children in Nazi Germany. We forget today that this program was run entirely by the medical establishment, with almost no involvement by the military.



“T4 was the first industrialized medical murder project in history. The first victims were disabled German infants and children under three. They were identified by midwives who reported their existence to the state. The next victims were the mentally ill, followed by the elderly in nursing homes. The murderous operations were methodical and followed protocol very, very carefully. Questionnaires were sent out to all psychiatric institutions requiring detailed information about each patient. A committee of 54 psychiatrists made the final life and death decisions for each patient.”

### **Corporate involvement**

Referring to the Holocaust, Sharav said Hitler could not have carried out this industrialized, murderous operation without the help of Wall Street bankers and major corporations in the US, Germany and Switzerland. She lists some of the companies that benefitted financially from this: Standard Oil and Chase Manhattan (both owned by the Rockefellers), IBM, Kodak, Ford, Coca Cola, Nestlé, BMW, IG Farben, Bayer, and Escher-Weiss [*which was owned by the father of Klaus Schwab, head of the World Economic Forum and leading spokesman for The Great Reset*]. In her opinion, given the way the Nazis behaved and the degree to which powerful multinational corporations are still involved, the Covid-19 vaccines are linked to a wider eugenics program:

“The Covid-19 pandemic has exposed eugenics-driven public health policies in Western Europe and the United States. This is a chilling replay of T4. Government directives to hospitals and nursing homes essentially condemned the elderly to death. In Europe and the United States hospitals were ordered not to provide medical treatment, including oxygen, to elderly people in nursing homes. Several US governors sent infected elderly people to nursing homes knowing that they lacked essential safeguards to prevent the spread of the virus.”

## **The role of fear**

The Nazis used fear to silence dissent and keep concerned citizens from speaking out. The same is happening today:

“The virus is being exploited to maintain a state of fear. Lockdowns this time around have proved to be very effective tools for social control, but they failed to change the course of the virus. People are being conditioned to submit passively to government dictates. Children, who are deprived of an education, are being conditioned to distrust people. Mandatory masks are an insidious psychological weapon. They demean our dignity as free human beings. They do not work... and they are the symbolic equivalent of the yellow star [which the Nazis forced all Jews to wear].”

“Doctors and scientists who express views that challenge official dictates are treated as heretics. They are threatened with loss of livelihood... Anyone who questions the safety of vaccines, that have been rushed through Operation Warp Speed, is muzzled and vilified by the media.”

She went on to explain that, in her opinion, the oligarchs who planned and financed the Holocaust, which was based in Europe, are now planning and financing a worldwide ‘Holocaust’ -

“...this is a kind of Final Solution. To ensure compliance with Covid vaccines governments have instituted unprecedented aggressive measures. This is primarily to ensure a vigorous cash flow. They are already talking about the vaccines being required every year...”

“Read ‘The Great Reset’ [by Klaus Schwab] ...It’s to go beyond Hitler... This is global. It’s about population reduction. That’s always been the oligarchs’ goal since John D Rockefeller. And power. ... Green passports are now being instituted to [create] an apartheid, two-class society. One class privileged, the other reviled and discriminated against. Sound familiar? ... Will ghettos, detention camps follow? And how will people be killed?”

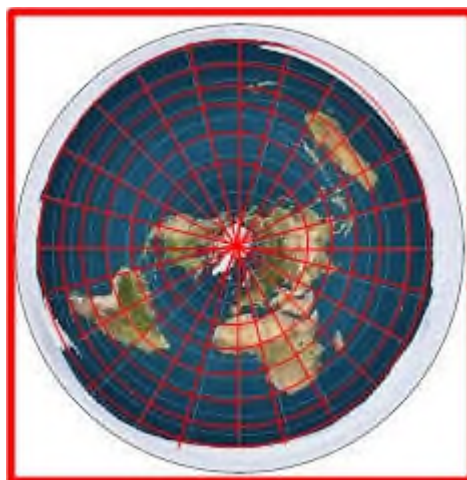
“Now this ‘Great Reset’ is the Master Plan...The oligarchs already own governments... The elite truly believe they are **Übermenschen** and we are all **Untermenschen**. That is what is driving this...Power is like a drug... There are people who are absolutely evil. They do not recognize the human species as being one. Once you start having these two-class systems, you will not prevent a global holocaust. And they can do it remotely – click-click.”

Please note what may possibly be her most telling observation: “The oligarchs already own governments...”!

### **The World Elite already own our governments**

Just as we stated in previous papers, the governments of the world undertook exactly the same drastic course of action in March 2020, despite its immensely disruptive, cruel and costly nature, because they were following orders. The Elite *own* our governments. This is why there was no discussion, no public criticism, no examination of the alternatives. For the first time in history, leading politicians of every hue gave their immediate and unconditional support to the same controversial strategy. Why? Because the main political parties in every country – the 193 countries that endorsed *Agenda 2030* – are controlled by the oligarchs.

Once we grasp this basic truth, everything else makes sense.

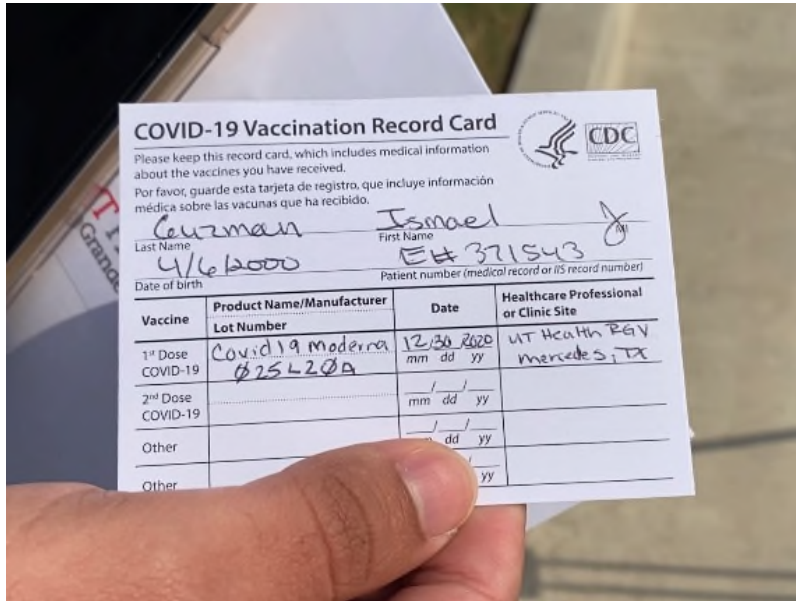
### **An ex-Vatican Perspective**

Our third and final voice is that of a Roman Catholic archbishop – Carlo Maria Vigano. For many years this man served in the highest echelons of the Vatican hierarchy. One might ask how someone with such close connections to an organization infested with homosexuals and Freemasonry can possibly be trusted to speak truthfully about its role in world affairs? Despite ongoing attempts to extirpate upright individuals from within its ranks, the Catholic Church still has a small remnant of senior clerics who oppose the New World Order. Given his tireless efforts in recent years to expose the lies, hypocrisy and criminality of Jorge Bergoglio (the current Pope), we are inclined to believe that he may be part of this remnant. If so, then his recent observations are especially valuable and worthy of consideration.

“What we have learned so far about the pseudo-pandemic gives us the picture of a disturbing reality and of an even more disturbing criminal conspiracy hatched by misguided minds. This reality, however, is not taken into consideration by those who, hypnotized by media indoctrination, persist in considering a serious seasonal influenza as a pandemic scourge, known treatments as ineffective, and the so-called vaccines that are admittedly useless and harmful as nothing short of miraculous.”

### **Victims of a criminal conspiracy**

He wants his Catholic readers to understand that they are victims of a criminal conspiracy. Fear-mongering in the media has convinced many that the vaccines are “nothing short of miraculous,” even as the deadly side-effects of the vaccines are being greatly downplayed:

“The recent findings about serious side effects have been designed to exclude the majority of cases and above all to deliberately ignore the causal relationship between inoculation with the vaccine and its short- or long-term side effects.”

He echoes the point made by Vera Sharev, where governments cater for the obscene greed of the *pharmakeia* industry by giving them total immunity for injuries caused by their products. Details of the vaccine contracts between each government and the industry are also being withheld:

“Thus, along with the scandalous profits from the sale of the vaccines, the pharmaceutical multinationals guarantee their own impunity for a criminal operation, conducted with the complicity of international institutions and governments.

“We know that the contractual terms of the agreements made by nations and by the European Union with these pharmaceutical companies are inaccessible and secret.”

### **The execrable complicity of health-care personnel**

In the following passage he draws attention, as Ms Sharev does, to the extraordinary way all nations responded to the ‘pandemic’ by adopting “the most absurd health protocols” -

“We know that every nation, with very few exceptions, immediately adopted the most absurd health protocols coming from the WHO, beginning with the unfortunate decision not to treat the sick at the onset of the first symptoms, and to subject them to deep ventilation once the flu syndrome degenerated into acute bilateral pneumonia. And this happened with the execrable complicity of health-care personnel – from doctors to hospital staff – provoking thousands of deaths not from COVID, as we are told by the mainstream media, but from incorrect treatment.”

This irrational worldwide response could only be the result of years of planning, not just by governments but also by top people in the medical profession in each country:

“We know that in order to conduct this criminal operation – since we must speak of a crime against God and against humanity, not of a merely unfortunate fate – it was necessary to have years of planning, conducted systematically, in order to weaken national pandemic plans, drastically reduce the number of beds in hospitals and intensive care units, create a mass of blind, deaf, and dumb employees, no longer doctors, who placed their own safety in the workplace ahead of their duty to cure the sick. The Hippocratic oath was violated in the name of profit for the pharmaceutical companies and the pursuit of a social engineering project.”

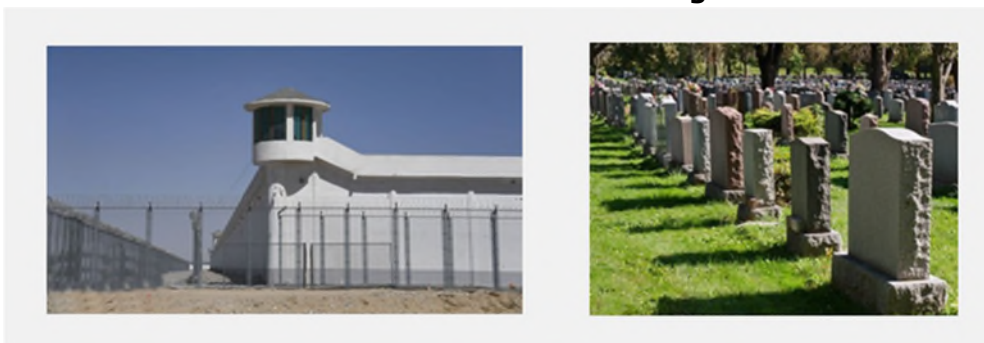
He wants his Catholic audience to understand that the information they are receiving via the media is grossly manipulated, and eminent scientists are being censored:

“The dissemination of data on the infections and deaths has been grossly manipulated, suggesting that every person with a positive test result should be considered sick, even though the asymptomatic are not contagious – by the very admission of the WHO and the analogous bodies in the United States, Canada, Australia, etc.”

“[We are witnessing a] scandalous censorship operation, to the point of erasing the profiles of eminent scientists and established journalists, for the sole reason that they did not obey the *diktats* of the COVID narrative.”

## **The Church of Satan**

He says we know who the “theorists” or creators of the pandemic are, citing Bill Gates and George Soros as examples. They operate

“in a network of complicity of interests so vast and organized that any measure of opposition is practically impossible. Along with them, we find the most disturbing repertoire of so-called philanthropic organizations and lobbies of power, like the World Economic Forum with Klaus Schwab, the WHO and all of its national branches, the Trilateral Commission, the Bilderberg group, the Council for Inclusive Capitalism headed by Lady Lynn Forester de Rothschild under the spiritual direction of Bergoglio and, more generally, the phalanx of multinationals, banks, and groups of power that belong to this dome of conspirators. Do not be surprised if, in perfect coherence with their plans, the sects and world Satanist movements also mobilize, beginning with the Church of Satan that exalts abortion as a propitiatory ritual for the end of the pandemic, exactly as BigPharma requires pseudo-vaccines produced with aborted fetuses... part of the Catholic hierarchy is also present in this plan, which in Jorge Mario Bergoglio finds an obedient preacher of the pandemic narrative and the primary sponsor of the vaccines...”

He refers also to the coming ‘One World Religion’ and the role the current Pope [Bergoglio] will play in its creation:

“On the other hand, the Great Reset envisages the establishment of a Universal Religion that is ecumenical, ecological and Malthusian, which sees in Bergoglio its natural leader, as was recently recognized by Masonry.”

We do not know what Vigano is specifically referring to when he speaks of the recognition that Freemasonry is giving Bergoglio. However, it is well known that many high ranking Masons in various countries have been making very flattering references to the current Pope. Consider the following remarkable example. In 2014, on the occasion of the reunion of the Grand Lodge of Free and Accepted Masons of Florida, the Grand Orator, Gilbert Weisman, not only quoted enthusiastically from *Morals & Dogma* by Albert Pike 33rd degree – a self-declared Luciferian – but went on to quote the Pope with almost equal enthusiasm:

“As Pope Francis pointed out in his New Year’s Day Service on January 1, 2014: ‘We are all children of one Heavenly Father, we belong to the same Human Family, and we share a common destiny. This brings a responsibility for each to work, so that the world becomes a Community of Brothers who respect each other, accept each other in one’s diversity, and take care of one another.’ He could just as well be speaking to a body of Freemasons.”

Vigano does not mince his words when he describes the purpose of the alleged pandemic and the irrational response by our governments. In his opinion it serves only one purpose, namely, to bring about “an economic, social, and religious crisis” -

“It must be recognized that the apparent illogicality of what we see happening – the boycotting of preventative treatments, erroneous therapies, ineffective vaccines, lockdowns with no usefulness, the use of masks that are absolutely useless – makes perfect sense as soon as we understand that the declared purpose – defeating the alleged pandemic – is a lie, and that the real purpose is the planning of an economic, social, and religious crisis using an artfully provoked pseudo-pandemic as a tool.

“There is a single script under a single direction, which makes use of the collaboration and complicity of politicians and rulers, doctors and scientists, bishops and priests, journalists and intellectuals, actors and influencers, multinationals and bankers, public employees and speculators.

“This crisis serves to create the conditions necessary to make the Great Reset inevitable, that is, the transition from the world based on Greco-Roman civilization and Christianity to a world without a soul, without roots, without ideals. In practice, it is the passage from the Kingdom of Christ to the Kingdom of the Antichrist, from a virtuous society that punishes evildoers to the impious and wicked society that punishes the good.”

## **The Great Reset is another name for the Kingdom of Antichrist**

This is and has always been the goal of Freemasonry, namely to secure a transition from a Christian society to one controlled by the Antichrist. As far as he is concerned, *The Great Reset* is just another name for the Kingdom of the Antichrist:

“The deception of liberty, equality, and fraternity propagated by Masonry consists precisely in usurping the primacy of God to give it to Satan, with the apparent pretext – which is in any case erroneous and immoral – of placing God and Satan on the same level in such a way as to allow an alleged freedom of choice that morally does not exist.

“In reality those who denounced this plan, which is currently underway, were called conspiracy theorists, ridiculed, or passed off as crazy, ostracized by mainstream information and criminalized, driven out of university professorships and the scientific community. Today we understand how far-sighted were the alarms that were raised, and how powerful is the organizational mechanism that has been put in place by our adversaries.”

The media continues to brand all enquiry of this kind as conspiracy theory. Where the general public is concerned, the barrier to recognizing what is happening and to discerning the great evil behind it, is a deeply rooted reluctance to believe that our own governments are working against us. Vigano ascribes this, at least in part, to the psychological phenomenon known as cognitive dissonance, which he defines as “the tension or discomfort we feel in the face of two opposing and incompatible ideas.” The average person simply does “not want to accept that their political leaders are lying shamelessly.” The inner conflict that this creates is too much for most people to overcome:

“They do not know how to accept that the lie can be passed off as truth, that doctors are not curing and indeed are killing their patients, that civil authorities are not intervening to stop crimes ...that Bergoglio wants to demolish the Church of Christ to replace it with an infernal Masonic parody.”

While Vigano does not use the word genocide, he refers to the deliberate killing carried out by the medical establishment. He refers also to the clear determination of those in control to push ahead with their agenda, come what may. Thus an escalation in systematic, unlawful killing can be expected.

## **CONCLUSION**

Humanly there is only so much we can do. When the Satanic World System shifts into high gear, we feel even more helpless than before. As believers, however, we are blessed with the power and assurance of God’s Word. We can live each day in the joy of our salvation.

This will give us the strength we need to alert our sleeping neighbors. The authors of the encroaching tyranny want true believers to stay silent. Alas, those who have been drugged by the world are not easy to wake up. Some will hate us for interrupting their slumber. But with the guidance of the Holy Spirit we may find ways to touch one or two souls with the Gospel message. The Word of God is the voice of prophecy, and those who believe His Word will hear His gentle warning.

Huge numbers of professing Christians hear nothing because, in reality, they don't believe His Word.

In the last century a group of miners got trapped underground when a gas explosion caused their exit tunnel to collapse. No-one seemed to be injured but they were stuck in total darkness for several hours. Finally the rescue crew managed to make a hole and the light shone through. Everyone cheered except one young fellow: "I don't see no light," he said. Until that moment no-one had realized, not even the lad himself, that the explosion had made him blind. It took the light to reveal his true condition.

Last March we all learned the true condition of the professing church. Our worship services were terminated. Very few said anything when the doors were closed. For those who are blind, it really makes no difference.
